# SCHOOL REPORT.

## DISTRICT NO. 1.

Summer term taught by Etta Leavitt of Dorchester, with good success. Winter term commenced by Etta Leavitt, but not meeting with good success, left the school. Her register has not been returned, therefore I have no further report to make of the school. The remainder of the term was taught by Fred S. Hall, of Rumney. Good order was maintained, and good improvement made, especially in reading and arithmetic.

## DISTRICT NO. 2.

Both summer and winter terms taught by Nellie E. Hunkins, of Groton. Good improvement made in both terms.

## DISTRICT NO. 3.

Summer and winter terms taught by Carrie A. Hall, of Groton, with good success.

## DISTRICT NO. 4.

Summer term taught by Eliza M. Blodgett of Dorchester. A good school. Winter term taught by Lucy E. Reed of Dorchester. The scholars made good improvement in all their studies, especially in arithmetic.

## DISTRICT NO. 5.

Summer term taught by Mary E. Sanborn, of Canaan. A good school. Fall term taught by Etta Leavitt, of Dorchester, with good success.

## DISTRICT NO. 6.

Two terms, taught by Roxann W. Leavitt, of Dorchester. Good order maintained, and good improvement made. A fine school.

## DISTRICT NO. 7.

Two terms, taught by Bessie J. Powers, of Dorchester. This was Miss Powers' first experience in teaching. She succeeded in gaining the good will of the scholars, therefore good order prevailed, and good improvement made in the several branches taught.

## DISTRICT NO. 8.

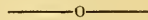
Two terms, taught by Dora M. Columbia, of Canaan. This also was Miss Columbia's first experience in teaching. The teacher, scholars and parents all worked together in harmony, and the result was a pleasant and profitable school.

## DISTRICT NO. 10.

One term, taught by Jennie A. Hutchins, of Canaan. Good order prevailed, and good progress made in the several branches taught.

## DISTRICT NO. 13.

Two terms, taught by C. Josie Hucking of Plymouth. Miss Hucking is a thorough teacher, and the schools were both pleasant and successful.



Most of our schools have been under the management of good teachers. A great deal of responsibility rests with the prudential committee; it is rather their duty to use more exertion to secure the services of competent teachers. A teacher should possess good morals and gentle manners, and a thorough knowledge of the branches to be taught. He should wear a pleasant countenance, cultivate a cheerful disposition, be social with his pupils out of school, and he will seldom fail to be master in school. A great responsibility rests upon school teachers. They are looked to by their pupils as their guide, therefore they should set an example for them worthy to be followed. If parents would take more interest in schools, visit them occasionally, it would tend to encourage both teacher and scholars, and thereby promote the interest of their schools.
