## WARRANT FOR ANNUAL TOWN MEETING

---

### The State of New Hampshire

(L. S.) To the inhabitants of the Town of Lebanon  
qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said town on the second Tuesday of March next at ten o'clock in the forenoon, to act upon the following subjects:

**First**—To choose a Town Clerk for the ensuing year.

**Second**—To choose one Selectman for the ensuing three years, Overseer of the Poor, Collector of Taxes, Highway Agent, and all other necessary town officers for the ensuing year.

**Third**—To choose a Trustee to administer the Trust Funds of the town for three years.

**Fourth**—To raise such sums of money as may be necessary to defray town charges for the ensuing year.

**Fifth**—To raise such sums of money as may be necessary for the construction and repair of highways and bridges for the ensuing year.

**Sixth**—To see what sums of money the town will vote to raise for the construction and repairs of sewers and sidewalks for the ensuing year.

**Seventh**—To see what sums of money the town will vote to raise for the improvement of the cemeteries of the town.

**Eighth**—To see what sum of money the town will vote to raise for the proper observance of Memorial Day.

**Ninth**—To see if the town will vote to raise the sum of six hundred dollars to provide a free bed at the Mary Hitchcock Hospital.

**Tenth**—To see what sum of money the town will vote to raise to assist in the work of the Visiting Nurse Association.

**Eleventh**—To see what sum of money the town will vote to raise for the benefit of the West Lebanon Library.

**Twelfth**—To see what sum of money the town will vote to raise for the benefit of the Lebanon Public Library.

**Thirteenth**—To see what action the town will take to enable it to secure the provisions of Chapter 35, Laws of 1905, in relation to improved highways, and of Chapter 133, Laws of 1911, Section 27, in relation to the maintenance of the roads.

**Fourteenth**—To see if the town will appropriate the sum of one thousand dollars to control the White Pine Blister Rust.

**Fifteenth**—To see if the town will vote to authorize the Selectmen to hire money in anticipation of taxes.

**Sixteenth**—To determine the division of the school money.

**Seventeenth**—To see if the town will vote to raise the sum of one hundred dollars to hire Rogers & Whitney Park for a playground.

**Eighteenth**—To see if the town will vote to raise the sum of fifty dollars for the benefit of a playground at West Lebanon.

**Nineteenth**—To see if the town will vote to allow a discount on taxes, if paid before specified dates.

**Twentieth**—To see if the town will continue the inspection of milk, and raise money therefor.

**Twenty-first**—To see if the town will vote to give prescription permits from May first 1926 to May first 1927 according to Section 99, Laws of 1919, to druggists who are registered Pharmacists doing business in Lebanon, to sell liquors for medicinal, sacramental, scientific or mechanical purposes.

**Twenty-second**—To see if the town will vote to build a tomb in West Lebanon cemetery and appropriate money for same.

**Twenty-third**—To see if the town will vote to build a sewer on Williams Street from the corner of Ela and Williams Street three hundred and fifty feet to the corner of Colburn Street extension and to appropriate money therefor.

**Twenty-fourth**—To see if the town will vote to employ a firm of certified public accountants to audit the accounts of the Town, for the year 1926.

**Twenty-fifth**—To see if the town will vote to ratify and confirm the actions of the Selectmen in leasing the auditorium in the town hall to the Lebanon Improvement Society.

**Twenty-sixth**—To see if the town will vote to lease the auditorium in the town hall to the Lebanon Improvement Society.

**Twenty-seventh**—To see if the town will vote to build a cement or concrete road from the westerly side of the bridge over the Mascoma River on Hanover Street to the southerly line of land of Fred M. Simmons on said Hanover Street, and on High Street from Hanover Street to West Street, and to raise money therefor.

**Twenty-eighth**—To see if the town will vote to authorize its Selectmen to take advantage of an act empowering the Town of Lebanon to establish the office of Town Manager.

**Twenty-ninth**—To see what action the town will take regarding the purchase of the Beacons put up by the American Gas Accumulator Company and to raise money to pay for same.

**Thirtieth**—To see if the town will vote to re-appraise the Real Estate of the town and to appoint a committee of three to act with the Selectmen.

The Board of Selectmen of Lebanon, N. H. :

Acting under your authorization we have audited the accounts of the Town of Lebanon for the year ended January 31, 1926 and submit herewith a balance sheet as at that date and a statement of receipts and disbursements for the year then ended.

All recorded receipts of town monies were traced to the banks, disbursements of funds were found to be supported by proper vouchers and we reconciled the selectmen's record of receipts and disbursements with the treasurer's cash book.

Cash was verified by confirmations obtained directly from depositories, except that the amount \$2,664.26, shown by the books as being on deposit to the credit of the New Town Hall Building Committee in the Peoples Trust Company on January 31, 1926 was not confirmed to us by the agent of the Board of Bank Commissioners in charge of that bank. We accounted satisfactorily for all other assets, except supply inventories, which could not be checked by physical count because of weather conditions.

Notes payable and bonds outstanding as of January 31, 1926 were confirmed by independent investigations.

The following accounts were audited by us for the year ended January 31, 1926 in addition to the town's general accounts:

Trustees of Trust Funds  
Lebanon Public Library

Treasurer of the Lebanon Cemetery Committee

All recorded receipts and disbursements of the foregoing were satisfactorily accounted for and all funds on deposit to the credit of these divisions on January 31, 1926 were verified directly with the depositories. The Trustees of Trust Funds have received a liquidation dividend of 33 1-3 per cent. from the Peoples Trust Company on account of

monies on deposit in that bank when it suspended payments.

Subject to the foregoing comments we hereby certify that, in our opinion, the attached balance sheet and related statement of receipts and disbursements set forth correctly the financial position of the Town of Lebanon, New Hampshire as at January 31, 1926 and properly present its financial transactions for the year ended on that date.

## HEALTH OFFICER'S REPORT

The health condition for the Town of Lebanon for the past year has been very good up to the first of November, at which time 4 cases of Diphtheria developed, with one death.

An epidemic of Scarlet Fever started the middle of December and 51 cases, up to the middle of February, with 3 deaths. A few cases of Measles in town, and 1 case of Infantile Paralysis.

The co-operation of the school nurse and the teachers has been of great help in locating communicable diseases and lessening their spread through the community.

A great deal has been done during the past year to better water conditions and an investigation is being made by the State Board of Health with a suggestion of placing septic tanks at Enfield the source of our water supply.

The reports received from our State Chemist on samples of milk taken from the Lebanon producers the past year are very gratifying inasmuch as they have all showed well above the statutory limits as regards solids and fats, and show that the milk has been produced under sanitary conditions.

The same method has been carried out in regard to inspecting stables, milk rooms and taking of samples as in previous years with the result that Lebanon is getting a very satisfactory lot of milk.
