TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Goshen, in the County of Sullivan, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Goshen on Tuesday, the twelfth day of March next, at nine o'clock in the forenoon to act upon the following subjects:

- Art. 1. To choose all necessary town officers for the year ensuing.
- Art. 2. To hear the reports of the selectmen and other town officers heretofore chosen and pass any vote relating thereto.
- Art. 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for the same.
- Art. 4 To raise and appropriate such sums of money as may be necessary for the repair of highways and bridges.
- Art. 5. To see if the town will vote to apply for State Aid for permanent improvements of highways and raise and appropriate the necessary money therefor.
- Art. 6. To raise and appropriate the money necessary for State Aid Maintenance.

- Art. 7. To raise and appropriate the money necessary for Trunk Line Maintenance.
- Art. 8. To see what sum of money the town will vote to raise and appropriate for the Library.
- Art. 9. To see if the town will vote to authorize the Selectmen and Town Treasurer to borrow money in anticipation of taxes.
- Art. 10. To see what action the town will take in regard to the White Pine Blister Rust and pass any vote relating thereto.
- Art. 11. To see if the town will vote to repair the Town Hall and raise and appropriate the money therefor.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Goshen:

In submitting my annual report, there is only one phase of the school work on which I desire to present an extended discussion for your consideration. I feel that our schools are doing as good work as any schools in the School Union under like conditions and better than some of the schools. In spite of this fact, if you will accept my judgment in the matter, I believe that with a small initial outlay, you can about double the efficiency of your schools by putting them together at Mill Village for the following reasons:

First: Probably there arises in the minds of some. at once, upon the mention of putting the schools together at Mill Village, the subject of "Lessening Farm Values." I will discuss that subject form a personal point of view. If I were to buy a home in Goshen or elsewhere, I would hesitate a long time in doing it if my child had to attend a one-room school of eight grades. Why? I have observed the workings of the schools for seventeen years and it is my experience that you cannot make half the progress in an eight-grade school that you can in four grades, and it has been my duty to arrange them to the best advantage possible. It is a matter of fact with me through long observation that the greatest stumbling block in a school of eight grades is the matter of time. This handicap cannot be eliminated by any arrangement known to exist. In a school of eight grades the teacher must arrange for the following number of classes each day:

First Grade	4 classes (at least)
Second Grade	4 classes (at least)
Third Grade	7 classes (at least)
Fourth Grade	8 classes
Fifth Grade	8 classes
Sixth Grade	8 classes
Seventh Grade	8 classes
Eighth Grade	8 classes

Number of classes per day 55

There are in a six-hour day beginning at nine and dismissing at four, six hours or three hundred sixty minutes. Deduct from this thirty minutes for forenoon and afternoon recesses, and five minutes for morning devotional exercises, and we have three hundred twenty-five minutes in which to hear fifty-five subjects. Now such subjects as Spelling, Writing, Reading, History, and Geography, will permit uniting of classes (which we do not do in single grade—our first handicap) which will reduce the number of recitations to forty. This gives us about eight minutes to a recitation. But questions must be answered between classes and time will be taken up in the passing of classes which will reduce the recitation time to at least seven minutes. But every recitation cannot be seven minutes long, as it takes longer in the upper grades to get any value from the work in such subjects as English, Arithmetic, History, and Reading, which must have at least ten minutes for each recitation. That leaves other subjects in these grades as well as all subjects in the lower grades with four or five minutes for each recitation.

In schools having single grades, we use at least twenty minutes for reading recitations and reading drills in the lower grades. Under ideal conditions it often becomes of grave concern at times, by experience and skillful teachers, as to whether or not they can make sufficient progress to promote the children at the end of the year. Ability to read is the chief standard for promotion in the first two grades.

If we should divide our forty pupils in town into two groups, composed of the first four and last four grades we would then have twenty recitations for each group and thereby make it possible to have twenty-minute recitations in all major subjects. It would also enable us to hire teachers who are specialists, either in the upper or lower grades, which most teachers are anyway. I have never seen a teacher who was equally enthusiastic and proficient in upper and lower grade work alike.

Now to come back to my own personal point of view as to the advantages of the four-grade school over the eight grade school. If good transportation facilities are provided (and the state law says there shall be, whenever transportation is necessary) I should consider that especially fine provisions had been made if my child were hauled to school and back home in a better manner than that, in which kings could have ridden fifty years ago. At the same time, I should be sure that my child were making more progress than he possibly could in an eight-grade one-teacher school. I should also be sure that with two teachers he would be under better constant supervision while he was away. There is always a danger from mixing the very small and the older people in the same school which is always our constant concern — morally.

The division of two schools with separate teachers and separate recesses lessens this menace which exists to a greater or less extent in proportion to the size of the group thrown together with widely varying ages and working in the same room. I think this last concern looms largest in the minds of parents and gives most trouble in the one-room school of eight grades. The reason is that the school contains mature children in the upper grades and immature children in the lower grades. In running our schools the foremost and most important thing is to give our children the best possible education during their school years. All other considerations are of secondary importance in deciding this question.

The matter of whether or not the people of Goshen will, at this time, desire to unite their school children in two rooms at Mill Village, of course, rests entirely with them. The advantages I believe resulting from such a change largely outweigh the present arrangement. Whatever you may decide to do, rest assured I shall do my utmost to give you the best schools in my power to arrange with the condition which you may decide you desire at the time of your school meeting. I have written this explanation of the situation knowing the concenus of opinion that exists on the School Board.

My relations with the people of Goshen and your representatives, the School Board, whom you elect to represent your educational interests, have always been the pleasantest. In concluding this report, permit me to express my appreciation for your loyal support and cheerful cooperation.
