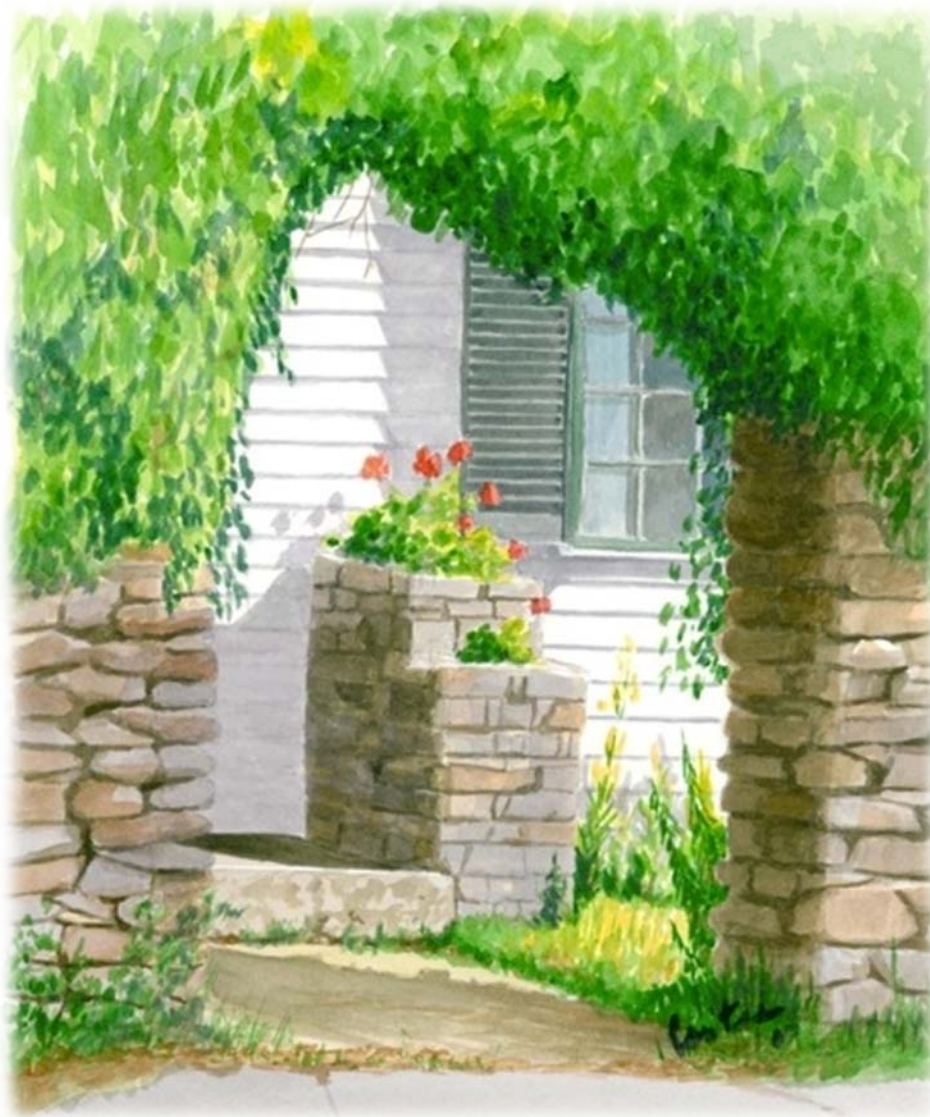

YEAR END REPORT TO CITIZENS OF EXECUTIVE COUNCIL DISTRICT FIVE

The Governor and Executive Council held 22 meetings this past calendar year. The Executive Council approved 2,632 items/contracts totaling \$1,540,138,079.06 and voted to authorize the Governor's Warrant and Expenditures requests (State operating expenses) in the accumulated amount of \$5,670,115,959. In addition to the contracts and expenditures listed above, the Council appointed 51 citizens from District 5 to serve on various Boards and Commissions for the State of New Hampshire.

On February 1, 2011 the Governor and Executive Council held a Public Hearing on the Pardon Request of Ward Bird's conviction for Criminal Threatening. The power to pardon persons convicted of criminal offenses is vested in the Governor and Council by the Constitution. NH Const., Pt. 2, Art. 52. The Governor and Council commuted Ward Bird's sentence the following day.

During 2011, the Governor's Advisory Commission on Intermodal Transportation (GACIT), which is composed of the five Executive Councilors and the Commissioner of the New Hampshire Department of Transportation, held Public Hearings throughout the State, three of which I hosted in Nashua, Peterborough and Keene. The purpose of these Public Hearings is to receive public comments/testimony on the projects and materials included in the draft 2013-2022 Ten-Year Transportation Improvement Plan as recommended by the New Hampshire Department of Transportation to GACIT. In this report are the plans for all methods of transportation including highways, bridges, rail and air transportation. Recently I have had a few constituents come to me with concerns as they face foreclosure. The investigation into the foreclosure situation is ongoing and now involves several State agencies including, The Governor and Executive Council, the Secretary of State, the Attorney General, and the Banking Commission.

It was a busy but enjoyable year serving the constituents of District 5 and I look forward to continuing that service in 2012. Please feel free to contact me by e-mail or phone with any concerns.




- requiring compatibility with the character of a small New England rural town as found in the Vision Chapter of the New Ipswich Master Plan;

TRUSTEES OF THE TRUST FUNDS

We continued to invest trust funds in a bank interest bearing account with Citizens Bank. Interest rates were very low during the year so very little was earned on the funds. The average balance of trust funds for the year was \$1,199,186 and the interest earned was \$760.26. This is .06 of 1% rate of return. In the interest of trying to improve the investment return of the trust funds we have spent the year investigating other investment options.

The state laws governing trustees allow some latitude in making investment decisions. The capital reserve funds which are funded by taxpayer money must be invested conservatively in the highest quality investments with little or no risk to the preservation of the principal. These are generally government securities. This is the "Prudent Man Rule." Other trust funds that have been funded by private donations may follow the "Prudent Investor Rule" which allows more latitude in investment choices. Speculation or outright risk taking is not sanctioned under this rule. State law also allows the trustees to hire an investment advisor.

At our December 19, 2011 meeting we voted unanimously to hire Mackensen & Company of Hampton, NH as an investment advisor. Additionally, we have set up three brokerage accounts with National Advisors Trust, a bank in Kansas City, MO to hold the trust funds and investments. The three accounts are for the town's capital reserves, the privately funded trusts and the Mascenic School. The town capital reserves and the school funds will be invested following the "Prudent Man Rule" and the private trusts will be invested following the "Prudent Investor Rule." We believe that this change in investment strategy will improve the return on the trust funds without having to take undue risk.

The Trustees of the Trust Funds generally meet monthly. The meetings are open to the public and the times are posted. Please feel free to attend.

TOWN CLERK / TAX COLLECTOR

As another year ends and another one begins we are continuing to make changes in this office to try and make your life easier to get things done and meet the demands of the State that governs us.

The first change this year was Abby leaving to start her own business; we wish her well. Jill Hopkins became the Deputy Town Clerk/Tax Collector.

The next major change came as we were forced by the State to go behind glass. We are now in the former Tax Collector's Office with two new windows, a new waiting room and entrance. This is a nice set up; however, the glass is a hindrance to communication.

Abby has returned to work with us one day a week. Jill and Abby are sharing this position to accommodate both their schedules.

We have just completed our first year with the new software from Avitar for motor vehicles which has alleviated a lot of "glitches" that kept people waiting for long periods of time. I chose this software because we already used Avitar's product for taxes. However, it has created other issues. I will be addressing these issues and others on my website, townclerknewipswich.webs.com, throughout the coming year.

The new software also brought you the renewal letter for motor vehicle renewals, which most people are really happy about. Everything has a price and I did report this one dollar increase, to cover postage and handling, in the town report last year. I would also like to do this for the dog letters to try and make life easier for all of us. This would also mean a one dollar increase in dog licenses to cover postage and handling. This would help all of us who are so busy and sometimes forget that the dog license expires on April 30th every year.

I want to be clear; I have nothing to do with the three warrant articles pertaining to this office. I also do not intend to work Fridays. By law, Tax Collectors only have to be open two hours per month. Town Clerks can work whatever hours they would like. I have tried to make things easier for you all by offering two days with morning hours and two days of evening hours. The renewal letters and e-reg have made it possible for you to not even come in at all, for a renewal, if you like.

The offices have always been closed on Fridays. This gave all office staff time to do the work we need to do without being open to the public. I choose to work later in the evening every day rather than come in on Fridays.

I will continue to try and bring more beneficial changes to this office. I have tried to cut costs and save wherever possible. This town is changing, along with ever increasing paperwork and procedures that come with a changing world and economy, and the ever changing state regulations; this all brings more work. I am still working on making things more efficient and economical. I understand none of you wants to increase costs, nor do I. But with change some things are increasing while others are decreasing. And it's my hope, when everything is set up as I envision, you will have a quick and efficient office for less.

I have also set up a tax kiosk where you can check on the status of your tax payment or calculate the interest if you are making a late payment. You can access the kiosk at www.newipswich.nh.taxkiosk.com.

I am still working on credit cards. This has proven to be more difficult because it involves a third party and very lengthy contracts. Not many software vendors offer a product that can handle these transactions properly. I will be addressing this issue at townclerknewipswich.webs.com.

It has been a pleasure serving you this year. Thank you.

BOARD OF SELECTMEN

Despite operating under a default operating budget in 2011, the Town continued to provide essential services. The Police, Fire and Highway Departments all worked hard to assure public safety. The staff and elected officials in the Town Office provided high quality service to residents and managed to find even better ways to assist them on administrative, financial and regulatory matters.

As is typical, however, the year had a number of noteworthy accomplishments and challenges.

- Although voters had adopted a default operating budget for 2011, total spending actually increased by \$347,723 because the default budget exceeded the prior year's budget and additional appropriations were approved in several separate articles. Since revenue was little changed compared to the prior year, this caused the Town tax rate to increase from \$2.87 to \$3.55 in spite of the fact that Fund Balance was used to moderate the increase.
- Road issues remained prominent in 2011. The \$190,000 appropriation in the so-called "road article" was used to repave Davis Village Road because it tied into Upper Ashby Road which had been repaved in 2010. In addition, the Board adopted a Weight Limit Ordinance for River Road, and it also conditionally accepted the Phase 1 portion of Green Farm Road as a Town road.
- The NH Department of Labor conducted a safety audit of Town buildings and cited the Town for a lack of security in the Town Office and for a diesel fume hazard in the Fire Station. To comply with these audit findings, the Town Office lobby was moved and redesigned to improve security and the Fire Department administration/training no longer occurs in the Fire Station. The resulting compliance cost was covered by an emergency expenditure from Fund Balance.
- The Board renegotiated the cable TV franchise agreement with Comcast. The new agreement has a five-year term and provides slightly more favorable terms.
- The Employee Handbook was updated to improve clarity and consistency and to reflect changes in Federal and State labor laws.
- A Fund Balance Policy was adopted to comply with the new GASB 54 accounting standard.
- The Town began to implement the Furnace Brook Watershed Restoration Plan. This project is being funded by an EPA grant of \$119,000 administered by the NH Department of Environmental Services. Initially, the project will focus on reducing runoff into Furnace Brook and Willow Brook and identifying failing septic systems located near these brooks.
- The goal of the Building #2 renovation project is to convert the building into a public safety complex (Police, Fire Administration/Training and Emergency Management). As the project progressed, more problems were discovered (mainly mold, moisture intrusion, faulty electrical wiring, and inadequate insulation). Consequently, the

estimated renovation cost has increased, and an additional appropriation will be required to complete the project.

- The Town Departments will face additional capital budgeting challenges in the near future. The Highway Department should replace at least two dump trucks, and the Police Department will need to begin replacing its cruisers relatively soon. The Old Town Hall continues to be neglected. The Town Pool suffers from considerable deferred maintenance. The Recreation Department will require additional resources after it finishes defining its new mission.

Budget year 2012 will present its own opportunities and challenges. Needs and wants will continue to expand while revenues are unlikely to increase significantly in the current sluggish economic environment. To maintain stability in Town finances, priorities will have to be clearly established, plans carefully formulated, and operations closely monitored.

TOWN ADMINISTRATOR

One Hundred and fifty years ago the country was emblazed in Civil War and the Town of New Ipswich held its first Children's Fair. In 2011 the Board of Selectmen presented a proclamation to the 2011 organizers in honor of the 150-year celebration of the Children's Fair.

In March 2011 the proposed budget was defeated and the Town fell into its third default budget. To handle the defeated budget the Recreation Director was not replaced and programs were cut, the cemeteries received less maintenance, the transfer station hours were reduced and the pool charged higher user fees. Also defeated was a sand and plow truck that was to be paid using funds in the Capital Reserve Account; in 2012 it will be requested again. The voters did approve \$70,000 to continue to renovate the Old Police Building #2.

The Town Office was structurally changed to comply with a State of New Hampshire Department of Safety audit. The Town was mandated to provide a safe and secure office for the Town clerk-Tax Collector and provide limited access through a secure window. As a security measure the Town also installed a wall to separate the Town Offices from the waiting room lobby.

The Town hired the auditing firm of Melanson and Heath to review the 2010 accounting records. A three-year contract has been signed. I welcomed Roger Somero as our Accounting Clerk. He will assist with the financial duties and business regulations that the town is obligated to comply with daily, weekly, monthly and annually.

The New Hampshire Retirement system went through comprehensive changes this year forcing additional contributions by the town and the employees.

The Town receives internet, cable and phone service through Comcast. The Town also has a franchise agreement with Comcast. In 2011 the Comcast agreement was renegotiated and the amount of \$15,000 will be given to the town for video equipment upgrade.

The Furnace Brook Grant to remediate the runoff into various areas of Furnace Brook was accepted. Engineering has been done and the Highway Department provided labor and equipment to complete a trench project at the playground. Warwick Mills and the Highbridge Foundation have worked closely with the Town to receive a Community Development Block Grant to provide an educational program in their factory for Mascenic students to learn about biomass heating systems. A public hearing was held and plans are continuing to move forward.

Over the last two years Town officials have been involved in plans with the State of NH Department of Transportation for the replacement of Highbridge. Currently the replacement is scheduled for 2013.

In 2011 I completed my sixth year as your Town Administrator; I thank you for this opportunity to serve your town. If I can assist you in any way, please call me at 603-878-2772 ext.422 or email administrator@townofnewipswich.org.

BOARD OF ASSESSORS

EMERGENCY MANAGEMENT

Emergency Management continues to improve the local emergency operation plan to make sure we are prepared for major events. We also attend FEMA and New Hampshire sponsored trainings.

We continue to participate in the Greater Monadnock Public Health Network by attending quarterly meetings. New Ipswich Emergency Management co-sponsors the New Ipswich Citizens Emergency Response Team (CERT). Our mission is to help the community to prepare for, respond to, and recover from emergencies and disasters by providing a group of readily trained and available volunteers to supplement and assist local emergency response systems.

Emergency Management has presented programs to educate the public in family preparedness during disasters. The Emergency Management Office has disaster preparedness information. We invite everyone to stop by the town hall and get valuable information that could save your families during a disaster. Being prepared is everyone's responsibility.

We have secured a grant to review and update our Hazard Mitigation Plan with Southwest Regional Planning. The plan submission has been delayed. We are waiting upon the results of a fluidity study being conducted by the NH Department of Environmental Services - Water Division Dam Bureau. This study has also impacted the filing of our updated Emergency Operations Plan, currently under revision. Once the study has been completed and the results reported, both the Hazard Mitigation and Emergency Operation Plans will be revised appropriately. The Hazard Mitigation is required by FEMA. The plans need also be submitted to the New Hampshire Emergency Management Office. Without these documents filed and approved by the appropriate authorities, the town would be ineligible for grants and disaster relief funds.

Emergency Management was activated several times during 2011. During the summer heat we worked with town officials and the New Ipswich Pool staff to extend the hours of the swimming pool for the benefit of those able to use swimming as a relief. Both the Congregational Church and Souhegan Valley Ambulance Service were opened to provide cooling stations for citizens in need. We were on Level 2 stand by during Hurricane Irene. We are grateful the storm track shifted and we were spared the devastation suffered by our Vermont neighbors. Due to power loss, one citizen was relocated to a shelter in Nashua. We were also activated during the unanticipated October snow storm, and were fortunate shelters were not needed.

We rely upon our relationships with civic organizations to help us and deeply appreciate their cooperation in times of need (as demonstrated above). We would also like to thank the other departments, particularly the Police, Fire and DPW for their assistance and cooperation throughout the year and particularly during emergencies. We are always looking for volunteers to assist us and join our CERT Team. We welcome Kevin Rutledge as our new volunteer coordinator. Please consider coming out to join us in 2012.

Finally, it is with regret we announce the loss of former Communications Officer and one time Deputy Director, Richard Lehtonen. He gave many years of service to his community and his loss will be deeply felt by many.

FIRE RESCUE DEPARTMENT

In 2011 the department responded to 205 calls for service, the most calls we have had in quite some time. We were blessed again to have had very few serious fires. As always the single largest number of calls was assisting the Ambulance Service.

Ben Hatcher and Theresa Laplante were welcomed as new members of the department during 2011. The officers of the Department currently are Captain James Feldhusen, Captain Scott Vaillancourt, Lieutenant Peter Bergeron, Lieutenant Dennis Eastman, Lieutenant Eric Maxwell and Lieutenant Michael Cain.

As I mentioned in my report last year with all facets of emergency services becoming more complicated we started utilizing outside professional instructors for some of our training sessions. However, all training is still supervised by Deputy Chief Meredith Lund and conducted by the officers.

Our Fire Explorer post is still here and active but like the regular Department is always seeking new members.

The position of Fire Chief remains busy even with the decrease in new construction inspections.

The most difficult part of 2011 has been working without an office. We began the year in the Fire Station then during the summer began moving into building 2 and then during the fall we were evicted from building 2 and I spent most of my time in my pickup truck. During early winter we were offered a room at the Mascenic High School that I could use as an office. I want to thank Principal Trevor Courtney for letting the Fire Department have a place to work. We are now holding our training sessions at the Boynton Middle School. The Department is hoping to have a permanent home soon.

With the opening of the new Highbridge Hill Elementary School and the closing of Central and Appleton, Deputy Chief Meredith Lund, Deputy Chief Gary Somero and I spent countless hours revising all of the school district's emergency response plans as well as drawing up new plans for the new school.

I want to take this time to thank the members of the New Ipswich Fire Rescue Department for their continued commitment to the residents of New Ipswich. I also need to say thanks to my officers for all their work, advice and counsel.

FOREST FIRE WARDEN AND STATE FOREST RANGER

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forests & Lands, work collaboratively to reduce the risk and frequency of wild land fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. Under State law (RSA 227-L:17) a fire permit is required for all outside burning, unless the ground is completely covered with snow. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 603-271-1370 or www.des.state.nh.us for more information. Safe open burning requires diligence and responsibility. Help us to protect New Hampshire's forest resources. For more information please contact the Division of Forests & Lands at (603) 271-2214, or online at www.nhdfi.org.

Both in terms of the number of fires, as well as the number of acres burned, this past fire season was the smallest since records have been kept. Extensive rainfall virtually all season long kept the fire danger down. When fires did start they were kept very small. The largest fire for the season was only 5.4 acres which occurred in Littleton on May 2nd 2011. There was however a small window of high fire danger in the northern third of the state during July when little rainfall was recorded. During this time there were a number of lightning started fires which are fairly unusual in New Hampshire. As has been the case over the last few years, state budget constraints have limited the staffing of our statewide system of 16 fire lookout towers to Class III or higher fire danger days. Despite the reduction in the number of days staffed, our fire lookouts are credited with keeping most fires small and saving several structures due to their quick and accurate spotting capabilities. The towers fire spotting was supplemented by contracted aircraft and the NH Civil Air Patrol when the fire danger was especially high. Many homes in New Hampshire are located in the wild land urban interface, which is the area where homes and flammable wild land fuels intermix. Several of the fires during the 2011 season threatened structures, a constant reminder that forest fires burn more than just trees. Homeowners should take measures to prevent a wild land fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home free of flammable materials. Additional information and homeowner recommendations are available at www.firewise.org. Please help Smokey Bear, your local fire department, and the state's Forest Rangers by being fire wise and fire safe!

JOINT LOSS COMMITTEE

Under New Hampshire law an employer of 5 or more employees shall establish a Joint Loss Committee composed of equal numbers of management and employees to address and correct safety issues, develop safety programs, and allow and encourage injured workers to return to work. In 2011, the committee met eight times over the course of the year to discuss any workplace injury claims by employees, identify safety hazards, inspect the town buildings and correct problem areas. By addressing problems early on, it will lessen the likelihood of accidents, thus protecting employees and saving the town money.

The biggest accomplishment this year was to secure the access to the town office. This has been an ongoing area of concern for several years now and the subject of numerous Joint Loss meetings, as well as a mandate for change from the NH Department of Labor. With input from the police, town employees and other safety experts, we reconfigured how the public enters the town office. The old entrance became "employee's only", locked 24/7 and accessible through electronic key fobs. The new entrance was placed in a previously low use doorway in the middle of the office. Handicap access remained as before, with someone from the town clerk's office assisting as necessary. New lighting was put in place for the access sidewalk. The Town Clerk's office was moved to where the old Tax Collector's office was. Two new windows were put in place to serve the public. The land use clerk's office remained where it was, with a new service window put in place. With this change, we have put in place a barrier to the unlimited access the public had to the office previously. An office worker may let someone from the public in if they wish, but it's now their option. With this improvement, we feel that the workers are safer.

The return of mold in Building #2 was discussed also. A cease and desist order from the Selectmen was posted on the doors of the building. It was suggested by Phil St. Cyr of Primex that before anyone occupies this building in the future it be tested to make sure the mold has been removed.

The town buildings and pool were inspected, with mostly minor safety issues corrected. A new electrical switch was installed on the air compressor in the Highway Department to protect workers. Trip and falling hazards were removed and secured.

I wish to thank all the members of the Joint Loss Committee for their ongoing commitment to meet despite busy schedules. I also wish to thank Mary Fortier for her excellent job as secretary.

CEMETERY TRUSTEES

This past year with the economy still sluggish, the Town budget was once again reduced including the requested funds for our cemeteries. Again we reduced the number of cemetery mowing cycles and much of the brush clearing work that keeps growing and expanding each year. Also, the completion of the fencing around the South Cemetery was delayed again for another year.

In 2011, we continued to provide planned regular support for the funerals and provided cemetery clean-up and ground mowing maintenance focusing on the special dates when the cemeteries have a greater amount of visits and use, such as Memorial Day, July 4th, and the Children's Fair.

This year we provided burial services for eleven interments. Twice due to the closeness of graves, weather conditions and landscaping, it was necessary to hire outside contractors to open and close the graves safely. In addition, the Cemetery Trustees voted to look into hiring outside contractors to open and close graves.

The Cemetery Trustees then requested bids for the grave excavation work and hired a local contractor. In addition, all lot and burial fees were adjusted to reflect costs to the Town. The new revised Lot and Burial Schedule will be in effect for 2012. This new fee schedule still remains the lowest in the area and we will make every effort to continue to keep our costs down. However, we need to also continue to provide sufficient cemetery maintenance and improvements.

One point of concern that has been brought to the Trustees' attention that needs commenting on is that some folks, who are walking their dogs in the cemeteries, have been seen not removing "waste" material from the cemeteries. This act shows some disrespect to those interned and those who work in the cemetery. Please be considerate so no further steps need to be taken.

The 2012 budget level remains the same as what was requested for 2011. We hope the Town will approve our 2012 budget so that we can continue with much needed brush clearing, tree removal and memorial repair.

Thanks to George, David and Ollie for their continued good work.

PUBLIC WORKS DEPARTMENT

The Public Works Department repaired cross drainage pipes on Willard Road, Lower Ashby Road, Davis Village Road, Timbertop Road, Mason Road, Poor Farm Road, Perry Road, Old Tenney Road, and Andrew Drive. After we removed the guardrails on Page Hill Road, to better maintain the road during the winter months we added some extensions on the end of the culvert outlets. We graded dirt roads, applied dust control, and patched paved roads. We reclaimed and repaved Davis Village Road and Dark Lane and shimmed a section of Green Farm Road, Page Hill Road and Fox Farm Road that had large potholes and that had broken up during the spring thaw. Debris from past winter build up was cleaned up from all the paved roads to help with the drainage. We repaired catch basins on Page Hill Road, Poor Farm Road and Academy Road and repaired ditches along Davis Village Road, Dark Lane, Appleton Road, and Thayer Road. The guardrail by the river on Lower Ashby Road, which received damage from this past winter from a vehicle that hit it, has been replaced with new parts. We also dug several graves and spent many hours repairing and maintaining all town equipment and vehicles.

During the summer we replaced two overhead doors at the Highway Garage making it easier to bring in equipment with wings and front plows. The Public Works Department, in working with FB Environmental, has started implementing the Furnace Brook Restoration Project by putting some drainage in at the town playground parking lot. We are planning on doing more of these projects in 2012. The expenses for these projects are from the grant the town received from the New Hampshire Department of Environmental Services. The Public Works Department, in conjunction with the Building Committee, installed two one-thousand gallon propane tanks to heat building number two. We also installed a floor drain in the sally port at the old police station, with S & S Concrete, to take care of any run off from the cruisers.

In 2012, we are looking at paving Lower Ashby Road and to replace a culvert on Matson Road and extend the twin culvert on Thayer Road. This will make Lower Ashby Road safer and wider for the residents that use that section of the road. We will also continue working on the Furnace Brook Restoration Project to help clean up the brook from contaminated run off from road and parking lot drainage. We also will be installing a fifteen hundred gallon oil and sand separator for the sally port in building number two.

The Board of Selectmen revived the Road Committee. The goal for members Butch Leel, Marcus Rautiola, Ronald Stanley, Selectman George Lawrence, and Public Works Director Peter Goewey is to develop a multi-year plan to identify and prioritize town roads needing repair, and to estimate the cost to accomplish this. The committee has identified the following roads and estimated year and cost of repair. To accomplish these repairs the money will need to be approved by the voters on an annual basis in March. The committee will continue to meet and update the plan as needed.

All in all it is a great fit and we are very happy with the new space.

Our hours are still the same: Saturdays 9:00 am- 12:00 pm, except for the first Saturday of every month, which is 9:00 am- 3:00 pm if there are volunteers to cover the afternoon. We are closed on the Saturdays preceding a long holiday weekend to allow our volunteers some quality time with their families.

BUILDING INSPECTOR / CODE ENFORCEMENT OFFICER

This year the permit activity was the same as last year with many small projects and few larger ones. The school work was all completed in 2011 and the elementary students moved into their new school after the Christmas break.

This year my budget was cut by 40% so I had to make some adjustments in order to make my budget last all year. The only change I made was to eliminate code enforcement from my responsibilities. I deferred all code enforcement issues to the Board of Selectman for resolution. In 2012 the Board of Selectmen gave me the code enforcement responsibility again along with the funding to perform it.

No year seems to pass without some controversy but, this year was exceptionally busy for me. It seemed that every time one of the Police Chief's false accusations was successfully proven to be wrong he would come up with another complaint. After all the local officials grew tired of his harassment tactics and would not listen anymore, he turned to the State Fire Marshall's office. I went to the State Fire Marshall's office in Concord and met with all 5 inspectors for the Department of Safety. In that meeting we discussed building 2 and my role as the Building Inspector and also as a Building Committee volunteer. The conclusion of this meeting was that everything they saw in building 2 was fine but that the Police Chief has told them that he was going to file conflict of interest charges against me and that they would have no choice but to follow through on his complaint. They suggested that I consider giving up one of the positions to avoid the conflict of interest charge. I had asked the Selectmen to find an inspector from a nearby town to inspect building # 2 and I would stay on the Building Committee. The selectmen could not find any local inspectors who would inspect because they did not want to be caught up in this controversy created by the Police Chief. The Selectmen had me removed from the Building Committee so I suppose the Police Chief is one step closer to stopping the building 2 renovations.

BUILDING COMMITTEE

2011 was a frustrating year for the Building Committee.

Our intention, as charged by the Selectmen, was to complete the Police Station section of Building #2 and go on to other town building needs.

In March of 2011, the voters overwhelmingly approved \$70,000 to complete the Police section. We planned to expend this on bringing the electrical up to code, repairing ceilings, floors, walls, and windows, and completing the sally port begun by the Police Department.

As work began, four unexpected inspections were made by the State Fire Marshall's office. Even though our project head Jim Shultz was a volunteer, we were told his heading our project was a conflict of interest with his work as New Ipswich Building Inspector. The loss of his expertise set the project further back. Other items of concern to the Fire Marshall were already on our list for repair.

The last mold test reports of 2010 had given us confidence the building was healthy to work in. We always intended a final mold test before the Police Department, Fire Department, and other town employees went back to work in the building. But last winter, the Selectmen chose NOT to heat the building. While the heat is now back on, the building had become cold and damp over last winter, and mold returned. Consequently the Selectmen had a comprehensive mold retesting done, and the results were positive for mold, and forced the Selectmen to order all work on Building # 2 stopped.

We have obtained quotes to remediate the entire building, including areas for the Fire Department and Emergency Management as well as the Police Department section. These quotes are to remove all mold, strip the sheetrock from the inside of the exterior walls, add 3" closed cell foam insulation to insulate and also seal out moisture.

There is over \$40,000 remaining and encumbered from the 2011 article for completing the Police section. We are asking for \$135,000 this year to remediate the entire building, and finish the interior for the Fire Department, Police Department, and Emergency Management. By Emergency Management moving to Building #2, the area it presently occupies in the downstairs of the Town Office building becomes available for meetings and other Town use.

To ensure the work is done, we obtained quotes from contractors but hope to use as many volunteers as possible and so do more with the money.

We are proud to report our accomplishments in this building, and thank the voters for all the support and encouragement. We wish to recognize the donations and work of volunteers and local businesses.

The electrical needs to meet codes are almost completed. Doorways have been cut through most locations. This is no mean feat when considering the block walls are 12" thick. A new Sally Port door was cut in to the walls and a new overhead door was installed. As requested by the Chief of Police, windows were blocked up. A 6" thick floor in the Sally Port area was cut into 2x4 foot sections and removed. A drain was installed in the floor, a new floor was donated by S&S Concrete Floors, Inc. and then the bathroom was plumbed by a donation from Ralph Somero. Steel studding for more interior rooms was installed with assistance from Alan Soini, Nathan Lambert, and Ron Stanley. The Fire Marshall required a fire escape door in the hallway installed. The heat and A/C is operating. Tile and new doors are paid for and awaiting installation.

NOTICE

If you own real estate lots that were involuntarily merged by municipal action, you may be able to have those lots restored to their pre-merger status.

Your property may qualify if two or more lots were merged for zoning, assessing, or taxation purposes and the merger occurred:

- During your ownership, without your consent, or
- Prior to your ownership, if no previous owner consented to the merger.

To restore your property to pre-merger status, you must make a request to the local governing body no later than December 31, 2016.

Once restored your properties will once again become separable lots; however, they must still conform to applicable land use ordinances. Restoration does not cure non-conformity.

ZONING BOARD OF ADJUSTMENT

The New Ipswich Zoning Board of Adjustment is an all volunteer board composed of members of the community. The Board hears requests for special exceptions and variances from the zoning ordinances as well as appeals of administrative decisions.

For 2011, the Board was presented with nine applications. Three variances applications were approved while a variance and a special exception were denied. The remaining four applications were pending at the close of the year.

Mr. David Lage and Ms. Becky Doyle were appointed by the Board of Selectmen to join Mr. David J. Cotzin, Ms. Marianne Graham, and myself as regular members. Ms. Toni Lovell requested to become an alternate member, stepping down as a regular member. Toni's service has been and continues to be appreciated, along with that of alternate member, Mr. Clark S. Baldwin.

Our activity level increased significantly at the end of the year so the Board has an immediate need for alternate members. POLICE DEPARTMENT

The year 2011 started with petitioned warrant articles to modify the structure of the Town by eliminating the Town Administrator and changing the positions of Chief of Police and Road Agent to elected positions.

Last year, you were lead to believe that for \$70,000 dollars you could renovate the former police station and make it as good as new. I spent many frustrating hours trying to make the case that the building was not safe or properly remediated. Finally, the Board of Selectmen elected to hire another company to test the building for mold. The results were not a surprise, not to me anyway.

People associated with the project were hoping that they could quickly cover the problems with a fresh coat of paint and shiny new tile. "Move along, nothing to see here". To use a football reference, the Building Committee tried to snap the ball before the chief threw the challenge flag. Fortunately for all of us, they didn't get their play off in time and after review, it was determined to be a fumble. This probably saved the Town thousands in litigation, although it might be only temporary.

In this year's warrant, you will be asked to dump another \$130,000 into the building. And you will be told however untruthfully, that this will be enough money to "finish" the job. Hopefully, this time you will trust me, and say "enough is enough".

In 2011, the Police Department handled 4,437 calls for service, 43 reportable accidents, and 267 criminal complaints were filed with the Courts.

We lost two officers this year; Officer Chris Follomon and Officer Mark Slavin both left the Police Department to go to work for other agencies. We have invested significant amounts of money in our Police Officers to get them to a level of performance that this job requires. Unfortunately, there are many agencies that look to recruit seasoned officers who are not being properly compensated for the responsibilities they are tasked with. We fell victim to this twice in 2011. Don't get me wrong, it's not all about the money. But with no salary increases and a majority that has turned a blind eye to the obvious, you have to weigh your options.

On a positive note, Mary Fortier transferred from the Town Office to the Police Department as the secretary. Mary has been a welcome addition to the Police Department.

Unfortunately, we have drastically cut services that we used to provide. There are many calls for service that will go unanswered. This is a very scary scenario for a community this size in today's world.

CONSERVATION COMMISSION

The purpose of the Conservation Commission is to insure the "*proper utilization and protection of the natural resources and for the protection of watershed resources of the said city or town*" (RSA 36-A). Our activities are directly related to this purpose. Activities for 2011 are outlined below:

- During the year Commission members maintained hiking trails located on town conservation land. The hiking trails, provided for the use and enjoyment of the public, require ongoing maintenance such as brush cutting, bridge repair and other trail grooming activities.
- Proceeds from the Current Use Tax enabled the Commission to purchase two parcels of land. The first (35A) provides for the protection of an area in the heart of Tophet Swamp. The second, (197A) provides permanent protection for nearly a mile of the Wapack Trail and protects the summit of New Ipswich Mountain (1881 feet), the highest point in town. What is the lowest?
- The Conservation Commission continued the publication of a series of documents to inform the citizens of New Ipswich about the value of the town's natural resources and the importance of protecting those resources. Each document, known as the "*Green Sheet*", covers such topics as timber harvesting, stream buffers and wetlands.
- The Conservation Commission is partnering with the State of New Hampshire, Department of Environmental Services (DES), in testing the waters of Furnace Brook with the objective of increasing the water quality of the brook. The testing teams include members of the Conservation Commission and student volunteers. The testing programming is under the direction of Dixie Rhoads.
- The Commission continued its ongoing review of Wetland Permits and monitoring development activities adjacent to the wetlands. The Commission is very concerned about the impact increased development will have on the town's wetlands. The wetlands are important for wildlife habitat, water storage and flood control and quality of life. Wetlands are one of the town's most valuable natural resources, and your Commission focuses on time protecting them.
- Members of the Conservation Commission's Easement Monitoring Teams monitored the various conservation lands managed by the Conservation Commission. The purpose of the monitoring is to insure that the conservation values of the lands are not negatively impacted.
- The Conservation Commission sent letters to town boards, offering comments and suggestions on the impact of development on the town's natural resources.
- The Commission is looking for full or part-time members who have an interest in protecting the town's natural resources and are able to give time to various Commission projects. If you are interested, contact the Town Office.

LIBRARY

2011 was a very successful year for the New Ipswich Library. New Ipswich residents enjoyed many of the programs, activities, and resources the library has to offer. The trustees and staff are proud to say they have managed to operate within the previous year's budget, without cutting services.

The many children's programs offered at the library continue to be very popular. The Summer Reading Program had over 29 children participating. Children were able to earn prizes based on the amount of reading they completed. Children continue to enjoy Bedtime Story Hour every Monday evening at 7 pm. Preschool Story Hour has seen its patronage flourish. The children enjoy songs, crafts and stories every Tuesday morning at 10 am, making for a very lively program.

In addition to the many children's programs, many adult clubs meet at the library. Book Club still remains very popular, and meets the first Wednesday of every month. An array of books are selected and then discussed, giving many different perspectives and opinions in lively discussions. Scrabble Club has been meeting for two years now and has been challenging players every other Monday at 7 pm. Photography Club meets the second Wednesday every month from 6 pm to 8 pm. Many of the photographs taken are on display in the library.

Many free educational programs were enjoyed by patrons in 2011. Margaret Hagen presented a workshop on how to grow your own food this past spring. A presentation on how to reduce stress and one on finances were given. A favorite program in 2011 was deemed to be the puppet show, with a fantastic showing of residents. Flu shots were offered in September. Many town organizations meet in the back meeting room including American Youth Soccer Organization. This room is also often used for student tutoring.

The library still utilizes the NH State Inter-Library Loan program. This opens up local and state resources for all New Ipswich residents as well as home schooled children.

The library offers free Wi-Fi and this service has seen active usage. Patrons also continue to use the public access computers which are connected to the Library's internet access. This free service has been helpful for home schooled children, patrons seeking employment, and browsing the internet.

In 2011 staff and trustees worked to implement E-books, which is free downloadable books to electronic devices, ie, Ipads, Nooks, MP3 players, etc. This service should be completed and available to New Ipswich residents in March 2012.

We sincerely thank our library patrons for using the library and we also thank many charitable individuals and organizations such as Stearns Burton Lecture Fund, The Children's Fair, and numerous Friends of the Library for their on-going support.

SOUHEGAN VALLEY AMBULANCE SERVICE INC

The Souhegan Valley Ambulance Service Inc. (SVAS) is a non-profit emergency medical transport service which was organized on September 1, 1972. We serve the towns of New Ipswich and Greenville. SVAS responded to approximately 460 calls during 2011 and also provided a standby ambulance for many community events. We have a very dedicated membership that spends countless hours ensuring the highest quality of care for our community. These hours not only include responses to emergency calls but also the many hours of training required to maintain medical licenses, maintain equipment, and complete the required day-to-day administrative tasks.

In 2011, we handled 543 patient requests, 336 in the Town of New Ipswich and 207 in Greenville. While all transported patients are billed for services, many of our communities' residents have suffered in the economic downturn. The loss of jobs has resulted in the loss of insurance or savings to cover medical treatments. Unfortunately, this translates to an increase in hardship requests for the ambulance to write off costs incurred when we provide service. These losses become the burden of the community at large. The towns of Greenville and New Ipswich have partnered with Souhegan over the years by contributing to our operating budget. As our costs increase and local residents are less able to pay their individual charges, the burden is spread through the tax base by increasing our funding requests to the towns. We are deeply indebted to our communities for continuing their support.

Economic considerations have affected our staffing levels as well. During the past year we have lost Emergency Medical Technicians to higher paying jobs with regular hours. Like so many organizations we struggle to do more with less. We are always looking for more qualified personnel so if you have ever considered serving your community in this capacity, now would be a good time to take the necessary steps to earn your license.

The Board of Directors would like to extend its thanks to the community for its support of the ambulance service. We would also like to express our sincere appreciation to the members of Souhegan Valley Ambulance Service and their families (who put up with the countless hours and interrupted lives. Thank you for your time and dedication.

HEALTH OFFICER

This past year has brought many challenges to the local communities. Unfortunately smaller towns like New Ipswich have limited resources to meet the increasing demands, but I continue to find resourceful ways to help our residents working in collaboration with the Welfare Officer and other local officials.

In February of 2011 the rules and guidelines for septic systems changed, giving property owners a small grace period that had already had repair permits approved completed by June 1st, 2011. That window has closed and by this occurrence the property owner now has to have a new septic system design and complete an application to DES -Sub Surface. For a large number of property owners this has caused a financial burden; it has been difficult to find financial help with funding a new septic system. Should you have any questions in regard to the new rules and regulations on septic systems or need financial assistance with a new septic system project, please call Dick Desave DES -Sub Surface at 603-271-3503.

There has been an increase in complaints regarding poor housing on behalf of renters and more inspections of poor living conditions, complaints of poor heating, no hot water, septic systems, trash build up, bed bugs, and mold concerns to name a few.

In the recent months the Health Department has been dealing with the issue of dumping on the side of the road and empty lots. I realize that the cost of disposing of old mattresses, TV's, tires, and trash is costly but remember your neighbors and fellow town residents all live here and it's a shame to drive down the road and see a couch and bureau thrown off to the side of the road near residential homes. It's the first thing people see when entering New Ipswich, and it does have a cost to us all. First a report is made to the Police Department and then request the Highway Department is asked to go pick it up and dispose of it. We need your help; if you see dumping please call the Town Hall or the Police Department to report it.
