Voted to raise and appropriate \$8,169.00 to defray Town Charges for the ensuing year.

ARTICLE III

Voted to raise and appropriate \$5,000.00 for Summer Maintenance of highways and bridges, and for any construction of the same, for the ensuing year.

ARTICLE IV

Voted to raise and appropriate \$5,000.00 for Winter Maintenance

ance of highways and bridges for the ensuing year.

ARTICLE V

Voted to raise and appropriate \$1,550.00 for the General Expenses of the Highway Department.

ARTICLE VI

Voted to raise and appropriate the sum of \$505.64 for Town Road Aid in order to receive the full State share of \$3,370.91.

ARTICLE VII

Voted to raise and appropriate \$350.00 to maintain adequate Public Library service or to supplement funds otherwise provided.

ARTICLE VIII

Voted to raise and appropriate \$700.00 for the operation of the Fire Department and the purchase and maintenance of equipment.

ARTICLE IX

Voted to authorize Selectmen to borrow money in anticipation of taxes.

ARTICLE X

Voted to add to the capital reserve fund \$2,462.87 for the purpose of purchasing new highway equipment, and designated the Selectmen as agents of the Town to make withdrawals from said fund to carry out the purpose for which it was established.

ARTICLE XI

Voted to authorize the Selectmen to revise town officers' and employees' salaries.

ARTICLE XII

Voted to raise and appropriate the sum of \$100.00 to support the Community Mental Health Clinic, of the Monadnock Family and Mental Health Service, said services operating under the provisions of the Community Mental Health Services Act of New Hampshire, with State Grant-in-Aid.

ARTICLE XIII

Voted to pass over.

ARTICLE XIV

Voted to accept the reports of Agents, Auditors, and Committees, as printed in the Town Report, adding page 50, detailed statement of payments to the 1970 Town Report.

ARTICLE XV

Public meetings will be held to discuss the building code.
Voted the meeting be dissolved at 11:00 p.m.

THE STATE OF NEW HAMPSHIRE

TOWN WARRANT

To the inhabitants of the Town of Sullivan in the County of Cheshire in said State, qualified to vote in Town affairs.

You are hereby notified to meet at the Community Hall in said Sullivan on Tuesday, the ninth day of March next, at 7:30 p.m. in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise and appropriate such sums of money as be judged necessary to defray Town Charges for the ensuing year.
3. To raise and appropriate such sums of money, including that sum required by law, as may be judged necessary, for Summer Maintenance of highways and bridges, and for any construction of the same, for the ensuing year.
4. To raise and appropriate such sums of money as may be judged necessary for the Winter Maintenance of highways and bridges for the ensuing year.
5. To raise and appropriate such sums of money as may be judged necessary for the General Expenses of the Highway Department.
6. To raise and appropriate the sum of \$516.64 for Town Road Aid in order to receive the full State's share of \$3,443.63.
7. To raise and appropriate such sums of money as may be judged necessary to provide and maintain adequate Public Library service or to supplement funds otherwise provided.
8. To raise and appropriate such sums of money as may be judged necessary for the operation of the Fire Department and the purchase and maintenance of equipment.
9. To authorize the Selectmen to borrow money in anticipation of taxes.
10. To see if the Town will vote to add to the Capital Reserve Fund, for the purpose of purchasing new highway equipment, the sum of \$1,187.63, and to designate the Selectmen as agents of the Town

to make withdrawals from said fund to carry out the purpose for which it was established.

11. To see if the Town will vote to revise the Town Officer's and Town Employees' salaries or take any action thereon.

12. To see if the Town will vote to accept the following Cemetery Trust Funds: (a) Edwin A. Blood Fund \$100.00. (b) Edward L. Jewett Fund \$100.00 (c) Cordingley Family Fund \$200.00.

13. To see if the Town will vote to raise and appropriate the sum of \$218.86, to support the Ashuelot Valley Regional Planning Commission, or take any action thereon.

14. To see if the Town will vote to raise and appropriate the sum of \$70.60, to support the Monadnock Health and Welfare Council, or take any action thereon.

15. Shall the provisions of Chapter 287 of the Revised Statutes Annotated relative to playing games of Beano be adopted in this town. (By Petition).

16. To see if the Town will vote to establish a Planning Board of five (5) or seven (7) members, with duties as set forth in Sections 1-15, Chapter 36, New Hampshire Revised Statutes Annotated 1955, to make a study of the Town's development and report to the Town appropriate recommendations, for the promotion and maintenance of the Town's best development. The Board shall consist of one Selectman and four (4) or six (6) other citizens appointed by the Selectmen as provided in Chapter 36, New Hampshire Revised Statutes Annotated 1955.

17. To see if the Town will vote to raise and appropriate a sum of money to build a building to house Town of Sullivan Road Equipment. (By Petition).

18. To see if the Town will vote to have a Selectman's Room located in the room adjoining the library in the East Sullivan Community Hall. (By Petition).

19. To accept the reports of Agents, Auditors, and Committees, as printed in the Town Report.

20. To transact any other business which may legally come before said meeting and to listen to opinions of a purely advisory nature in regard to the conduct of Town affairs for the ensuing year.

REPORT OF THE FOREST FIRE WARDEN AND DISTRICT CHIEF

The 1970 forest fire season was a quiet one in this area, quiet in part because of your continued cooperation and favorable weather conditions.

Fires that did occur were, for the most part, caused by debris burning, children and smokers.

The elimination of these three causes of forest fires would drastically change this picture. To bring about this change we make the following suggestions:

1. When the ground is not covered with snow a permit to burn must be obtained from the Forest Fire Warden. This permit covers waste burning, even if in an incinerator, grass burning, as well as garden trash and brush burning. Such burning is restricted by regulation to prior to 9:00 a.m. and after 5:00 p.m. with the following exceptions:

Commercial or Industrial burning is permissible at any time under normal conditions but only with the approval of the District Chief and a written permit from the Forest Fire Warden.

2. Fires caused by children can be prevented only with the complete cooperation of parents in the supervision of their children. This action will help to prevent fires and may save a life, the life of your child. Take time to explain this to your child, won't you?
3. Forest fires caused by smokers can be reduced in number by the exercise of more care in the discarding of matches and smoking material, whether from a vehicle or by a hiker. In all cases, make sure that the butt or match you discard is out, dead out. Smokey says, "Thanks for your help," and invites you to join with him in setting a good example for others in the prevention of fires and the protection of our environment.
