## WARRANT FOR ANNUAL TOWN MEETING.



STATE OF NEW HAMPSHIRE.

*To the inhabitants of the town of Wolfeboro qualified to vote in town affairs:—*

You are hereby notified to meet in Brewster Memorial Hall, in said town, on the second Tuesday of March next, at nine o'clock in the forenoon, to act upon the following subjects:

### ARTICLE I.

To choose a Town Clerk for the ensuing year.

### ARTICLE II.

To choose three Selectmen for the ensuing year.

### ARTICLE III.

To choose three Road Agents for the ensuing year.

### ARTICLE IV.

To choose two Auditors for the ensuing year.

### ARTICLE V.

To choose a Fish and Game Warden for the ensuing year.

### ARTICLE VI.

To choose a Collector of Taxes, Treasurer and all other necessary town officers.

### ARTICLE VII.

To see if the town will vote to authorize the Selectmen to appoint a Book-keeper to keep the books of the Wolfeboro Water Works.

## ARTICLE VIII.

To see what sum of money the town will vote to raise to defray town expenses.

## ARTICLE IX.

To see what sum of money the town will vote to raise to pay on its indebtedness.

## ARTICLE X.

To see what sum of money the town will vote to raise to pay for breaking roads the past winter.

## ARTICLE XI.

To see what sum of money the town will vote to raise to repair the highways the ensuing year in addition to that required by law.

## ARTICLE XII.

To see what sum of money the town will vote to raise as a tax for each hydrant, the same to be held as a Sinking Fund, to pay indebtedness of said Water Works.

## ARTICLE XIII.

To see what sum of money the town will vote to raise and pay each fireman legally returned for the year 1894, in addition to that required by law.

## ARTICLE XIV.

To see what sum of money the town will vote to raise and pay to J. R. Newell Post, No. 61, G. A. R., of said town, to assist in defraying the expenses of decorating the graves of deceased soldiers and other necessary expenses of Memorial Day, May 30, 1894.

## ARTICLE XV.

To see if the town will vote to reconsider the vote passed March 14th, 1893, in relation to building a Receiving Tomb, and to use the appropriation for the same in the redemption of town bonds.

## ARTICLE XVI.

To see if the town will vote to extend the system of Water Works from Goose Corner, to the residence of Dr. Henry F. Libbey, and to raise money for the same, agreeable to a petition signed by Gorham B. Humphrey and others.

## ARTICLE XVII.

To see if the town will vote to extend the system of Water Works to the residence of Elmira H. Varney, and to raise money for the same agreeable to a petition signed by F. W. Peavey and others.

## ARTICLE XVIII.

To see what action the town will take in regard to publishing its history and raise money for the same.

## ARTICLE XIX.

To see if the town will vote to raise the sum of twelve hundred dollars to pay its indebtedness to the Wolfeboro Loan & Banking Company for money hired to pay for water rights around Beech Pond.

## ARTICLE XX.

To see if the town will vote to cement the Reservoir, and raise money for the same.

## ARTICLE XXI.

To see what action the town will take in regard to

settlement of claims for damages caused by leakage or overflow of Reservoir.

### ARTICLE XXII.

To see if the town will vote to sell the Kimball pasture (so called) and authorize the Selectmen to compromise any adverse claims to the same that they may deem for the best interest of the town, agreeable to a petition signed by A. B. Rust and others.

### ARTICLE XXIII.

To transact any other business that may legally come before said meeting.

GENTLEMEN: In submitting our financial report, we would preface it with a few remarks as to the condition and working of the system.

During the past year, the excellent and satisfactory working of the system has continued. No serious or expensive breaks have occurred. Every blow-off, valve, air-cocks, and hydrants, as far as is possible to be known, is now in perfect condition. There is an abundance supply of water in the Pond, and at no time since the construction of the works has there been less than four feet of water over the intake.

Last summer we found we were not getting sufficient water to keep the Reservoir full, and upon a thorough examination we discovered the cast iron strainers at the

intake were so badly corroded that they would not admit sufficient water to supply the demands, and we removed them and put in their places some copper strainers that have given satisfactory results so far.

There have been eighteen services added this season, making in all, three hundred and fifty-five.

We have moved one hydrant and repaired two, the top being split on one and the other the valve being so injured that we had to procure a new base. In our opinion there should be something done to the Reservoir in the way of making it tight, so there should be no more waste of water through its banks and thereby injuring the Reservoir.
