To the inhabitants of the Town of Randolph in the County
[L. S.] of Coos in said State, qualified to vote in Town Affairs:..

You are hereby notified to meet at the Town Hall in said Randolph on Tuesday, the 8th day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for same.
3. To raise such sums of money as may be necessary to repair highways and bridges for the ensuing year, and make appropriation for same.
4. To raise such sums of money as may be necessary for support of the library for the ensuing year, and make appropriation for same.
5. To raise such sums of money as may be necessary for care of the cemetery, including painting the fence, for the ensuing year, and make appropriation for same.
6. To raise such sums of money as may be necessary to secure Trunk Line maintenance for the ensuing year, and make appropriation for same.
7. To see if the town will vote to raise the sum of \$5,000.00 for the year 1927 or 1928, and pay \$1,000.00 the year the Federal Aid is expended and then in 1935, pay \$1,000.00 with interest, and each year thereafter a like sum until paid.
8. To see if the town will vote to authorize the Selectmen in case of damage being done by fire, to procure aid from the Town of Gorham and pay for same with any money in the treasury not otherwise appropriated.
