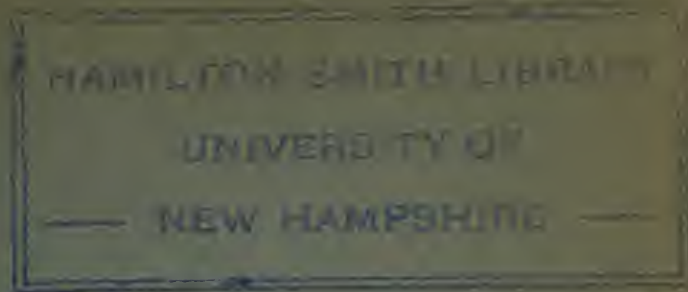


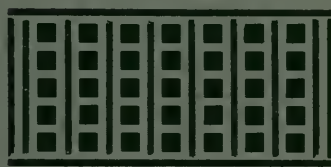

Warrant for the Annual Town Meeting, March 8, 1938

THE STATE OF NEW HAMPSHIRE

*To the inhabitants of the town of Tuftonboro in the (L. S.)
County of Carroll in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall in said Tuftonboro on Tuesday, the eighth (8th) day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.

2. To elect a Delegate to the Convention to revise the Constitution of the State of New Hampshire.

3. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of same. (\$8,451.50 figures of Budget Committee).

4. To see if the Town will vote to raise and appropriate the sum of one hundred dollars (\$100) for the Huggins Hospital.

5. To see if the Town will vote to raise and appropriate the sum of one hundred and twenty-eight dollars (\$128) for the Lakes Region Association.

6. To see if the Town will vote to raise and appropriate the sum of one hundred dollars (\$100) for cemeteries in the town, said money to be used to remove trees and brush from the neglected cemeteries, to repair fences and walls and make these neglected cemeteries look as though Tuftonboro had respect for her dead.

7. To see if the Town will vote to raise and appropriate the sum of one thousand dollars (\$1,000) for legal expense, said money for the purpose of paying legal expense of the Town in the Tuftonboro v. Iva M. Willard case.

8. To see if the Town will vote to raise and appropriate the sum of one thousand nine hundred and eighteen dollars (\$1,918), the State to raise one thousand nine hundred and eighteen dollars (\$1,918), for State Aid Construction on the Ledge Hill Road.

9. To see if the Town will vote to raise and appropriate the sum of three thousand dollars (\$3,000), and authorize the Selectmen to hire the sum of six thousand dollars (\$6,000) in long term notes, for the following purposes: to purchase two fire trucks with pumps and equipment similar to Moultonboro's new fire truck, (one to be placed at Melvin Village and the other at Mirror Lake), for the purchase of fire hose, digging water holes, and to provide funds for maintenance for the ensuing year.

10. To see if the Town will vote to raise and appropriate the sum of four thousand dollars (\$4,000) for tarring and improving the following roads: Tuftonboro Neck, fifteen hundred dollars (\$1,500); Wawbeek, three hundred dollars (\$300); the cross road between Union Wharf and Town Hall Schoolhouse, nine hundred and fifty dollars (\$950); High Street and New Road, one thousand dollars (\$1,000); Ledge Hill, two hundred and fifty dollars (\$250).

11. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes of the levy of 1938.

12. To transact any other business that may legally come before said meeting.
