Town Meeting Warrant

State of New Hampshire

To the inhabitants of the Town of Benton qualified to vote in Town affairs:

You are hereby notified to meet at the Benton Town Hall in said Benton on the second Tuesday of March next, the eleventh, at ten o'clock in the forenoon, to act upon the following subjects—

Article 1. To choose a Town Clerk, one Selectman for three years, one Highway Agent, one Tax Collector, one Town Treasurer, one Auditor, one Trustee of Trust Funds for three years, one Library Trustee for three years and all other necessary Town Officers and Agents for the ensuing year.

Article 2. To hear the Reports of Officers and Agents heretofore chosen and pass any vote relating thereto.

Article 3. To see how much money the Town will vote to raise and appropriate for Town Officers' salaries and expenses and for the repair and maintenance and construction of highways and bridges, for the observance of Memorial Day and for all other Town charges and expenses for the ensuing year.

Article 4. To see what action the Town will take in regards to how Memorial Day will be observed and where.

Article 5. To see what action the Town will take to authorize the Selectmen to borrow money in anticipation of Taxes. Article 6. To see what action the Town will take in regards to keeping Town Highways open for motor vehicle traffic for the winter season including snow removal and sanding and make the necessary appropriation of the same.

Article 7. To see if the Town will vote to dispense with delivery of inventory blanks until April 1st.

Article 8. To see what action the Town will take in regards to securing State Aid for highways and to raise and appropriate such sums of money as may be necessary for that purpose.

Article 9. To see if the Town will vote to raise \$15.00 for the White Mountain Region Association.

Article 10. To transact any other business that may legally come before said meeting.

REPORT OF THE SUPERINTENDENT

OF SCHOOLS

To the School Board and Citizens of Benton:

I herewith present my seventh annual report as superintendent of your schools.

The total enrollment for 1939-1940 was 24, the average membership was 21.48; the percent of attendance, 94.7%, and the number of cases of tardiness, 46. The percent of attendance was better than that for the previous year. There were four pupils attending high school at Woodsville and four at Bath. There were two elementary pupils at Glencliff and two at East Haverhill.

This year the enrollment to date is 15 which is much smaller than for the past few years. There are four pupils attending high schools and five pupils attending elementary schools outside the district.

Miss Kathryn Driscoll of North Woodstock replaced Mrs. Louise Ross as your teacher this year. Miss Driscoll is a graduate of Plymouth Teachers College and has had several years of experience in the schools of Pittsburgh, N. H.

During the past year the school building has been greatly improved in appearance by painting it both inside and outside. The School Board purchased a second-hand jacketed heater at a very reasonable price. This heater should be much more efficient than the old stove which it replaced.

The School Board is asking for an appropriation this year of \$900, which is \$600 less than that of the previous year. This has been made possible by a larger estimated balance, more state aid, and by a reduction in the cost of high school tuition.

I wish to thank the members of the School Board for their cooperation during the past year.
