# Warrant The State of New Hampshire Sullivan, SS: Town of Plainfield

To the inhabitants of the Town of Plainfield in the County of Sullivan in said state, qualified to vote in town affairs;

You are hereby notified to meet at the Plainfield School gymnasium on Tuesday, the fourteenth day of March next, at 10 o'clock in the forenoon to act upon the following subjects:

ARTICLE I: To choose by ballot one selectman for three years, one moderator for two years, one trustee of trust funds for three years, one auditor for two years, two library trustees for three years, one supervisor of the check list for six years, and any other necessary town officers.

ARTICLE II: To bring in your votes on the following questions:

Question 1. Shall the town adopt the new provisions of RSA 72:43-c relative to expanded exemptions on real estate for the elderly, changing the eligibility requirement that a person may own no more than \$35,000 in assets of any kind to a requirement that a person may own no more than \$50,000 in assets of any kind?

(Yes) (No)

Question 2. Shall the town adopt the new provisions of R.S.A. 72:43-b relative to expanded exemption on real estate for the elderly, changing the basis of the exemption from the equalized assessed value to the actual assessed valuation?

(Yes) (No)

The polls shall remain open from ten o'clock in the forenoon until six o'clock in the afternoon for voting on Articles I and II.

You are further notified to meet at the Plainfield School Gymnasium on Saturday the eighteenth day of March next at two o'clock in the afternoon to act upon the following subjects:

ARTICLE III: To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes.

ARTICLE IV: To see if the town will vote to authorize withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 the following sums for use as setoffs against operating budget appropriations: Welfare, \$1,200; Ambulance, \$1,800; Nursing Service, \$1,700; Land fill, \$6,000; Libraries \$9,000; Conservation, \$3,00; and Police, \$6,000.

ARTICLE V: To see if the town will vote to raise and appropriate a sum of money to purchase a new pick-up truck for the Highway Department, and to authorize the selectmen to sell or trade the 1972 pick-up truck now owned by the town and apply the proceeds of such sale or trade to the purchase price of the new truck.

ARTICLE VI: To see if the town will vote to raise and appropriate a sum of money to purchase new high-band radios and monitors for the Plainfield and Meriden Fire Departments.

ARTICLE VII: To see if the town will vote to raise and appropriate the sum of \$1,100 for 1978 membership dues in the Upper Valley-Lake Sunapee Council.

ARTICLE VIII: To see what action the town will take with respect to reports of town officers.

ARTICLE IX: To raise and appropriate such sums of money as may be necessary to defray town charges for the 1978 fiscal year.

ARTICLE X: To see if the town will vote to raise and appropriate funds to properly record various vital statistic records.

ARTICLE XI: To see if the town will vote to authorize the selectmen to dispose of property acquired by Collector's deed.

ARTICLE XII: To see if the town will vote to increase the real estate tax exemption on dormitories, dining halls, and kitchens of Kimball Union Academy above \$150,000 as allowed in R.S.A. 72:23 and to take any other necessary action relating thereto.

ARTICLE XIII: To see if the town will vote to instruct the moderator to appoint a Finance Committee of six persons to advise the selectmen and other town officers in the prudential affairs of the town.

ARTICLE XVII: To see if the town will vote to authorize the selectmen to draw up an ordinance to regulate on-street parking during snow removal months.

ARTICLE XVIII: To see if the town will vote to accept a parcel of land from William T. and Hazel H. McNamara for purposes of expanding the River Cemetery.

ARTICLE XIX: To see if the town will vote to authorize the selectmen and trustees of trust funds to negotiate for and acquire in the name of the town additional land for the Plainfield Plain cemetery.

ARTICLE XX: To see if the town will vote to instruct the moderator to appoint a committee to study the administrative structure of the town's government and the possible creation of the position of Administrative Assistant to the Selectmen, said committee to present its report and recommendations no later than the 1979 annual town meeting.

ARTICLE XXI: To see if the town will vote to direct the selectmen to appoint a five member committee to study the need for housing for the elderly in Plainfield and to further explore ways of funding such housing under FHA and/or the New Hampshire Housing Authority, said committee to report by the next annual town meeting. ARTICLE XXII: To see if the town will vote to raise and appropriate the sum of three hundred and seventeen dollars (\$317.00) as its share of the cost of publicizing and promoting the natural attractions of the Dartmouth-Lake Sunapee Region and encouraging vacation travel in the region. ARTICLE XXIII: To see if the town will vote to designate Harriman Hill Road a scenic road as provided in R.S.A. 253:17. (by petition)

ARTICLE XXIV: To see what action the town will take with respect to the following: "On the ballot petition of Charles Flickinger and others to see if Plainfield citizens oppose the concept of Construction Work in Progress (CWIP) as a devise by Public Service Company of New Hampshire to pass construction costs on to the consumer in the form of higher electric rates. "Section 3.3 Home Occupations. Any resident may use a minor portion of his or her dwelling, outbuildings, and/or a portion of the homestead premises for a 'home occupation' which is customary in residential areas and does not change the character thereof. The establishment and continuance of a 'home occupation' shall be subject to the following conditions:

- (1) Such use shall be conducted on the homestead and only by the inhabitants thereof.
- (2) There shall be no advertising display or other indications of home occupation on the premises except a customary sign or nameplate for identification purposes only, such sign not to exceed two square feet in area.
- (3) A 'home occupation' shall provide additional offstreet parking area reasonably adequate to accommodate the needs created by the home occupation. Such parking shall be not less than one space for each 300 square feet of floor area devoted to the 'home occupation.' Such parking shall be provided on the lot utilized for the 'home occupation.'
- (4) For further requirements and definitions, see Section 8.7 of Article VIII."

Article VIII Section 8.7:

"Home Occupation: An accessory use of a service character that is incidental and secondary to the use of the homestead for residential purposes, and does not change the residential character thereof. 'Home occupations' shall include the production and sale of home grown agricultural products and such customary uses as workrooms for craftsmen, artists, tutors, beauticians, dressmakers, milliners, photographers, cabinetmakers, radio repairmen, as well as incidental work and storage areas in connection with off-premises trades such as those of builder, carpenter, electrician, painter, blacksmith, plumber, tree surgeon, or landscape gardner. The business of selling merchandise, supplies or products other than incidental retail sales in connection with other permitted uses shall not be considered a home occupation use."

Ouestion 15 was voted in the affirmative and it was so declared.

Question 16: Do you favor amending Article III Section 3.6 and the Mobile Home Ordinance Section 2.3 by deleting each section and substituting in its place the following: 377 (yes) 87 (no)

"SECTION 3.6 Travel Trailers, Occupancy and Storage. Camping trailers (whether of the truck-mounted or towed varieties) or motor coaches may be occupied for a period of 14 consecutive days in the Town of Plainfield without a special permit hereunder. For a period of longer than 14 consecutive days, a special permit authorizing occupancy must be issued by the Zoning Administrator. Such special permit shall be for a period not to exceed 90 days in any 12-month period. Camping trailers or motor coaches may be garaged or stored on premises in the Town occupied by the person in charge of the trailer or coach."

"2.3 Mobile homes that are not occupied as residence may be temporarily parked or stored in the Town of Plainfield only as a special exception hereunder pursuant to prior permit issued by the Board of Adjustment and subject to such terms and conditions as the Board of Adjustment may find necessary in order to safeguard the purposes of the ordinance."

Question 16 was voted in the affirmative and it was so declared.

Question 17: Do you favor amending Article IV Section 4.2 to read as follows: 380 (yes) 80 (no)

Section 4.2 Combination of Contiguous Lots. When two or more lots or parcels of land, either of which lacks adequate area and/or dimension to satisfy the requirements of the zoning district in which they are located, are contiguous and are held in one ownership for a period of more than three years, they shall be considered to be one zoning lot or parcel for the purposes of the Ordinance."

Question 17 was voted in the affirmative and it was so declared.

Then the following came forward and took the oath of office in epen meeting.

Resolved: That the Town authorize and instruct the Selectmen to withdraw from the Revenue Sharing Fund established under provisions of the State and Local Assistance Act of 1972 the sum of \$28,000 in principal and interest for use as setoffs against the following operating budget appropriations: Welfare, \$9,000; Libraries, \$9,000; Visiting Nurse, \$2,000; Ambulance, \$1,500; Landfill and solid waste removal, \$5,500; and Conservation, \$1,000.

It was voted in the affirmative and it was so declared.

#### **ARTICLE V**

The following resolution was offered and it was moved and seconded that it be adopted.

Resolved: That the Town authorize and instruct the Selectmen to purchase a new dump truck for the Highway department, that the sum of \$23,500 be raised and appropriated for said purpose, with \$5,500 to be raised through current years appropriation and the balance through issuance of serial notes in the name of the town to be retired one each year beginning in 1978, and that the Selectmen sell or trade the 1969 International truck now owned by the Town and apply the proceeds from such sale or trade toward the purchase of the new truck.

It was so voted in the affirmative and it was so declared.

#### **ARTICLE VI**

The following resolution was offered and it was moved and seconded that it be adopted.

Resolved: That the Town accept the reports of the Town Officers, as printed in the 1976 annual report, subject to corrections and that a corrected copy be placed on file with the Town Clerk.

It was voted in the affirmative and it was so declared.

#### ARTICLE VII

The following resolution was offered and it was moved and seconded that it be adopted.

Resolved: That the Town raise and appropriate the sum of \$314,731 to defray town charges for the 1977 fiscal year.

The following amendment to the resolution was made and seconded.

Resolved: That the appropriation for general expense of the Highway Department be increased by \$8,000 to make it \$15,500 and the total appropriation for town charges by \$322,731, in order to effect the repairs of Mill Bridge over Bloods Brook.

The amendment was voted in the affirmative and it was so declared.

Resolved: That the Town provide indemnification for selectmen, town officers and agents and town employees for personal loss or expense including reasonable legal fees and costs, if any, arising out of any claim, demand, suit or judgment by reason of negligence or other act resulting in injury to a person or damage to property providing the indemnified person was acting within the scope of his office or employment, as provided in RSA Chapter 31:104, 105, 106.

Voted in the affirmative and it was so declared.

#### ARTICLE XI

The following resolution was offered and it was moved and seconded that it be adopted.

It was voted in the affirmative and it was so declared by the Moderator.

#### ARTICLE XIII

It was then voted in the affirmative on the resolution and it was so declared by the Moderator.

The following motion was made and seconded that the Town of Plainfield designate Grantham Mountain Road from Route 120 to that portion of the road closed subject to gates and bars, as a scenic road as provided in RSA 253:17.

After discussion the question was moved and seconded and it was voted in the affirmative.

It was then voted in the affirmative on the motion to designate Grantham Mountain Road a scenic road and it was so declared by the Moderator.

#### **ARTICLE XVII**

#### **ARTICLE XVIII**

A rising vote of thanks was extended to David R. Stone for his unfailing good humor, insight, and his devotion to duty during his terms of office as Selectman of Plainfield.

After Article XVIII had been discussed, one voter of the Town of Plainfield, having voted with the majority on Article XII, made a motion that the meeting reconsider Article XII. The motion was duly seconded and it was voted in the affirmative that Article XII be re-opened.

Resolved: That the Selectmen be authorized and instructed to dismantle the iron bridge over Blow-Me-Down Brook at Mill Village and to sell all salvageable material from said bridge at the highest obtainable price for the town, and to take any other necessary action relating thereto.

It was voted in the affirmative and it was so declared by the Moderator.

There being no further business it was moved and seconded that the meeting be adjourned.

### Selectmen's Report

The selectmen recorded a successful year of administering the town's affairs. The board welcomed Paul Franklin to its membership to replace the retiring David Stone, who had served ably for some nine years.

The Highway Dept. enjoyed a productive year, with considerable amounts of improvement and betterment work being accomplished. High Street and Old County Road were improved under state aid projects and several sections of town road were gravelled and their drainage improved. The town took delivery on a new diesel powered dump-plow truck to replace a 1969 unit. The majority of town equipment is now diesel powered with resultant savings in fuel and repairs.

After many months of negotiations the selectmen decided to finally settle with the federal government on claims for damage assistance from the 1973 floods. It was decided to accept the government's final offer rather than litigate with the uncertainties of costs and outcome that would have entailed. Thus the town absorbed some \$40,000 which will have to be worked off through the overlay account in the coming years.

In addition to the flood money setback, the town also lost the Blue Mountain Forest tax suit in the state Supreme Court, forcing the town to pay back some \$13,000 in taxes to Blue Mountain and to grant a large reduction in the appraised value of the Blue Mountain property.

Balanced against these setbacks were modest increases in our town's grand list, all of which serve to ease the rising burden of taxation to support town services, the schools and the county government.

Members of the board of selectmen held 52 regular meetings during the year, made more than 20 trips to Concord and Newport on town business, participated individually in over 100 meetings connected with town affairs and handled Heaven knows how many telephone calls and individual inquiries. Regular meetings are becoming longer and longer as the workload of tending to the town's affairs grows. Meanwhile many other citizens contribute their time and effort to make Plainfield's local government go.

Looking ahead to 1978, the selectmen hope to continue to explore ways to make things run better and to save taxpayers money. The door is always open to ideas and suggestions, and the selectmen hope citizens will come forward when they have them.

The selectmen wish to thank all who helped them in the conduct of town affairs in 1977.

Here are several new laws that will have a direct affect on many of us.

\*\*\*\*\* State law now requires absentee ballots be available for local elections. Ballots must be picked up in person from the town clerk or be mailed directly by the town clerk no later than 11 a.m. of the day before the election and returned no later than 5 p.m. of the day before the election.

\*\*\*\*\* A revised state law, RSA 466:31, relates to controlling dogs that are a nuisance (including such things as barking; scattering garbage or digging on property other than the owner and allowing a female dog in heat to run at large), a menace (a dog chasing a person or any vehicle), or vicious (a dog biting or attacking a person or any wild or domestic animal).

Any person who considers a dog to be a nuisance, a menace, or vicious may make a complaint in writing to any law enforcement officer in the town. After investigation and substantiation of the complaint, the law enforcement officer shall order the owner of the dog to abate the nuisance or menace and fine the owner \$10.00 for a nuisance offense, \$15.00 for a

menace offense, and \$25.00 for a vicious offense. The owner may pay the fine to the town clerk or, WITHIN TEN DAYS PETITION THE DISTRICT COURT TO REVIEW THE COMPLAINT.

For more information contact the Chief of Police or the Dog Officer.

\*\*\*\*\* The penalty for changing the use of land enrolled in the current use program to a non-qualifying use is now due at the time of the change of use. Previously, it was due the following April 1st. Also, it is the person who changes the use of the land that is responsible for the penalty, not necessarily the one who sells the land.

\*\*\*\*\* There is now a penalty for any person who fails to file a completed property inventory form by April 15th. The penalty is 1% of the property tax, but in no case less than \$10.00 nor more than \$50.00.

\*\*\*\*\* According to revised regulations of the N.H. Air Pollution Control Agency, no commercial burning of brush, slash, tree cuttings, not over five (5) inches in diameter is allowed without written permission from the Agency. To receive this permission, one would have to show that there is no other suitable method, such as chipping, that can be used.

Residential burning of brush and tree cuttings not over five (5) inches in diameter on an occasional basis is allowed by an individual landowner from material generated by the owner. On premises burning for agricultural and forestry improvement is also allowed. Please note: you still must have a fire permit to burn on your own land, if there is no snow cover.

### Report of the Finance Committee

The Finance Committee met with the Selectmen to review expenditures and policies concerning town finances in May, July, and November; and with the School Board in August and December. Another meeting is currently scheduled with the School Board late in January.

In cooperation with the Selectmen and School Board the Committee prepared, distributed and tabulated the results of a questionnaire intended as a directional aide for Town and School officials in preparing budgets for 1978. The questionnaire was prompted by the vote at Town Meeting in March, 1977 to reduce town services with resultant lower taxes, effective 1978. The detailed results of the questionnaire were delivered to the Selectmen in November, the School Board in December, and a summary was published in the news media. Anyone interested in reviewing the tabulated results or the 34 pages of comments can contact the Selectmen, the School Board, or the Finance Committee.

Since this report must be filed with the Selectmen before the Finance Committee has seen the final proposed town and school budgets for 1978, we are not in a position to comment on them.

### Report of the Planning Board — 1977

The Planning Board had another busy and productive year. The Board met regularly on the third Monday of the month at 7:00 p.m. in the Plainfield School. In addition, eight special meetings were held throughout the year. Public hearings for one or more subdivisions were held on nine of these occasions as well as the final hearing for the Zoning Ordinance changes and an open meeting to accept petitions. A total of 6 major subdivisions and 12 minor subdivisions were passed, creating a total of 39 new lots in the Town of Plainfield. The Board made recommendations to the Zoning Board of Adjustment on 12 requests for special exceptions and one variance. Board members also made site reviews of 2 proposed major subdivisions in the company of the Road Agent.

Aside from the routine business of the Board throughout the year, there were several significant hurdles crossed as well. The first meeting for the Board in 1977 was the last of the series of meetings and hearings about a group of proposed changes in the Zoning Ordinance. These proposals were later voted on and accepted at the Town Meeting in March. Another major event in the year was the review of the Land Vest vs Plainfield case by the State Supreme Court. The resulting decision should help Planning Boards throughout the State to better understand the legal powers granted to them in the Statutes, as well as clarifying the situation at hand. A great deal of time has been spent in meetings toward the end of the year reviewing the Subdivision Regulations, as a new supply of booklets will soon have to be printed. This work will continue into the new year.

Last year's report included an invitation to anyone contemplating a subdivision to come for an informal discussion of their proposal prior to making a formal application. We are pleased to say that many people are doing this, and we believe it has been to the benefit of all concerned. We would like to further extend the invitation this year to anyone questioning what should or should not be considered a subdivision. Any property owner in town contemplating the development, sale, or transfer of property is invited to come in and determine whether or not their plans should include subdivision approval. It is our belief that better communication between the Town's people and the Planning Board that serves them will benefit us all.

The Board wishes to extend special thanks to Mr. Floyd Avery of New London and Road Agent Tom Bircher for their time and expertise in the review of road related questions. Thanks are also due Edward G. Martin and Stephen H. Taylor who left the Board this past year. We welcomed Mary W. Cassidy and Paul B. Franklin in their places and look forward to their continued help in the future.

## Facts about the Plainfield Fire Departments

While taking inventory of our town's fire protection equipment and capabilities we decided that this information would be of interest to the people we protect.

The Plainfield Fire Department's stations were built, owned by the members and are located one on each side of town. We have similar equipment and are dispatched by the Lebanon Fire Department to answer all fire calls and other emergencies. The dispatching is done with radio operated sirens, home monitors and our new mobile scanning units are in constant contact with the Claremont, Cornish, Lebanon, Hanover and other upper valley fire departments.

Meriden Engine 2 purchased new in 1964 at a cost of just over \$16,000 is our newest pumper. This 750 gallon per minute pumper with a 500 gallon tank and now carries an approximate \$55,000 replacement cost. The other three engines were purchased used from larger departments and both tankers have been put on used but newer adequate chasis by each department. The department responds to all fires with a total pumping capacity of 2,500 gallons per minute and carries 6,800 gallons in the tanks. In addition we have an automatic mutual aid agreement with Cornish Fire Department and they respond with fire equipment and the Cornish Rescue Squad. To protect each fireman with a helmet, coat and boots now costs approximately \$145.00 per man. Some of the protective gear now used has been purchased by the firemen themselves or from donations.

Operating expenses include fuel for both stations and equipment, lights, telephone, insurance and maintenance. Our firefighters are all volunteer and what money earned fighting forest fires is turned back to the departments.

All the engines and most of the equipment have been purchased by the Fire Department. We would estimate the replacement cost of our equipment at current prices to be:

- (4) Engines at \$55,000 = \$220,000
- (2) Tankers at \$20,000 = \$40,000
- (2) Stations at \$35,000 = \$70,000
- (6) Mobile Radios at \$1,200 = \$7,200
- (26) Home Monitors at \$125 = \$3,250
- (40) Sets of Protective Clothing at \$145 = \$5,800

Total replacement cost 1977 values would be \$326,200.00.

### Report of District Fire Chief and Town Forest Fire Warden

Forest fire control in New Hampshire is a joint state and town/city responsibility (RSA 224).

The Director, Division of Forests and Lands (State Forester) appoints a forest fire warden and several deputy forest fire wardens in each town/city upon the recommendation of local authorities.

The local forest fire warden is responsible for forest fire prevention and suppression activities in his town. He regulates the kindling of outside fires when the ground is not covered with snow by the issuance of written permits only when conditions are safe. He is responsible for suppression with the town/city and state sharing the cost. Suppression costs in excess of ¼ of 1% of the assessed valuation of the town are assumed by the state.

The state provides training for the local fire organization and helps coordinate activities between towns/cities. The state also supports local forces with backup personnel, equipment, and supplies for suppression and prevention.

This combination of state and local cooperation, started in 1893, works well, for New Hampshire has enjoyed one of the smallest acreage losses due to forest fires in the United States for the past 25 years.

## Annual Report of Representative to the N.H. General Court — 1977

Is truth stranger than fiction? If you had been in my shoes during the last session (s counting the "special" ones) you might have thought so. It was impossible for the average legislator to keep track of just where we were. The conference committee on the operating budget just couldn't agree and the state went from July until October without one. We were called in periodically to see what was going on, and most of the time it was a deadlock between the Senate and the House—with the Governor apparently trying to manipulate the two.

In addition to that mess, the Governor vetoed the capital budget, and to this day the state of New Hampshire cannot make repairs nor build any new buildings. When this happened in the Governor's first term, we discovered that when a capital budget was finally passed, the state had to spend thousands of extra dollars due to galloping inflation. I call this unfortunate, but I do agree that certain items in this budget are not needed, but merely a pet project of someone's. There is no telling when we shall be able to pass a capital budget, once again due to the deadlock between the Senate and the House and the Governor.

I serve as vice-chairman of the Executive Departments and Administration committee this term—we handle all the bills which deal with the state agencies in any way: A very busy session for us. We are studying the corrections system in N.H. as well as the crime commission and the reorganization of the Dept. of Mental Health, to name a few of the kinds of bills we get.

With much help from the senior citizens across this state we managed to secure a good hearing-aid bill. This was my "baby," and I had worked for two years on it. We found fraud and sharp practices among certain dealers, and felt the need to protect the elderly, especially, by outlawing door-to-door or phone sales, providing for a 30-day money back guarantee, an

itemized receipt and other things. The dealers fought this, and we got the bill through both houses and even overrode the Governor's veto (no small task—unanimous in the Senate) we felt pretty gratified.

Unfortunately the ethics bill, having passed the House, died in the Senate, but this is the first time it even got through the House—progress! I do not give up.

It has been a good feeling to have many of you calling on me to help you with bureaucratic problems or to give you what information I can on some subjects. If I do not know the answer, I DO know where to find it.

The overall box score: 1191 House bills introduced, 370 in the Senate. 272 bills became law, and 208 are in study. The subject matter of bills becomes increasingly complicated, and often the heaviest bills seem to come in late in the session when there just is not time to do them justice, so they are sent to study. Our committee alone has over 25 bills to work on between sessions.

As in any line of endeavor, you win some and you lose some. When you are trying to get good laws for your state and its people, and you win, that is when politics is truly rewarding. And when you lose, you try again. The key to success is sustained effort.

Thank you for having once again elected me as your Representative.

### Report of the **Plainfield Conservation Commission**

One of our major concerns is to try to preserve some areas of the Town in their natural state. To this end, the Commission has been studying conservation agreements with the aid of the Society for the Protection of New Hampshire Forests. The Commission has discussed conservation agreements with several landowners and will gladly furnish information about them upon request.

The Commission assisted conservation education in several ways. Two town students Janice Chapman and Mark Wilder were awarded scholarships to the Youth Conservation Camp. One of our members taught conservation in the school and we now have a bulletin board in the hall devoted entirely to Conservation items. A Conservation Newsletter will appear in the near future.

The Commission sponsored its first Annual Clean-Up Day. It was a successful start of an event we hope to continue to assist in keeping our Town clean and attractive to our residents and visitors.

The Commission members, after hiking over the area, have outlined and marked the Town Conservation Land on Columbus-Jordan Road. A map and a registration book are now set up at the entrance for the convenience of anyone who wishes to hike through the area. The Commission is most interested in hearing from Town residents on any suggestions they might have on how to make best use of this land.

We held a joint meeting with the Cornish Conservation Commission as our guests. It was a most worthwhile meeting as we discussed mutual challenges and how we might work cooperatively in some of these areas. We will be guests at one of their meetings this year.

The Commission is planning to replace the tree that was cut down in front of the Plainfield Library. This will be handled in the spring.

The Commission assisted a landowner in interpreting and getting the answers about building codes and health regulations in regard to his property lines.

We continue to review dredge and fill applications and make recommendations when necessary.

The chairman served as a panel member for a Dartmouth-Lake Sunapee Region Association meeting held in Cornish.

Our town map is available from the Town Office and from Commission members.

### Report of the Meriden Library Trustees

There has been a wealth of activity this year at the library. In the year ending December 1976, circulation figures almost matched the number of volumes in the library. Approximately 6,500 books went out this year. The bookmobile came four times. We exchanged selected books several times with the Plainfield library. Many patrons are taking advantage of the inter-library loan system through the State library. Over 100 books were requested through this system.

Programs for the children of Meriden and Plainfield were successful this year. There were ten story hours conducted from April to December: six for pre-schoolers, and four for school-aged children. There were ten film programs after school and the nine kindergarten film sessions.

The Corn Roast in August was grand success and the first meeting this fall was well attended.

The Display case held many interesting exhibits this year including old KUA and Meriden Photos, Doug Beaupre's Baseball cards, Hats from the Bryant Estate by Bobbie Ellison and Donna Beaupre, Shells from the Feichtinger's trip to the West Indies, Projects made by the 4-H Dandee Kandies, a Bird Club exhibit, Avon Bottles by Marcia Swett, old postcards and greeting cards belonging to Kay Jones and Sue Timmon's Santa Claus collection.

We obtained the excellent services of Barbara Outridge as assistant librarian in May.

This year saw the retirement of John F. McNamara as Treasurer of the Meriden Library Association. His 40 years of service and devotion to the welfare of the library will always be admired and greatly appreciated. We all express our sincere thanks.

### **Report of Nursing Services**

The City of Lebanon Public Health Nursing Service provided the Town of Plainfield with 292 nursing visits and 69 physical therapy visits to 136 individuals.

### **COST OF SERVICE**

The contract for this year has been written on a cost per visit charge rather than on a set number of hours per week. We pay Lebanon their cost for each visit to us. We are credited with the payments they receive on behalf of our patients from insurance companies, medicare, medicaid and direct patient fees. In cases not covered by the above, the Town of Plainfield underwrites the cost of the visit.

### Plainfield Village Water District 1977 Annual Report of Commissioners

During the past year the District engineers completed study for a 100,000 gallon reservoir. The District has prepared option agreements with the land owner. Arrangements for funding the construction of the reservoir and pipeline are in process. The total cost of the project is expected to be in the \$150,000 range. Application for grants are being made to several Government agencies and it is hoped the construction could start in 1980.

The benefits of construction of this reservoir are numerous. One being a 20% reduction of fire insurance to residential subscribers. Another is a one week reserve supply of a gravity water system.

The location of the reservoir was chosen with future expansion in mind. Service to the Mill Village area and the Stage Road area would be possible.

A new item that appears in this year's budget is the testing of water samples, which in the past was done by the state free of charge.

The construction of the infiltration galley and the conservative use of water by our subscribes has allowed us to get through this year with no water outages, which proves that conservation works for the benefit of all. As Commissioners, we wish to thank you all for your efforts.

Motion was seconded by Hazel Amidon and it was passed in the affirmative.

Article 3. To fix District officers salaries to be paid for the ensuing years and to establish expenditures for 1977, by and for the District, to be paid by the Treasurer upon authorization by the Commissioners. Paul Roeber offered the following resolution and moved the adoption of the proposed budget for 1977 as printed on Page 76 of the Plainfield Town Report for 1976 with the following exceptions: 1 - Operating Expenses, Maint. wages \$600; 2 - Operating Expenses, Maint. Suppl., etc. \$600; 3 - Operating Expenses, Clerical wages, \$350; 4 - Operating Expenses Totals, \$3,587. 5 - Net operating gains \$66, 763.; 6 - Other disbursements, Capital Expend., Auxiliary pump system, \$500; 7 - Other Disbursement Totals - \$5,963; 8 - Net other (decrease) (\$5,663.) 9 - Cash Increase, \$1,100. All payments to be made by Treasurer upon authorizations by the Commissioners. The motion was seconded by Wayne Wheeler and passed in the affirmative.

Article 4. To see what action the District will take with regard to reports of the District officers. George Adams offered the following resolution and moved its adoption: That the District accept the reports of the District officers as printed in the Plainfield Town Report for 1976. The motion was seconded by Hazel Amidon and the motion passed in the affirmative.

Article 5. To see if the District will authorize the Commissioners to utilize an amount, not to exceed four thousand dollars, from the Capital Reserve a/c, for all or part thereof of an engineering investigation and study of the feasibility of constructing distribution storage together with long-range development of the water supply and distribution system, compiled in an engineering report, and including periodic engineering consultations with the Board of Commissioners.

Article 6. To see if the District will authorize the transfer of \$1,500 from current operating funds to the Capital Reserve as subsequent to July 31, 1976. Wayne Wheeler offered the following resolution and moved its adoption. That the District authorize the transfer of \$1,500 from the current operating income to the Capital Reserve account.

Paul C. Roeber offered the following resolution and moved for its adoption: That the District authorize the Commissioners to utilize an amount, not to exceed four thousand dollars, from the Capital Reserve a/c, for all or part thereof, of an engineering investigation and study of the feasibility of constructing distribution storage together with the long-range development of the water supply and distribution system, compiled in an engineering report, and including periodic engineering consultations with the Board of Commissioners. The resolution was seconded by Paul Amidon and the motion passed in the affirmative. A motion was made and seconded that we return to Article 1; the vote was in the affirmative.

Article 1. To choose necessary District officers for the ensuing year or otherwise as the law directs:

- 1. a Moderator for one year
- 2. a clerk for one year
- 3. a treasurer for one year
- 4. a commissioner for three years
- 5. other officers and agents the voters judge necessary for managing District affairs, or as directed by law to be chosen.

Moderator for one year: Motion was made by Gertrude R. West and seconded by Beulah Pickering that the clerk cast one ballot for William A. Smith for moderator. The ballot was cast and said clerk declared William A. Smith elected.

Clerk for one year: Motion was made by Hazel Amidon that the clerk cast one vote for Gertrude R. West for clerk. The ballot was cast and said clerk declared Gertrude R. West elected.

Treasurer for one year: Motion was made by Paul Roeber and seconded by Paul Amidon that the clerk cast one ballot for Elaine Wheeler for treasurer. Gertrude West, clerk, cast one ballot and Elaine Wheeler was declared elected. Commissioner for three years: Motion was made by Paul Amidon and seconded by Hazel Amidon that the clerk cast one ballot for George Adams, for Commissioner for three years. Gertrude West, clerk, cast one ballot and declared him so elected.

Other officers and agents the voters judge necessary for managing District affairs or as directed by law to be chosen. Paul Amidon offered the following resolution and moved its adoption. That the Commissioners be authorized to request and to pay for the services of the Auditors of the Town of Plainfield, N.H. or of a professional firm, for necessary audits, and further that the Commissioners be authorized to hire, to direct the activities of, to establish rates of pay of, to approve payments of earned wages to, and to discharge or replace, when necessary, such personnel, other than officers in their official functions, as the Commissioners may deem necessary. The motion was seconded by Paul Roeber and passed in the affirmative.

Article 7. To enact any other District business that may legally come before the meeting.

Wallace Pickering proposed a vote of thanks to Paul Amidon for his devotion of duty to the Plainfield Village Water District.

It was discussed that Vera and Donald MacLeay, who have been donating services of their duplicating machine, be reimbursed for said services. Paul Amidon offered to speak to the MacLeay's regarding such reimbursement, and authorization for such payment be given to Clerk, by submitting such bill to Treasurer.

### Report of Commissioners Meriden Village Water District

The Meriden Village Water District provided good service to its customers this past year, particularly since the major leaks which plagued us last winter have been repaired. There is still at least one suspected minor leak on a customer line. Since August, when most leaks had been repaired, daily water usage fluctuated between 30,000 to 58,000 gallons per day, with an

average usage of about 45,000 gallons per day. Maintenance costs were higher than expected this year due to the repair of leaks and the repair of one pump. Hopefully, the maintenance will be lower next year, but with the extent of old lines in our system, costs may continue to be high.

The sewer system engineering study has recently been completed and approved by the State of New Hampshire Water Supply and Pollution Control Commission and the Federal Environmental Protection Agency. Dufresne-Henry Engineering Corporation performed the study which is the first phase of a proposed three-step project. A request for approval to begin the detailed design phase will be voted on at the annual meeting in March.

#### Plainfield School District Report of the Superintendent of Schools

Instructional Programs: Under the leadership of Stephen Beaupre, principal, the staff has made substantial progress in developing and implementing a language skills curriculum that will ensure that each student develops, consistent with his ability, the basic skills of reading, writing, speaking, and listening. In the area of enrichment programs, the Plainfield School has been fortunate in participating in two regional programs which are funded by federal grants. The "Maximizing Talent" program is organized to train teachers and volunteers to provide enrichment activities for students with special talents, interests, and abilities. Through this program, small groups of Plainfield students have worked with interested adults in intensive study of topics of special interest. The "Artists in Schools" program has brought cultural activities and performing artists into the Plainfield School to give the students first-hand experience with producing and performing arts.

In summarizing instructional programs at the Plainfield School, it is meaningful to look at the end product of our programs: our graduates. Plainfield students continue to be recognized at both Lebanon High School and Kimball Union Academy as knowledgeable and well-prepared. Our local students are both "achievers" and "participants". It is particularly satisfying to attend athletic events, plays, and honor society inductions and note the involvement of Plainfield students.

School Board Activities: The past year has been productive for the Plainfield School Board. Communication with you, the community, has increased by distributing School Board Minutes through the Plainfield Store and Meriden Store. Regular meetings with the Town Finance Committee have resulted in a useful exchange of points-of-view and a sharing of the "real" problems which face us in our dual role as educators and taxpayers. On behalf of the school staff and administration, I would like to thank Sandy Stettenheim for her service to the children of Plainfield. Sandy has approached her duties as a school board member with great dedication.

Warrant and Proposed Budget: The Warrant for the 1978 Annual School District Meeting contains one article requesting \$5,000 to contract to have the exterior of the school restained and repainted. In order to protect our investment in the building, this type of preventive maintenance will be necessary periodically. If approved at the School District Meeting, the work will be bid out for completion by late summer.

The major increase in the proposed budget is the result of graduating the largest eighth grade class in Plainfield's history. Next year we will have seventeen additional students in high school. Other increases represent cost-of-living increases for all personnel and an increase in consulting services in order to comply with federal requirements for diagnosing the problems of handicapped children.

In Memory of Mrs. Ruth L. Rogers: The Plainfield School District will miss Ruth Rogers. Her careful attention to details and her interest in both school district and town affairs made her an important part of our community. On behalf of the School Board, staff and administration, I would like to extend to Ruth's family our deepest sympathy.

## Plainfield School District Principal's Report

There have been some changes on the Plainfield School staff this year. Robert Brewster, who taught grades 1 & 2 and Camille Frankel, English teacher for grades 7 & 8, have left this area to pursue other interests. Marion Stone, a 6th grade teacher, retired.

Four new teachers joined the staff this year; Carol Wood, grade 6, Julie Perkins, grade 6, June Donnelly, grades 3 & 4, and Albert Pothier, an English teacher for grades 7 & 8.

Some of the past and present years' accomplishments are:

- The completion of a language arts manual for grades 1-5 to be used as a guide for teachers in facilitating a sequential and comprehensive curriculum for students.
- 2. The federally funded Maximum Talent program, which was started last year, has been expanded. More students have been selected to work with an instructor to increase their knowledge of a chosen subject.
- 3. We have been chosen as one of seven Upper Valley schools to participate in a federally funded Artists-In-Residence program. The artists' come to the school to work with teachers and students, providing instruction in music, art, dance, and drama.

Although items appearing in the budget this year are much the same as last year, inflation has forced costs up regardless of our constant efforts to keep expenses down.

The largest increase in the budget this year is for outgoing transfers which is the result of an anticipated 23 more students attending Lebanon High School.

Staff salaries for next year have been increased approximately 7 percent, based on cost-of-living increases and not on an additional year of teaching experience.

More money will be spent next year on testing and mental health services. The New Hampshire State Board of Education plans to require each district to report individual student achievement minimum competences in mathematics, reading, and language. Federal law P.L. 94-142 will require periodical tests for all handicapped children between the ages of 3-21. Qualified people will be hired to administer these tests.

## Plainfield School District Report of the School Nurse

This past spring we did an extensive pre-school screening which enabled the first grade teachers to prepare lesson plans for the different maturity levels of incoming first graders. Parents were very cooperative which the staff appreciated.

At this moment we are attempting to assess the immunization needs of the children in grades 6-8. The state law on immunization requirements has been in effect since 1972 and pupils beginning school after that date have on the whole, good completed immunization.

Your school nurse spoke with pupils in these upper grades explaining the importance of the required immunization and sent home a history sheet for parents to fill out. My thanks to the cooperating parents and my request for other parents to comply.

Routine physicals assessments are being done on each child and parents promptly notified of any effects. Health Education classes continue in dental care, nutrition, growth, and development. A health career day was held in the spring in conjunction with a tour of Alice Peck Day Hospital for 8th graders. Plans this year are being made for a First Aid Course for 7th graders. The aim of the school health department is on education and prevention, with the hope that this knowledge is carried over through-out life.
