TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Bradford, in the County of Merrimack, in said State, qualified to vote in Town Affairs:

(L. S.)

You are hereby notified to meet at Town Hall in said Bradford on Tuesday, the fourteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

The raising of money and other articles in the warrant will be taken up at 1:00 o'clock P. M.

3. To see if the Town will vote to accept State Aid for new construction, and if so to raise and appropriate the sum of \$1,081.50 for same.

4. To see if the Town will vote to raise and appropriate money for painting the outside, and repairing the ceiling on the inside of the Town Hall.

5. To see what action the Town will take in regard to carrying insurance on the firemen, and raise and appropriate for same.

6. To see if the Town will vote to authorize the Selectmen to hire money for current bills, in anticipation of taxes.

7. To see if the Town will vote to have the Road Agent take over the duties of office at the time of election instead of April 1st.

8. To see if the Town will vote to allow the holding of boxing bouts, subject to the rules of the State Boxing Commission.

9. To hear the reports of Agents, Auditors, Committees, and Officers heretofore chosen, and pass any vote relating thereto.

10. To transact any other business that may legally come before said meeting.

If any school is in session on any of these days, it may close that number of days earlier than scheduled in June. If other days are lost they must be made up. The day for Hopkinton Fair is allowed on condition that at least 50 per cent of the pupils of a school attend the fair on that day.

Teachers' salaries will be paid in ten equal installments: one during the week following the first Saturday of the month.

The regular hours of school are 8:45—12:00 a. m. and 1:00—3:45 p. m.

Pupils in grades I and II may be dismissed 30 minutes earlier than the pupils of the higher grades in the forenoon and in the afternoon. Care must be taken to see that they do not get into mischief during this time.

In all schools teachers are to remain at the school during the noon intermission. Organized plays and games should be planned for the pupils with the cooperation of the pupils.

Teachers are to be in their respective rooms, or on the playgrounds to look after their pupils not less than 20 minutes before school time in the morning. Much trouble will thus be avoided.

The annual medical inspection by Dr. R. F. Oliver was reported as follows:

Number pupils examined, 74; underweight, 15; defective vision, 11; defective hearing, 4; anaemia, 3; defective teeth, 18; diseased tonsils, 11; adenoids, 1; impetigo, several; no. vaccinated, 72; unvaccinated, 2.

We note that there has been an increase of 10.7% in number of cases of defective vision since last year. This is a serious matter and should receive immediate attention from the parents of the pupils affected. The number of cases of defective teeth has decreased 14.5% since last year. This is an excellent record, and we hope that it may be continued through next year. The work done at the regular rates at the dentist's office could be done at a local dental clinic for about half the usual cost, and more pupils benefitted. We recommend this plan to parents who expect to have more dental work done this year.

Seven pupils completed the work of the eighth grade in June. Of these all but two have entered high school.

In conclusion we wish to thank the parents of the pupils, also the school board members for their support and cooperation during the year.
