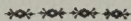

holden at the State House, Room No. 11, Feb. 1, 1893, at 2 o'clock in the afternoon :

1st. The delegation was called to order by Benjamin F. Clark, chairman.

2nd. The Clerk being absent Aldo M. Rumery of Ossipee, was chosen Clerk Protempore.

3rd. Voted to raise the sum of two thousand dollars (\$2000) for the year 1894 for the purpose of putting a system of steam heat into the County Almshouse at Ossipee, and the same or as much thereof as is necessary is appropriated for that purpose.

4th. Voted to raise the sum of twelve hundred dollars (\$1200) for the year 1894 for the purpose of furnishing water supply for the County buildings at Ossipee, and the same be and is appropriated for that purpose.

5th. Voted to raise the sum of twenty thousand dollars (\$20,00) to defray the expenses of the County for the year 1894.

6th. Voted to raise the sum of twenty-three thousand dollars (\$23,000) to defray the expenses of the County for the year 1895.

7th. Voted to adjourn subject to the call of the chairman.

# REPORT.

## COMMISSIONERS' REPORT.

TO THE CITIZENS OF CARROLL COUNTY :

In compliance with the statutes of the State, the commissioners of Carroll County respectfully submit the following report, together with reports of the other county officers :

The time of making the last report, embracing as it did a period of twenty months, was a most favorable one, as it included two summers and but one winter; and at the same time two full years' assessments: hence the showing in this report is less favorable than in the preceding one, although had the water works not been constructed and steam heating not been put into the county house, the total expense of both improvements amounting to \$3748.57, the reduction for the year would have been \$7608.72.

We think the tax-payers are to be congratulated upon the favorable condition of the county's finances.

The county farm and almshouse have been under the careful supervision of Mr. and Mrs. Manson for the past year, and we should be unmindful of the care and economy with which they have discharged their duties did we not mention the fact in this report. So satisfactory have been their labors that they have been engaged to remain another year.

The county convention voted at the last session of Legislature an appropriation of \$2000 for the construction of water works suitable for the county farm and almshouse, and a like amount for putting a system of steam heating into the almshouse. We are pleased to state that the water works constructed seem sufficient for any emergency, and the amount expended therefor was \$1944.37. A system of steam heating has been put into the almshouse at an expense of \$1804.20, making a total for water works and steam heating of \$3748.57, \$251.43 less than the appropriation. The introduction of steam heating adds much to the comfort and safety of both inmates and employees, and also lessens the danger of disease and fire.

The cost of supporting paupers away from the farm has been about the same as for the year 1892; while the aid of indigent soldiers has materially decreased, some having died and others having been placed upon the pension rolls. Our thanks are due the selectmen of the several towns for assistance rendered in caring for the poor away from the farm. No extensive repairs or outlays of any kind seem necessary for some years to come, and but a short time will elapse before the county's indebtedness will be a thing of the past.

These cases have been disposed of as follows : At the April term of court there were three criminal jury trials. One person was sent to State prison, one to the Industrial School, one to jail and one acquitted. A *nolle prosequi* was entered in one case, one continued because accused had fled to parts unknown, two continued by reason of the State's failure to obtain a verdict, the jury being unable to agree (these indictments were against the same person and by agreement submitted together). Fines and costs were paid in some of the liquor cases; the others continued.

At the October term there was one criminal trial. Two persons were sent to State prison, one to the Industrial School, one sentenced to jail, mittimus not to issue unless called for, one continued because accused had fled to parts unknown, and three continued on motion of respondents.

As physician to Carroll County Almhouse I would submit the following report for the year ending Dec. 31, 1893.

During the past year there have been no epidemics or prevailing diseases. Most of the deaths have been among the aged. Since the introduction of steam heat there has been very little sickness, and we see no reason why a large amount of disease due to over-heated and under-heated rooms may not be avoided. It appears that this institution in point of sanitation and personal comfort of its inmates may rank among the first in the State.
