PAMPHLET LAWS OF 1885.

CHAPTER 21.

Section 1. It shall be the duty of the County Commissioners of each county to publish attested copies of the proceedings of the county convention with the printed reports of the county officers for the year in which such proceedings shall have occurred.

Approved, July 29, 1885.

JUNE SESSION, 1883.

Agreeable to the requirements of the General Laws, the representatives of Merrimack County met in the Hall of Representatives on Wednesday, June 14.

The convention was called to order by Samuel C. Eastman. On motion of Charles R. Corning E. B. S. Sanborn was chosen chairman. On motion, Charles R. Corning was chosen clerk, who appeared and took the oath of office as required by law.

Adjourned.

JUNE 21st.

The convention was called to order by the Chairman. W. S. Harrod, one of the Commissioners, offered and submitted an estimate for the year 1884, which was read by the Clerk.

Moved by S. C. Eastman that the subject of estimates be re-

ferred to a committee of three to be appointed by the Chairman.

The Chairman appointed as such Committee, S. C. Eastman, of Concord, Jeremiah E. Smith, of Northfield, and Robert C. Carr, of Andover.

Adjourned.

JULY 23, 1883.

The convention was called to order by the chairman. The committee on estimates, by its chairman, Mr Eastman, reported that the county tax should be \$60,000 for the year 1884, and \$59,000 for the year 1885.

On motion of Mr Eastman, voted the county tax for 1884 be \$60,000, and for 1885 be \$59,000.

On motion of Mr Eastman, of Concord, voted,

Resolved, That the commissioners be authorized to sell and convey that part of the jail lot in Concord west of Fruit street on any terms that they deem proper for the county.

Mr Carr, of Andover, offered an amendment that the words "by auction" be inserted after the word convey. Adopted.

Resolution adopted.

Mr Eastman, of Concord, offered the following resolution :

Resolved, That the County Commissioners are hereby authorized and instructed to provide for the drainage and sewerage of the jail in a manner that shall be safe for the inmates and for the community.

On motion of Mr. Eastman, of Concord,

Voted, That the subject of the above resolution be referred to a committee of three, to examine the condition, the cost of repairs and to report thereon.

The Chairman appointed as such committee, Mr. Cook, of Concord, Mr. Hancock, of Franklin, and Mr. Hayden, of Dunbarton.

Mr. Cook, of Concord, moved that a committee of three be appointed to investigate the affairs of the County and to report to this Convention.

Adopted.

The Chairman appointed as such committee Mr. Hancock, of Franklin, Mr. Carr, of Concord, and Mr. Gerrish, of Webster. On motion of Mr. Gerrish, Mr. Corning, of Concord, was elected County Auditor.

On motion of Mr. Carr, of Concord, Mr. Carr, of Andover, was elected County Auditor.

Approved.

SEPTEMBER 11, 1883.

Meeting called to order by Chairman.

The resignation of Mr. Carr, of Concord, as a member of

the Committee to investigate the affairs of the County, was accepted.

On motion of Mr. Cook, of Concord, Mr Kimball, of Hopkinton, was elected to the vacancy.

On motion a committee of three was elected to confer with the County Commissioners about the water works at the County Farm. Said committee consists of Dr. Cook, of Concord, Mr Carr, of Andover, and Mr. Ellsworth, of Boscawen.

Mr. Cook, from the Committee on the Jail, submitted a report which was accepted on motion of Mr. Carr, of Andover.

Voted, That the County Commissioners be instructed to put in a sewer-pipe as recommended by the Committee.

On motion of Mr. Cook it was voted that the matter of internal improvements at the Jail be left to the County Commissioners.

On motion of Mr. Carr, of Andover. adjourned.

A copy of proceedings of that part of record of County Convention of 1885 relating to instructions and appropriations for the past year.

STATE HOUSE, CONCORD, N. H., August 13, 1885.

The Convention was called to order by the Chairman.

Mr Daniell, from the committee, appointed to investigate the water supply and wood-shed accommodations at the Farm, read the following report, which was accepted :

“The Committee instructed to visit the County Farm and investigate the matter of water supply would report that the present supply is muddy, and otherwise impure and entirely inadequate for sanitary and other uses.

The brook from which the water is taken has been dry nearly a month the present year. In 1883 it was dry five months. At such times water is carried in pails to the top of the house to cleanse the water-closets.

The delegation can understand from this alone that a better supply of water is an imperative necessity.

The Committee suggest that the delegation instruct the County Commissioners to take water from Glines brook, which will afford an abundant supply of excellent water, the amount to be expended for the same not to exceed \$3,000. Also that the Commissioners be permitted to erect a wood-shed of such dimensions as necessity demands, the amount to be expended for the same not to exceed \$600.

On motion of Mr. Peabody it was voted to instruct the County Commissioners to expend a sum not exceeding \$3,000 for the purpose of supplying the County Farm buildings with water from Glines brook, and that the sum of \$3,000 be and the same hereby is appropriated for that purpose.

On motion of Mr. Peabody voted to authorize the County Commissioners to erect a wood-shed at the County Farm at a cost of not exceeding \$600, and that the sum of \$600 be and the same hereby is appropriated for that purpose.

On motion Convention adjourned.

COMMISSIONERS' REPORT.

To the Citizens of Merrimack County:—

We present to you our Annual Report showing the financial condition of the County, as rendered by the County Treasurer, examined and approved by us and the County Auditors for the year ending April 30, 1886. Also reports of proceedings of County Convention, Superintendent of County Farm, Clerk of the Supreme Court, Sheriff, Jailor, Solicitor, Physicians and Chaplain.

MISCELLANEOUS.

The County Convention of 1885 appropriated \$3000 from cash in the treasury, for an aqueduct, to procure a permanent supply of water from Glines brook, so called, for the County Farm.

COUNTY DEBT.

The bonded debt of the County May 1, 1885, was \$81,000. At maturity 5000 of these bonds, with all coupons presented, have been paid and cancelled. As all coupons are not presented for payment before the end of the financial year, interest account may vary from true annual interest.

All other demands presented have been adjusted and paid, consequently \$76,000 practically represents the bonded debt. Deducting \$10,333.53 cash on hand and notes receivable leaves the liability of the County \$65,666.47.

FARM.

We are able to report a decrease of cash paid on Farm account to the amount of \$1994.69, although there has been an increase of number of weeks board, also increase of inventory. \$328.02.

A 4-inch cement pipe, two new hydrants with proper gates and connections, was ready for use in October with a full supply of excellent water from a source that has never failed in the memory of anyone acquainted with it. Cost, including \$100 paid Mrs. Sarah Glines for land damage and diverting water from its natural course, building a stone dam, laid in cement, including all labor paid and material purchased, \$2363.75.

The Farm is entitled to credit for work of team on dam and digging reservoir, removing stone in the ditch, not included in the agreement with the contractor.

To orders drawn on farm account should be added \$1200 for wood burned, which was inventoried May 1, 1885, making the total expense for Farm \$11,693.71. From this sum should be deducted \$1024.09 received from sales at the Farm by Superintendent and paid to the Treasurer; also \$5 over-drawn to pay help, leaving \$10,610.62 as net expense for Farm.

Number of weeks board 5271 2-7, making cost per week \$2.01.

The outside wood finish on the brick building, white house, and the stables have been painted, also dining and hall floors. Doors and standing woodwork varnished. All other needed repairs attended to, keeping all in good order.

Two terms of profitable school have been taught by Emma C. Randall. At present children are attending the town school.

Rev. G. W. Richardson, in his earnest but gentle winning way, preaches every Sabbath to attentive and interested listeners.

Dr. J. W. Staples has the confidence of those who receive medical treatment.

The Commissioners take this opportunity to express their thanks to the Superintendent and Matron and their corps of assistants which are at the Farm for their faithful discharge of duties.

The only fatal case of acute disease was from malignant pustule. The absolute freedom from any infectious or contagious disease among the inmates of the Farm speaks well for the cleanliness and good sanitary condition of the premises.

Consumption was the cause of death in the case of Mrs. Sleeper.

From personal observation, and from the testimony of the sick, I am confident that the nursing and general care of the sick have been faithful and efficient. The abundant supply of water furnished the buildings by you, during the year, was needed on the part of good sanitation.

PHYSICIAN'S REPORT.

CONCORD, N. H., MAY 15, 1886.

During the year there has been about the usual amount of sickness in the jail, but nothing of an alarming character. Colds, sore throats, and diseases occasioned by close confinement, have been the chief ailments prescribed for. No deaths have occurred, the nearest approach to it being a case of poisoning from corrosive sublimate, the victim taking the poison by mistake, at the solicitation of a fellow-prisoner.

The sanitary condition of the jail has been excellent in every respect, the food wholesome and abundant, and the care of the prisoners all that could be desired, the Commissioners and the Jailor exercising an intelligent supervision, wise discipline and humane care over the unfortunate men under their charge.

To these officials I am under many obligations for courtesies which I desire to acknowledge.

REPORT OF THE SOLICITOR.

During the past year there has been found by the Grand Jury forty-three indictments for the following offences :

Aggravated assault,	3

These cases have been disposed of on pleas acknowledging guilt, except as follows :

The respondents in four of the cases have been out of the State and their location is unknown. One of them being out on bail, his recognizance has been forfeited and the bondsmen defaulted. One respondent was sent to the insane asylum, after an examination by physicians. One indictment was *not pros'd*, from mistake as to locality of offense by the party pro-

curing the indictment. One has been dismissed because evidence was insufficient to convict.

Two are now on the docket to be disposed of. The indictments for breaking and entering, with intent to steal, and assault with intent to kill, were tried by the jury, and both the respondents were convicted.

During the year there have been ten appeals entered in the Supreme Court. In three of these the respondent has paid the fine imposed by the Police Court, and some of the remaining cases will be disposed of during the present session of Court.

The only civil case in which the County has been interested the past year is a suit brought by Merrimack County, against Grafton County, to recover for supplies furnished John Carter, jr. The case involved the construction of sec. 15, chap. 84, General Laws, and was decided in favor of Merrimack County at the March Law Term, 1886. Judgment in favor of Merrimack County, for the amount claimed, will be entered as of the April Term of Court, now in session.
