 - k. Street Lighting
 - l. Libraries
 - m. Town Poor and Old Age Assistance
 - n. Advertising
 - o. Memorial Day and other Celebrations
 - p. Cemeteries
 - q. Payment on Temporary Loans
 - r. Payment on Time Loans

- s. Interest on Loans
- 3. To see if the Town will raise and appropriate money for Civilian Defense.
- 4. To see if the Town will authorize the Selectmen to borrow money by temporary loans in anticipation of taxes.
- 5. To see if the Town will authorize the Board of Selectmen to administer or dispose of any real estate acquired by the town through tax collector's deeds, or otherwise.
- 6. To raise and appropriate to the White Mountains Region Association, for its program of advertising, etc., as a part of the cooperative investment by regional towns, an amount equal to 10c per \$1000 of the assessed valuation for 1943.
- 7. To transact any other business that may lawfully come before this meeting.
