Town Meeting Warrant

The State of New Hampshire

To the inhabitants of the Town of Benton qualified to vote in Town affairs:

You are hereby notified to meet at the Benton Community Building in said Benton on the second Tuesday of March next (March 12th) at ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose a Town Clerk, one Selectman for three years, Charles H. Tyler being the outgoing member, one Highway Agent, one Tax Collector, one Town Treasurer, one Auditor, one Trustee of the Trust Funds for three years, and all other necessary Town Officers and Agents for the ensuing year.

Article 2. To hear the Reports of Officers and Agents heretofore chosen and pass any vote relating thereto.

Article 3. To see how much money the Town will vote to raise and appropriate for Town Officers' salaries and expenses, for the repair and maintenance and construction of highways and bridges, for the observance of Memorial Day, and for all other Town charges and expenses for the ensuing year.

Article 4. To see what action the Town will take in regards to how Memorial Day will be observed.

Article 5. To see what action the Town will take to authorize the Selectmen to borrow money in anticipation of taxes.

Article 6. To see if the Town will vote to continue to rent a snow plow.

Article 7. To see if the Town will vote to buy an adding machine and to raise money for the same if voted in favor.

Article 8. To transact any other business that may legally come before said meeting.

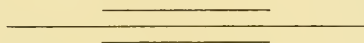

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Benton:

I hereby present my third annual report as superintendent of schools.

The total enrollment of the school in 1944-1945 was 15; the average membership 13.30; the percentage of attendance 95.72; the number of tardinesses were 2. There was one pupil attending the Haverhill Academy; there were 4 elementary pupils at Pike School and 6 at Glencliff.

This year the total enrollment is 11. There is 1 pupil attending Haverhill Academy and 3 pupils attending the elementary schools outside of the district.

Mrs. Katie Page, of Groton, Vermont, is completing her third year of teaching at Benton. Her work is successful, and I suggest that you retain her for the coming year. Outstanding work at the Benton School is an extensive reading program, craft work, and club work for the children. The blackboard borders and other types of art are in excellent taste.

The school building was painted this summer, a woodshed was built and tile floors were laid in the hall and kitchen. The community is to be commended on its interest in maintaining a modern and well-equipped school.

The School Board hopes to make an addition, this spring, in the way of playground equipment.

The janitor service at the Benton School is very good. The teacher reports the building warm and comfortable at all times. When I visit, it is always neat and clean.

The aim of the School Board, Superintendent, and teacher is to work with the community for a better school. We feel that our work this year has been successful.
