To the Inhabitants of the Town of Newington qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said town on Tuesday, the ninth day of March, next, at twelve of the clock, noon, to act upon the following subjects:

1. To choose, in the manner provided by law, a town clerk; one selectman, to hold office for three years; assessors of taxes; overseers of the poor; a town treasurer; a collector of taxes; a superintendent of burying ground; anditors; highway agents; a library trustee, to hold office for three years; a trustee of town trust funds, to hold office for three years.

2. To choose measurers of wood; surveyors of lumber; fence viewers; a pound keeper; constables, police officers and all other necessary town officers.

3. To hear the report of the budget committee, and to act thereon.

4. To see what sum of money the town will vote to raise and appropriate for all town expenditures for the year ensuing (as included in the budget).

5. To see what disposition the town will vote to make of the town land and buildings.

6. To see if the town will vote to authorize the selectmen to administer, or to dispose of, any real estate acquired, or to be acquired, by the town through tax collectors' deeds.

7. To see if the town will vote to authorize the selectmen to hire money on the credit of the town, in anticipation of taxes; and to fix the rate of interest.

8. To take the sense of the qualified voters upon the following question, to-wit: Is it expedient to revise the constitution?

9. To transact such other business as, legally, may come before the meeting.

The state statistics show that among libraries of our size and standing, Langdon Library has a splendid record of circulation per capita. Much credit for this record is due to our competent Mrs. Greenough.

Patrons of the library will note the marked improvement the renovating of the ceiling, walls, and floor has made in the appearance of the library. Attention to this need has been desired for some time, and we are pleased to have accomplished it this year..

The New Hampshire Library Commission advises that a book committee composed of the trustees, the librarian, and one or more qualified members of the community be appointed as an aid in selecting books, and we followed that advice. Miss Marie de Rochemont and Mrs. Ralph Loomis kindly served on that committee this year. In time, the changes of the committee will represent the varied tastes of our readers. The librarian is glad to receive suggestions for the book list from anyone at all times.

REPORT OF THE SUPERINTENDENT

To the Schoolboard of Newington:

I herewith submit to you my seventh report as superintendent of your schools.

The financial benefits of state aid have come to Newington with increasing force during the past three years. In the report of last year I said that \$479.99 had been paid the school district in December, 1934 and a like sum in December, 1935 "with a possibility of a slightly additional advance check in the spring." This additional check amounting to \$147.73 was received by the school board in June. Thus the total for that year was raised to \$627.72. The amount of aid for December, 1936 originally called for \$543.09 as stated last year. This has already been increased by twenty dollars and has been so received by your board. Thus, I believe, economy has been devoted and achieved. Another way of showing the effect of this aid may be as follows: In recent years up to and including the school year 1933 and 1934, the amount of money for the support of schools not derived from the school tax was between \$114 and \$140 yearly. The next two years the amounts were \$617.52 and \$770.75.

The amount of the appropriation for schools last March is about \$900 below the lowest in recent years. This is, of course, due to the first receipt of State Aid for the then current year. This cannot be expected to occur again.

Are Newington schools being operated economically? Tables of costs for the past year, as given out by the State Board of Education place the average per pupil cost in New Hampshire as \$77.93. The same tables place the Newington per pupil costs at \$75.03. Since there were sixtyseven pupils in our schools the per pupil allotment of State aid was \$9.37. Thus while the average per pupil cost was \$2.90 below the New Hampshire average, the cost to the people of Newington was actually \$12.27 below this average.

For the past few years Newington has been faced with the problem of a crowded primary room. This year we asked the teacher to give standard instruction to each of forty-one pupils in four different grades. With one grade in the room this might be possible but with four grades we were faced with two alternatives. We might continue under this handicap with the result of a continually increasing number of failing pupils and increasingly poor preparation for later grades. Since each year's work that is failed necessitates the pupil staving in school that much longer. failures are expensive. The other alternative was the employing of a part-time teacher to take charge of that part of the work which requires more personal supervision and individual attention. Mrs. Gaudreau is doing just this. It is my opinion that the extra expense to the district will result in a considerable lessening of failures and therefore obviate increased expense in the future. I feel certain that State Aid will keep the expense this year within the budget voted by the people last March.

This year, we are devoting special attention to the teaching of Spelling. Two definite steps have been taken toward increased efficiency in this skill. Samples of seventeen different and modern spelling texts were obtained and submitted to the teachers of this Supervisory Union for their comments and criticisms. It was the opinion of a large majority that for interest, teachability, and skillful application of the words studied, the Modern Life Spellers were the best. I am therefore recommending these texts in the Newington schools. Another approach to the same problem is to be made in that all papers written by pupils in any subject must be correct as to spelling before credit for the work will be given.

Our school nurse, Mrs. Sheehy, has won the confidence of the school people of Newington. Her services have helped to keep our attendance record in better condition. Whenever needed, she has given unhesitatingly of her own time and expense for the weifare of the children. Her itemized report follows and deserves careful reading.

Newington very much needs playground equipment. Such equipment may be as expensive or as inexpensive as need be. The problems arising from unequipped grounds are many and occasionally serious. The returns in school morale would be great. A slide would furnish amusement for a considerable number of pupils. Swings are inexpensive even when they are put out by commercial companies. Sometimes second-hand equipment can be purchased. This matter would furnish a project for some of the organizations in town which are interested in local conditions. Let me commend this matter to your earnest consideration.

I wish to express to you my appreciation of kindly advice and help received from you as a Board.

It was the pleasure of the School Board in September, to retain two of our teachers, Mrs. Marion Kenison and Miss Margaret Pickering. It was with regret, however, that we accepted the resignation of our Musical Supervisor, Mrs. Mary Poore.

At this time we wish to express our most sincere appreciation to the children's beloved music teacher, for her conscientious work in the past. The pupils and friends of Mrs. Poore will always have a warm feeling in their hearts for her.

We wish to extend a hearty welcome to the new addition to our teaching staff, Mr. George Wilson of Dover, N. H., who succeeds Mrs. Poore and is very competent in his work.

Upon the resignation of Mrs. Dorothy Lindsay, our district nurse, we were indeed fortunate in securing Mrs. Eloise Sheehy, whom we feel is carrying on the work in a most satisfactory manner.

We were pleased to secure Mr. Gillmore again for our district superintendent. As in the past, the interest and enthusiasm in his work is very valuable. Through his efforts we secured \$20. additional on State Aid. And as an increased attention to spelling seemed necessary a new system was inaugurated.
