Town Meeting Warrant

The State of New Hampshire

To the inhabitants of the Town of Benton qualified to vote in Town affairs:

You are hereby notified to meet at the Benton Community Building in said Benton on the second Tuesday of March next (March 11th) at ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose a Town Clerk, one Selectman for three years, John Boutin being the outgoing member, one Highway Agent, one Tax Collector, one Town Treasurer, one Auditor, one Trustee of the Trust Funds for three years, and all other necessary Town Officers and Agents for the ensuing year.

Article 2. To hear the Reports of Officers and Agents heretofore chosen and pass any vote relating thereto.

Article 3. To see how much money the Town will vote to raise and appropriate for Town Officers' salaries and expenses, for the repair and maintenance and construction of highways and bridges, for the observance of Memorial Day, and for all other Town charges and expenses for the ensuing year.

Article 4. To see what action the Town will take in regards to how Memorial Day will be observed.

Article 5. To see what action the Town will take to authorize the Selectmen to borrow money in anticipation of taxes.

Article 6. To see if the Town will vote to buy a snow plow.

Article 7. To transact any other business that may legally come before said meeting.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Benton:

I herewith submit my fourth annual report as Superintendent of Schools.

The total enrollment of the school in 1945-46 was 11, the average membership 10.83, the percentage of attendance 95.66, the number of tardinesses was 2. There was one pupil attending the Haverhill Academy, there were 2 elementary pupils at Pike School and 1 at Glencliff.

This year the total enrollment is 15. There are no pupils attending high school. One pupil is attending elementary school outside of the district.

The new playground apparatus is an excellent addition to the school equipment. A new set of encyclopedia has been added. Your teacher, Mrs. Katie Paige is to be commended for her interest and assistance in the procurement of these articles.

The future of your school is very uncertain. It appears that for the next few years, there will not be enough teachers to fill positions in the smaller towns. The teacher's colleges are graduating about one-third the demand. Many married teachers are giving up teaching. To exist, the small school must be prepared to make their positions more attractive than those of the large school. The answer to this problem is high salaries and good working conditions for those teachers who enjoy working in small communities.

Benton has a comfortable modern building and an excellent teacher. I am glad that the School Board and community are cooperating to retain their teacher and to support good education for its children.
