Coos County Convention.

CONCORD, N. H., January 11, 1899.

Agreeably to notice given by the Speaker, the Representatives from the several towns in Coos County met at the State House, Wednesday, January 11, 1899, at 1:30 p. m., for the purpose of organizing a County Convention.

The meeting was called to order by Mr. Howe of Lancaster. On motion of Mr. Crawshaw of Jefferson, J. Howard Wight of Berlin was elected Chairman. On motion of Mr. Smith of Lancaster, Herbert L. Robinson of Whitefield was elected Clerk.

And the above named Herbert L. Robinson was duly sworn according to law.

On motion voted to adjourn to the call of the Chairman. HERBERT L. ROBINSON, Clerk.

CONCORD, N. H., February 1, 1899.

The Coos County Delegation met in Representatives' Hall, Wednesday, February 1, at the close of the morning session.

Meeting called to order by the Chairman. On motion of Mr. Jordan of Stewartstown it was voted that the Delegation leave Concord next Friday morning, visit the jail at Lancaster, the Hatchery at Colebrook, and the County Farm at Stewartstown.

Meeting adjourned to the call of the Chairman.

CONCORD, N. H., February 22, 1899.

The Coos Delegation met in the Judiciary Room at the State House, Wednesday morning, February 22, at nine o'clock, on call of the Chairman. Meeting was called to order by Chairman Wight.

Moved by Mr. Smith of Lancaster that the sum of \$40,-000.00 be appropriated for each of the years 1899 and 1900, for the current expenses of the County.

After some discussion on the part of the members it was thought advisable to more fully understand the situation, and Mr. Smith's motion was withdrawn.

Moved by Mr. Hutchins of Stratford, and voted, that we adjourn until to-morrow morning at nine o'clock, pending an investigation of the needs and affairs of the County by the members of the Delegation.

CONCORD, N. H., February 23, 1899.

Agreeably to adjournment the Coos Delegation met in the Judiciary Room at nine o'clock. Meeting called to order by the Chairman.

On account of the absence of the Clerk, Mr. Butler of Northumberland was elected Clerk, pro tem, and took the oath of office.

Moved by Mr. Smith of Lancaster to have a committee of three appointed by the Chair to get estimates of appropriations for jail at Lancaster. The Chair appointed Smith of Lancaster, Cole of Stark, and Hutchins of Stratford. The Delegation discussed the re-recording of the County records, and it was voted that the Chairman, J. Howard Wight, be appointed a committee of one to investigate and report at the next Legislature.

Moved by Mr. Hutchins of Stratford that the sum of \$35,000.00 be appropriated for each year of the years 1899 and 1900, for the current expenses of the County.

Mr. Smith of Lancaster offered an amendment making the appropriation \$40,000.00 for each year.

Mr. Hutchins hoped the amendment would not pass. Mr. Jordan of Stewartstown spoke in favor of the amendment. Mr. Cole of Stark would further amend by making it \$35,000.00 the first year and \$40,000.00 the next.

On voting, Mr. Smith's amendment was lost, eight voting in favor and eleven against.

Moved by Mr. Crawshaw of Jefferson that the sum of \$35,000.00 be and hereby is appropriated for the year 1899, and the sum of \$40,000.00 be, and hereby is appropriated for the year 1900, for the current expenses of the County. Carried unanimously.

Voted to adjourn to the call of the Chairman.

Commissioners' Report.

To the Inhabitants of Coos County, N. H .: .

As required by law of the state to report the transactions of the county, we present this annual report together with the reports of the superintendent of the county farm and house of correction, physician, chapalin, sheriff, jailor, county solicitor, clerk of the supreme court, auditors and county treasurer, for the year ending December 31, 1899.

For the financial standing of the county, reference is made to the treasurer's report, also to the other reports herewith submitted of the various departments to which they refer.

We can but speak in terms of commendation of all connected with the farm and alms house. Mr. and Mrs. Fuller, superintendent and matron, are untiring in their efforts to make the poor as comfortable and happy as possible, and we believe that no institution within the state better cares for the poor than Coos County at its alms house, and at the lowest rate per week.

The expenses of the county have been unusually large for the past year owing to increased pauper bills, improvements at the County Farm in the way of a large refrigerator and wood shed, and an increased water supply which we deemed necessary for the preservation of the property in case of fire and which was put in at an extra expense of about \$700. Also an extra expense of about \$750 for shingling and painting the Court House, and making sewer connections with the Jail and Court House.

The costs in the Dean and Picot murder cases and all other criminal cases in our county have been extremely large for the past year, over which the county commissioners had no jurisdiction. The law passed by the legislature, 1899, making county houses, houses of correction throughout the state, for offences against the police of towns, we think is right. Since April 1 all drunks and minor offences have been sent to the farm where the county has furnished prison suits for them at a cost of four dollars per suit, and there has been furnished plenty of work for the prisoners to perform either at farm labor or cutting wood.

Physician's Report.

To the Commissioners of Coos County:

I have the honor to present to you the annual report of "The Coos County Poor Farm" and also a few remarks concerning it. At present the inmates are in good health, with one or two exceptions. There have been no contagious nor infectious diseases the past year except one case of "Typhoid" and an outbreak of "Measles" with no serious results. This absence of contagious diseases, etc., is due in large measure to the very good sanitary condition of the alms house and also to the perfect cleanliness preserved in and about the buildings. under the careful and efficient supervision of Mr. and Mrs. Fuller who are loved and respected by the inmates for their good care and kindness. The heating, lighting, ventilation, etc., are of the best and I consider it in all ways a model home. In the past year there have been an unusually small number of deaths, these being all elderly people. There have been only two births. They are as follows:
