

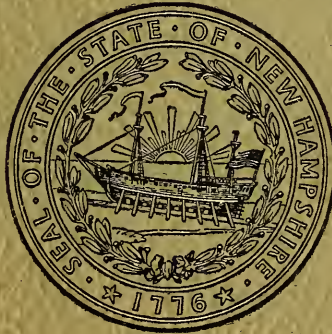

# TOWN WARRANT

STATE OF NEW HAMPSHIRE      CARROLL, SS.

To the inhabitants of the Town of Conway, County of  
Carroll, qualified to vote in town affairs:

You are hereby notified to meet at the Town House at  
Center Conway, New Hampshire, March 11, 1947 at nine  
o'clock in the forenoon to act upon the following subjects:

ARTICLE 1. To choose all necessary Town officers.

ART. 2. To see what sum of money the Town will vote  
to raise and appropriate for the following purposes:

- Section*
- A Town Officers' Salaries
  - B Town Officers' Expenses
  - C Election and Registration
  - D Municipal Court
  - E Town Hall and Office Expense
  - F Damage and Legal
  - G Police Department
  - H Fire Department
  - I Payment on Bond Issue

- L Town Maintenance of Highways (Summer)
- M Town Maintenance of Highways (Winter)
- N Libraries
- O Town Poor
- P Old Age Assistance
- Q Memorial Day
- R Soldiers Aid
- S Parks and Playgrounds
- T Interest on Bonds and Temporary Loans
- U County Tax

ART. 3. To see if the Town will vote to authorize the Selectmen to distribute the blank inventories at the time they examine and appraise the property to be taxed.

ART. 4. To see if the Town will vote to authorize the Selectmen to hire upon the credit of the Town the sum of \$60,000.00 if needed.

ART. 5. To see if the Town will vote to raise and appropriate the sum of \$368.54 to the White Mountains Region Association, being 10c. per \$1,000.00 of the assessed valuation (1/100th of 1%), for the purpose of issuing and distributing printed matter and advertising and otherwise publicizing the advantages of the town, in cooperation with the other 45 towns in the region. Agreeable to a petition signed by Robert N. Davis and others.

ART. 6. To see if the Town will vote to raise and appropriate the sum of \$2,072.25 for class 2 roads.



ART. 7. To see if the Town will vote to authorize the Selectmen of Conway to accept a road as surveyed on land of John Sheehy, Emma King, and Amos Ashnault, and to see if the Town will vote \$480.00 for the construction of said road. Agreeable to a petition signed by John W. Sheehy and others.

ART. 8. To see if the Town will vote to raise and appropriate a sufficient sum of money to make fill, and construct a foot bridge if necessary, across Pequawket Point in Conway from the rear of Dr. C. M. Wiggin's property to the Island so-called at or near the location of the present foot bridge. Agreeable to a petition signed by John W. King and others.

ART. 9. To see if the Town will vote to raise and appropriate a sufficient sum of money to repair and tar Quint street so-called in Conway Village from the Junction of the Allard Hill Road near the residence of the late Fred Towle to the end of the street at Pequawket Pond, a distance of one-half mile. Agreeable to a petition signed by John W. King and others.

ART. 10. To see if the Town will vote to rescind the adoption of the provisions of Chapter 55, Revised Laws of New Hampshire 1942, relating to Town Managers. Agreeable to a petition signed by L. W. Farrington and others.

ART. 11. To see if the Town will vote to authorize the Selectmen to secure the assistance of the State Tax Commission in reappraising the taxable property in the Town in order to secure greater equality as between taxpayers, and to insure the assessment of all property in the Town on the same standard of value, and to raise and appropriate money to pay for the same.

ART. 12. To see if the Town will vote to authorize the Selectmen to act for the Town in all matters pertaining to the establishment, construction and operation of aircraft landing areas and to confer and consult with State and Federal officials and to execute in the name of the Town any and all necessary or desirable instruments and agreements in connection therewith, provided that no financial obligation shall be incurred without a vote of the Town.

ART. 13. To see if the Town will vote to raise and appropriate \$2,500.00 to be expended under the direction of the Selectmen for the establishment, construction and operation of aircraft landing areas. Agreeable to a petition signed by Elmer H. Downs and others.

ART. 14. To see what sum of money the Town will vote to raise and appropriate for the activities of the Eastern Slope Region, Inc. for the year 1947. Agreeable to a petition signed by Wendell A. Lees and others.

ART. 15. To act upon any other business that may legally come before said meeting.

# Report of the ADVISORY COMMITTEE

---

The Advisory Committee of the Town of Conway presents herewith a brief report for the year 1946.

Immediately following the Annual Town Meeting in March, 1946 your Committee met frequently with the Selectmen, and, together with them, interviewed several applicants, unanimously approving the appointment by the Selectmen of Mr. Nat Stevens, an engineer formerly with the State Highway Department.

Following the appointment of Mr. Stevens in April, 1946 the Committee worked closely with the new appointee whose work and methods we have watched carefully and critically.

Mr. Stevens has supplied the Committee monthly with financial statements of those departments for which he was responsible. At each meeting these facts and figures were thoroughly discussed and it is the consensus of opinion of the Committee that the Town's money has been well spent under Mr. Stevens supervision. It is interesting to note that as of December 31, 1945 the Town had a debt of \$4,467.99 and as of December 31, 1946 the surplus was \$6,251.87. This shows an improvement in the financial position of the Town to the extent of \$10,719.87 for the year in which Mr. Stevens served as Town Manager for a period of eight months. The budget

which the Manager presented for the ensuing year, exclusive of any special articles to be inserted in the warrant, will result in a substantial reduction in our tax rate.

We are happy to report that we are of the unanimous opinion that Mr. Stevens, notwithstanding the many handicaps he encountered as Town Manager, has accomplished a remarkably fine job and effected many savings in those departments over which he has had jurisdiction.

As experience and knowledge of our Town is acquired by the Town Manager, there is every reason to believe that the expenses of our Town will be carefully supervised and less in total amount.

The Committee believes that the Town Manager form of government is proving as successful in Conway as in the many towns and cities throughout the United States where it is now in force.

- Sept. 22, 1946: Misuse of number plates. Pleaded guilty, fined \$5.00 and Court costs of \$4.70. Conway resident.
- Sept. 23, 1946: Driving while under the influence of intoxicating liquor. Pleaded guilty, fined \$50.00, and paid Court costs of \$16.32. Resident of Lovell, Maine.
- Sept. 24, 1946: Drunkenness. Pleaded guilty, fined \$5.00, and paid Court costs of \$4.70. Manchester, N. H., resident.
- Sept. 25, 1946: 1. Drunk and creating a disturbance. Subject struck another man on the left arm, with a beer bottle inflicting two lacerations that required medical treatment. Incident happened in Center Conway. Pleaded guilty, fined \$10.00, and ordered to pay Court costs of \$4.70. Resident of Franklin, N. H.
2. Taking a motor vehicle without owner's consent. Pleaded guilty, fined \$100.00, and ordered to pay Court costs of \$14.20. Same subject also booked for operating without a

license, \$10.00 fine suspended upon payment of Court costs of \$4.70. Subject took car from in front of the Eastern Slope Inn. While driving through Albany, N. H., he struck a tree causing approximately \$450.00 damage to the vehicle. Resident of Pearl River, N. Y.

Sept. 27, 1946: Drunk and disturbing the peace. Pleaded guilty, fine of \$5.00, suspended upon payment of Court costs of \$4.70. North Conway resident.

Oct. 5, 1946: Drunk and disturbing the peace. Pleaded guilty, fine of \$10.00 suspended upon payment of Court costs of \$4.70. On Oct. 17, 1946, he was again arrested for being drunk and disturbing the peace. Pleaded guilty, fined \$5.00 and paid Court costs of \$4.70. Subject was fingerprinted and the card was sent in to the State Identification Bureau to check on his record. It showed that he had been arrested one hundred and six (106) times and had been committed to jail to serve a sentence on twenty-three (23) different occasions. Nov. 3, 1946, he was again arrested for being drunk and creating a disturbance. Subject was not working, had no money, nor clothes, and needed medical attention. He pleaded guilty to the latter charge, was fined \$5.00, and ordered to pay Court costs of \$4.70, and he was sentenced to the House of Correction at Ossipee for a period of thirty (30) days.

Oct. 6, 1946: Driving while under the influence of intoxicating liquor, failing to stop for a Police Officer, and reckless driving. Pleaded guilty, paid fines totaling \$105.00 and Court costs of \$9.40. Fryeburg, Maine, resident.

Oct. 9, 1946. 1. Operating a motor vehicle, after his right to operate had been suspended. Pleaded guilty, fined \$5.00 and paid Court costs of \$4.70. Fryeburg, Maine, resident.

2. Drunk and disorderly. Pleaded guilty, fined \$5.00, and paid Court costs of \$4.70. Madison, N. H., resident.

Nov. 1, 1946: Driving while under the influence of intoxicating liquor. Pleaded guilty, fined \$100.00, \$50.00 of said

fine suspended upon payment of Court costs of \$4.70.  
Resident of Rumford, Maine.

Nov. 3, 1946: Carrying a gun on his person illegally. Pleaded guilty, fined \$25.00, and paid Court costs of \$4.70. Subject a Navy enlisted man was released to Naval authorities at Newport, R. I., for trial on charge of assault with a dangerous weapon. The assault was perpetrated on a North Conway resident in Intervale on the night of Nov. 3, 1946. Subject is a Berlin, N. H., resident and was stationed in Newport, R. I.

Nov. 4, 1946: Operating an unregistered motor vehicle. Pleaded guilty, fined \$5.00, paid Court costs of \$4.70. Conway resident.

Nov. 16, 1946: Operating while under the influence of intoxicating liquor. Subject was involved in an accident. Pleaded not guilty, found guilty, fined \$100.00, \$50.00 of said fine suspended upon payment of Court costs of \$4.70. Madison, N. H., resident.

Nov. 19, 1946: 1. Obstructing a Police Officer, pleaded guilty, fined \$100.00, \$95.00 of said fine suspended on payment of Court costs of \$4.70. Redstone resident.

2. Assault and obstructing a Police Officer. Pleaded not guilty, found guilty, fined \$100.00, \$50.00 of said fine suspended upon payment of Court costs of \$4.70. North Conway resident.

Nov. 22, 1946: Speeding, 50 miles per hour on Main Street, Conway, failing to stop for a Police Officer. Pleaded guilty to both charges, fined \$10.00, and ordered to pay Court costs of \$4.70 on speeding charge. Failing to stop charge placed on file. Tamworth, N. H., resident.

Nov. 30, 1946: Driving while under the influence of intoxicating liquor. Defaulted \$50.00 bail. Methuen, Mass., resident.

- Dec. 1, 1946: 1. Operating a motor vehicle without a license. Pleaded guilty, fined \$10.00 and paid Court costs of \$4.70. Fryeburg, Maine, resident.
2. Allowed an improper person to operate a motor vehicle. pleaded guilty, \$10.00 fine suspended upon payment of \$4.70 Court costs. East Conway resident.
- Dec. 7, 1946: 1. Driving while under the influence of intoxicating liquor. Pleaded guilty, fined \$50.00 and paid Court costs of \$4.70. Center Conway resident.
2. Drunk and disorderly. Defaulted bail of \$10.00. Sweden, Maine, resident.
- Dec. 19, 1946: Leaving the scene of an accident (hit and run). Subject struck an electric light pole near Manley's Cabins in North Conway, snapping the pole off at ground level, plunging three surrounding towns into darkness. Car was found abandoned in Bartlett the following day. Pleaded guilty, fined \$10.00 and paid Court costs of \$4.70. Resident of West Campton, N. H.
- Dec. 21, 1946: 1. Four Manchester, N. H., men were arrested upon complaint of the manager of the North Conway Diner. The aforementioned subjects when asked by the counterman to pay for the food they had ordered and consumed, refused. When the counterman insisted that they pay he was struck and beaten by the four men. They were charged with defrauding an Inn Keeper and creating a disturbance. Each man pleaded guilty and was fined \$30.00 and ordered to pay Court costs of \$9.40. A fifth member of the same party was charged with creating a disturbance, pleaded guilty and was fined \$10.00 and paid Court costs of \$4.70.
2. Drunk and disorderly. Pleaded guilty, \$5.00 fine suspended upon payment of Court costs of \$4.70. Conway resident.

On Oct. 7, 1946, three juveniles, two 10 years old, and one 12 years old, were apprehended for breaking, entering and

larceny. The subjects were not brought before a juvenile court or turned over to New Hampshire State probation authorities. A probationary period of one year was instituted by the Chief of Police. They are to report to him every Friday for a period of one year; during that time they will be instructed in the basic principals of Law, law enforcement, and the Chief will endeavor to follow a program which is interesting and educational.

On Nov. 16, 1946, a phone call was received from the Kennebec County Sheriff's office, in Augusta, Maine. It was requested that this department be on the lookout for a man they had reason to think that he might be in this locality. He was wanted for aiding and abetting in the escape of prisoners from the Kennebec County jail. They gave a detailed description of the suspect and stated they had a warrant for his arrest and they would rendite. On Nov. 21, 1946, the suspect was apprehended in Conway by a member of this department. The suspect waived extradition, necessary papers were issued and he was turned over to Maine authorities.

Up to December 1, 1946, five automobile accidents were investigated by this department. Three pedestrians were struck by automobiles, none were seriously injured. One hit and run accident, the car was found abandoned in Bartlett the following day. The damage to the car was extensive. The operator was apprehended two days later and brought to Court.

From Sept. 22, 1946 to Dec. 31, 1946, fifteen lodgers stayed overnight in the North Conway precinct building jail.

Seventeen men were fingerprinted and their prints forwarded to the New Hampshire State Bureau of Identification. Nine of the men had a criminal record prior to being arrested in Conway.

## Forest Fire Warden's Report

---

### HELP YOUR FOREST FIRE WARDEN PREVENT FIRES — IT PAYS!

---

Prevention is one of the most important phases of all fire effort. This is particularly true of forest fire control work. Preventing forest fires preserves valuable forest growth and other property, conserves man power and permits their use in productive channels, saves taxpayers' money and conserves fire fighting equipment.

The prevention of forest fires is the most important and difficult part of the work of your forest fire warden who heads a local organization set up primarily for the security of your community's forest property. Appointed by the State Forester, upon recommendation of the Selectmen, he is charged by law with the responsibility of local administration of forest fire laws, fire prevention and suppression. In his work he is aided by deputy forest fire wardens who, in emergency, may assume his power and authority. The warden is guided in his work by instructions received from the State Forester and by the District Fire Chief who represents the State Forester.

The importance and value of the work of the forest fire warden and his deputies is, perhaps, best appreciated during hazardous periods when fire danger is greatest. The public, however, looks to him at all times for speedy and economical suppression of going fires.

To properly fulfill his mission, the warden needs the generous and understanding cooperation of the public at large. He attempts to secure this cooperation by the posting of caution

notices, news items and by word of mouth, always carefully explaining the necessity of restrictions imposed. In the matter of giving cooperation, however, the public often fails. The record shows that an average of 7,300 acres of woodland are burned over by forest fires in New Hampshire each year. Analysis of fire causes reveal the fact that more than 98 percent of all forest fires are, consistently, the result of human carelessness and are preventable.

The careless smoker fails to properly extinguish his cigar, cigarette or pipe ashes or thoughtlessly throws them from the car window; the debris burner fails or refuses to consult the warden, as the law requires when the ground is not covered with snow, before attempting to burn; campers fail to properly extinguish their fires or frequently build fires when conditions are unfavorable.

The elimination of human causes from the forest fire problem is the answer. This is not as difficult of accomplishment as it might appear at first glance. Let each one who reads this—

1. Use ordinary common sense with fire in and near woodland.
2. Comply with requirements on the use of fire in and near woodland and when the ground is not covered with snow, secure written permission to burn from the forest fire warden.
3. Be careful when smoking in or near woodlands. Don't throw lighted material from moving vehicles.
4. Cooperate with and assist the warden and urge others to do so.
5. **HELP YOUR FOREST FIRE WARDEN PREVENT FIRES**—his efforts are only as effective as is the cooperation you give him!

## Report of Superintendent

---

*To the School Board and Citizens of Conway:*

School costs have greatly increased since 1940 and the trend will continue throughout the next school year. The money spent per pupil by the taxpayers of Conway is somewhat less than the State and National average for both high and elementary schools. The local cost per elementary pupil for the school year 1944-45 was \$83.11 as against the State average of \$112.29; and \$145.66 for each high school pupil as compared with the State average of \$158.03. The budget for the next year requests \$1,900.00 less from local taxation than was raised this year. This reduction is possible because of increased elementary and high school tuition receipts and because of the probability of more state aid money.

There should be a further study of the building needs at North Conway and of possible ways to reduce the crowded condition in the lower grades at the Conway Grammar School.

The health work this year has included a thorough examination of many pupils. The cooperation given by the doctors, and the funds donated by the Woman's Club, Salvation Army, and Red Cross are all greatly appreciated.

Sixty-three tuition pupils have registered at Kennett High School, six of whom have left school. Thirty-seven students have registered from Tamworth and have become amalgamated with the student body to a remarkable degree. They have been a real addition to the school.

Last June a class of 35 was graduated, five of whom are now married, 15 employed, seven in the Armed forces, one at home, five in college, and two in business for themselves.



There are students at the University of New Hampshire, Boston University, Harvard, Brown, Syracuse, Keene and Plymouth Colleges, Bowdoin, Simmons and Rensselaer Polytechnic Institute.

The Agricultural course, established last fall, has 21 students registered, working in all phases of agriculture fitted to this locality, including instruction in carpentry, plumbing, soldering, blacksmithing, care of farm engines, electricity, and rope work. Each student is required to carry on a home project, and these projects are approved and supervised by Mr. Bubar. There are projects this year in gardening, poultry, bee-keeping, landscaping, dairying, pigs, and forestry. Pupils from towns maintaining a high school may have their tuition paid by the State if they take the Agricultural course at Kennett High School. It is also possible that there will be money available for the payment of their transportation.

The Home Economics classes under the direction of Miss Folsom are so organized that the freshmen study the fundamentals of clothing construction, kinds of cloth, patterns, and problems in making over clothing. The sophomores study foods and nutrition which include food preservation, meal planning, preparation and serving. The juniors study the home, consider home furnishings and other problems relating to the home. The senior group studies the family, each girl's place in the family, child development, home nursing and family finances.

Both Miss Folsom and Mr. Bubar plan to visit each parent of the students in their classes before the close of this school year.

The work in Commerce has been increased this year and Miss Giles has given freely of her time outside of school hours that boys and girls wishing to learn to typewrite might have the opportunity. The classes have done a great deal of work for local churches, clubs, and school organizations.

The shop has been rearranged and reorganized and is functioning successfully. The course is very popular, and consequently presents the problem of limiting the enrollment in some sections.

The music work throughout the schools has shown great progress under the leadership of Miss May. The elementary and high school glee clubs have made an excellent beginning and an orchestra has been started.

The physical education program in the schools has been limited although organized basketball and football have been included in the program. Mr. Seidenstuecker, Mr. Davidson and Mrs. Sanborn have made it possible for many boys and girls both in high and elementary schools to have some athletic training.
