To the Inhabitants of the Town of Runney in the County of Grafton in said State, qualified to vote in Town Affairs: (L*S)

You are hereby notified to meet at Rumney Town Hall in said Rumney on Tuesday, the thirteenth (31th.) day of March, next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To see how much money the town will vote to raise and appropriate for Highways in addition to the amount required by law.

4. To see how much money the town will vote to raise and appropriate for the care of the Library.

5. To see how much money the town will vote to raise and appropriate for street lights.

6. To see how much money the town will vote to raise and appropriate for the care of Cemeteries.

7. To see how much money the town will vote to raise and appropriate for the care of the Common.

8. To see how much money the town will vote to raise and appropriate for the Owen B. LaMott Post No. 76, American Legion, for Memorial Day and other patriotic purposes.

9. To see how much money the town will vote to raise and appropriation for the Fire Department.

10. To choose a Fire Commissioner.

11. To see if the town will vote to raise and appropriate \$ 270.51 to secure from the State \$ 1,082.03 to be expended for Town Road Aid.

12. To see if the town will vote to raise and appropriate \$ 400.00 for control of the White Pine Blister Rust in cooperation with the State Forestry and Recreation Department.

13. To see if the town will vote to raise and appropriate\$ 81.00 to the Lakes Region Association which is one one

hundredths of one per cent (1/100 of 1%) of the assessed valuation, for the purpose of publicizing and promoting the natural advantages and resources of the town, together with other towns in the Lakes Region.

14. To see if the town will vote to authorize the selectmen to administer, lease, rent, or sell or otherwise dispose of any real estate or any "Mineral Rights" acquired by the town at its tax collector's sales.

15. To see how much money the town will vote to raise and appropriate for the Sceva Speare Memorial Hospital of Plymouth, N. F.

16. To see if the town will vote to petition the State Tax Commission to have an audit made by the division of municipal accounting and to make appropriation to cover the expense of such audit.

17. - To see if the town will vote to raise and appropriate \$ 1,287.00 to be set aside for future construction under the State Aid Orange System on unimproved Class 2 roads to match State funds which will become available later, at which time work can be started.

18. To see if the Town will vote to support United States membership in a general system of international cooperation, such as that proposed at the Dumbarton Oaks Conference, having police power to maintain the peace of the world.

19. To see if the town will vote to allow a 2 per cent discount on all taxes paid within fifteen days after presentation of tax bill.

20. To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes.

21. To see if the town will vote to have the inventory blanks distributed at the time of taking appraisal of property.

22. To transact any other business that may legally come before said meeting.

9. To see if the District will vote to raise and appropriate the sum of \$975.00 to install flush toilets together with necessary equipment and construction at the Village School.

ANNUAL REPORT OF THE SUPERINTENDENT OF SCHOOLS

To The Runney School Board:

This report, which is my second one, as your superintendent of schools will briefly present the principal facts about our Rumney schools and those recommendations which you are asked to consider.

We were fortunate in being able to retain all of our teachers of the previous year. Only those towns that were obliged to enter the highly competitive field of contract making for new teachers can fully appreciate how fortunate we were. In order that we may continue our schools without interruption I recommend that careful thought be given to the upward revision of our salary schedule.

Music instruction was resumed in October when Miss Carolyn E. Gove of Laconia was employed as music supervisor. There was an interruption of five weeks while her car was undergoing repairs following an accident which occurred while she was on her way to the Manchester Convention. Miss Gove's manner of approach has won the good will of her pupils and the teachers. We believe that much will be accomplished in music under her direction.

Transportation service is well organized and efficiently maintained. So far as I know there have been no criticisms this year either by parents or by pupils. Because of the detail involved in securing gasoline allottments for transporters it is strongly recommended that contracts for school transportation be negotiated before the term closes in June.

The new heating plant at the Depot School has been in operation since the begining of the present school year with good results. The decision to burn coal appears to have been a wise one which should, under normal conditions, give both greater comfort and reduced heating costs. Maximum efficiency and ease of operation can be realized when desired grades and size of coal can be readily obtained. The blower system insures a more even distribution of heat where it is needed. Shortage of manpower has thus far prevented completion of a well at the Depot School for which an appropriation was made two years ago. It now seems that we shall have no well until more labor is available unless arrangements can be made to have one drilled. The cost of such a well will be more than the two hundred dollars appropriated for digging a well but it should easily be worth the difference. Construction of a school well will provide greater convenience and will show a substancial cost reduction over a period of years.

The work of modernizing our textbook equipment and making it uniform in all schools is progressing as rapidly as finances permit. The basal system of readiling has been carried through grade four beyond which it wfll not be extended. "Adventures in English" is now used from grade three through eight.

Regular, planned instruction in hand writing is given throughout all grades. Manuscript writing was started this year in grade one and will be continued until the second half of grade two when the change will be made to cursive writing. Research and experimentation have definitely proved that better progress in reading accompanies the use of manuscript writing for beginners. We hope to introduce a new and better graded series of history textbooks by September. Changes in geography must wait until stable world conditions make possible the preparation of textbooks which promise less frequent revisions than are now necessary.

The new report cards being used this year are designed to give parents a clearer as well as a more detailed report of the progress their children are making. They are expected to stimulate pupil interest by showing parallel estimates of achievement and of effort in each subject and to make everyone more keenly aware of the importance of good school cuizenship. I believe the report on citizenship qualities is the best indication of what may be expected in adult performance. The ideals and attitudes we are able to establish in children will remain as a powerful force long after the facts of everyday instruction are forgotten.

Again it is my pleasure to report the most helpful cooperation of pupils, parents, teachers and the Rumney School Board. For all this my thanks are hereby expressed. Respectfully Submitted,

Vision 5, new glasses 3, lenses changed

29 Children were treated at dental clinics held at Plymouth.

2 Children had examinations and glasses through the sight Conservation Department of Public Welfare.

1 Child had Chest X-rays by the State Tuberculosis Association.

88 school calls, 144 home calls, and 45 business calls were made in connection with the Health Program of class room inspection and talks, home calls and clinic work.

At the beginning of school 1944 these pupils showed symptoms of defects: Children examined 108 Dental defects 38 Topsils enlarged or diseased 20 Vision defects $\mathbf{5}$ Enlarged glands 11 Orthopedic 1 4 Underweight

13 children have been tested to date with the audiometer for hearing and 1 found to be defective.

The usual fine co-operation of those interested in the health of the school children is greatly appreciated.
