A full attendance of the Representatives, together with the Senators of the county, the County Commissioners, Judge Young, and the Jailer, Meserve.

The committee appointed “To consider the commissioners’ report and recommend some estimate for their consideration regarding appropriations for county expenses for 1888 and 1889,” have attended to their duty, and submit the following resolutions and recommend their adoption :

1. Resolved, we raise by taxation upon the estates of Strafford county the sum of fifty-five thousand dollars for the year 1888, and appropriate the same as follows, to wit :

Decrease of bonded debt,	10000 00
Interest on bonded debt,	3000 00

3. Resolved, that we raise by taxation upon the estates of Strafford county the sum of \$1000 additional in 1888, for the purpose of re-indexing the Records of Deeds of Strafford county from Jan. 1, 1839, to Jan. 1, 1860, by the Campbell method.

Voted, on motion of Mr. Andrews, that the report of the committee be accepted. After some discussion the resolutions were adopted on motion of Mr. Ritchie.

Voted, on motion of Mr. Andrews, that a committee of five be appointed to take the matter of building a new jail into consideration, and get plans of building, and confer with Dover regarding a situation on the city farm, and also to examine other localities, and see at what price the old jail can be sold.

An informal vote showed that nineteen thought this delegation should build a county jail, and that eight opposed building.

Voted, on motion of Mr. Woodman, that the chair appoint the committee. The chair appointed Messrs. Andrews, Nute, Kimball, Gross and Calef.

Voted, on motion of Mr. Young, that the commissioners of Strafford county be instructed to place the jail in Dover in good sanitary condition, and to remove so much of the fence surrounding the jail as they deem for the best interests of the jail, and make such other improvements as they deem best, at a cost not exceeding fifty dollars for the same, and that it be done within two weeks' time.

## Commissioners' Report.

---

The Commissioners of the County of Strafford hereby submit their annual report for the year ending May 1, 1888, together with the reports of the Superintendent of the County Farm, Chaplain, Sheriff, Physician, Jailer, Solicitor, Treasurer, Auditor, and Clerk of Supreme Court.

### FINANCIAL CONDITION OF THE COUNTY.

The report of the Treasurer will show that the expenses of the county for the year ending April 30, 1888, were about the same as those of the preceding year, and that there has been an increase of the county debt to the amount of ten thousand dollars. The same reasons are applicable for the increase this year as were given in our report of 1887, i. e., the light appropriations of (\$30,000) thirty thousand dollars by the legislature for each of the years 1887 and 1888. We have been compelled to borrow (\$20,000) twenty thousand dollars this year, and anticipate a much larger sum for the year to come.

Ten thousand (\$10,000) of bonds due Dec. 1, 1887, were paid. A similar sum is due Dec. 1, 1888.

### JAIL.

At a meeting of the county delegation holden at Concord, Aug. 24, 1887, the sum of twenty-five thousand dollars was

raised and appropriated, along with the proceeds of the sale of the old jail and lot, for the purpose of the building of a new jail. The city of Dover very creditably and very liberally deeded the county five acres of land, well adapted to the use for which it was given. A contract has been signed with the Pauly Jail Co. for the building of a rotary jail and house for jailor. We presume that before another year the old jail that has stood as a disgrace and dishonor to the fair name of Strafford county, will be replaced by one of the most modern in New England.

#### COUNTY FARM.

The expense of running this institution for the year ending April 30, 1888, will not vary much from that of 1887. The commissioners, believing it to be for the best interests of the county, have made a change in the office of Farm Superintendent. Mr. Wentworth retired in favor of Mr. J. G. Stiles. Mr. Stiles and wife came highly recommended, and have entered upon their duties with energy. Dr. Blanchard has superceeded Dr. Daniels as county physician. Mr. Driscoll is caring for the insane. No improvements of importance have been carried into effect during the year.

#### PAUPERS OFF THE FARM.

There has been a slight falling off in the cost of this department. The Selectmen and Overseers of the Poor have rendered us efficient aid in the care of this class of the unfortunate.

## Physician's Report

---

TO THE COMMISSIONERS OF STRAFFORD COUNTY:

Gentlemen—The general health of the inmates at the Almshouse and Insane Asylum the past year has been as good as it is possible to have at an institution where a large number of those living there are there by reason of some infirmity.

There have been no diseases the past year which come from a neglect of sanitary laws. The isolated and excellent location of the buildings, and their construction in accord with modern hygienic regulations, all tend to bring about the above result.

There are many aged people at the county farm, and a large number of the deaths are due to the degenerative changes incident to advancing years.

Eleven of those dying the past year were over sixty-five years of age, two being over eighty. Several of those who have died were very near the close of life when brought to the almshouse.

There have been ten births during the past year, more than in any year for a number of years, and, indeed, if my information is correct, more than in any year in the history of this institution.

I appreciate very much the kind assistance I have received from commissioners, superintendents and matrons, all of whom have helped to make my work as light and pleasant as possible. Respectfully,
