To the Inhabitants of the Town of Danville, in the County of Rockingham, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said town on Tuesday, the 10th of March next, at nine o'clock in the forenoon, to act on the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To hear the report of the budget committee and act thereon.
- 3. To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriation for same.
- 4. To see what sum of money the town will vote to raise and appropriate to repair the several highways and bridges.
- 5. To see if the town will vote to raise and appropriate a sum of money necessary to obtain State aid on either new construction or town road maintenance.
- 6. To see what sum of money the town will vote to raise and appropriate for snow paths.
- 7. To see what sum of money the town will vote to raise and appropriate for the Public Library.

- 8. To see if the town will vote to raise and appropriate a sum of money to be used in improving the cemeteries.
- 9. To see if the town will vote to raise and appropriate a sum of money for the observance of Memorial Day.
- 10. To see if the town will vote to authorize the Selectmen to hire money for the use of the town.
- 11. To see how much of the Parsonage Funds the town will vote to spend for preaching for the year ensuing.
- 12. To see if the town will vote to raise and appropriate the sum of fifty dollars for a new culvert on Brown Hill Road.
- 13. To transact any other business that may legally come before the meeting.

At the same time, the ceilings at the Eaton School were brightened. The walls are of a dark color and should be painted a much lighter shade. This work appears necessary this coming summer. The outside of the Eaton School likewise needs painting. Let us anticipate the return of better times and begin consideration of repairs or changes to the toilet facilities at this school.

SCHOOLS OF TODAY

Whatever may be wrong with this country, the public schools cannot be charged with the whole responsibility for it. Yet, we are well aware of the many criticisms that are directed at them. We are quite sure that errors are evident, yet we strive to reduce these to the lowest minimum. We believe that education of today is a sane procedure to help the individual realize on his possibilities. We aim to improve character, to impress neighborliness and duty, to improve social responsibility, and to prepare youth for the life they must live whether they desire to or not. We must be progressive to meet the changing conditions the same as industry has to or is forced to by circumstances beyond its control. The schools must go on.

I would not be unmindful of the generous support given me by the corps of teachers, the helpful advice of a faithful Board, and the loyalty of an active citizenry. To all, I express my gratitude.
