- 9. To see what sum of money the Town will vote to raise and appropriate for Civil Defense.

- 10. To see if the Town will vote to raise and appropriate the sum of \$12.09 to the White Mountain Region Association, it being 10c per \$1,000.00 of the assessed valuation.
- 11. Shall the provisions of Chapter 171-A of the Revised Laws relative to playing games of Beano, be adopted in this Town?
- 12. To see if the Town will vote to allow the Collector of Taxes additional compensation for his service in collecting the State Head Tax and to fix the amount thereof.
- To see what sums of money the Town will vote to raise and appropriate for payment and interest on Light Line Note.
- 14. To transact any other business that may legally come before the meeting.
