

TOWN CLERK'S RECORDS

TOWN WARRANT FOR 1930

(L. S.) STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Hampton, in the county of Rockingham, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said town of Hampton on Tuesday, the eleventh day of March next, at ten o'clock in the forenoon to act upon the following subjects:

- Article 1. To choose by Austrailian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes and three Auditors.
- Article 2. To choose all other necessary officers for the ensuing year.
- Article 3. To raise and appropriate such sums of money as may be necessary for Town Officers' salaries and expenses, Election and registration, Municipal Court, care and supplies of Town Hall, Police Department, Fire Department, Moth Department, Health Department, Red Cross, highways and bridges, street lighting, library, Town poor, Memorial Day, parks and playgrounds, cemetery, sewer department, interest, sidewalks, comfort station, breakwater, Town notes, Hampton Beach and all other necessary charges arising within the Town.

- Article 4. To choose a candidate to Constitutional Convention.
- Article 5. To see if the town will vote to give the selectmen power to borrow money in anticipation of taxes.
- Article 6. To see if the town will vote to install a signal light at Lane's corner and raise money for same.
- Article 7. To see if the town will vote to raise \$3,000.00 for the rebuilding of the bridge over Taylor River.
- Article 8. To see if the town will vote to raise and appropriate \$2,000.00 for sidewalks.
- Article 9. To see if the town will vote to raise and appropriate \$2,100.00 for White Way at beach.
- Article 10. To see if the town will vote to raise and appropriate \$1,000.00 to purchase hose.
- Article 11. Upon a petition signed by William J. Crole and ten others, to see if the town will approve of a two way road on Island Path beginning at a point near the Merrill Cottage and continuing westerly about 1,000 feet to the Crole Cottage, and to raise and appropriate money for same.
- Article 12. To see if the town will give the selectmen power to make a contract for collecting garbage for three years.
- Article 13. To transact any other business that may come before said meeting.

REPORT OF TOWN MEETING, MARCH 11, 1930.

Meeting was called to order by the Moderator, Dean B. Merrill, at 10:10 o'clock in the forenoon. The warrant was then read by the Moderator after which prayer was offered by Rev. Herbert Walker. The Moderator then appointed the officers of the Australian Ballot to their respective places. The officers and clerk appointed were:

Moderator pro tem, Uri Lamprey; clerk pro tem, Charles F. Adams; ballot clerks, Francis C. Dennett, Clinton H. Durant, William Gilpatrick, Daniel H. Cushing, Harold E. Noyes. The ballots and manner of voting were explained to the meeting by Moderator Dean B. Merrill. The ballots to be used at this meeting were called for and they were given to the ballot clerk by Town Clerk William Brown.

Motion, to close the polls at 6:30 o'clock P. M. This motion was carried.

Recess of 30 minutes was declared by the moderator for voting. The meeting was resumed at 11:10 A. M.

Article 2. Motion, to elect Edgar Warren library committee for three years. This motion was voted.

Article 3. Motion, to take up each article separately.

Motion, under Town Officers' Salaries and Expenses, to raise and appropriate \$6,500. This was voted.

Motion, under Election and Registration, to raise and appropriate \$750. This was voted.

Motion, under Municipal Court, to raise and appropriate \$500. This was voted.

Motion, under Care and Supplies of Town Hall, to raise and appropriate \$1,000. This was voted.

Motion, under Police Department, to raise and appropriate \$7,500. This was voted.

Motion, under Fire Department, to raise and appropriate \$16,000. This was voted.

Motion, under Health Department, to raise and appropriate for Cleaning Beach, \$1,500; Health Dept., \$3,500. This was voted.

Motion, under Vital Statistics, to raise and appropriate \$30. This was voted.

Motion, under Parking Space, to raise and appropriate \$1,000. This was voted.

Motion, under Trunk Line Maintenance, to raise and appropriate \$7,500. This was voted.

TOWN MAINTENANCE

Motion to raise and appropriate \$10,000 to be used on High street and that \$5,000. should be expended on each end of High street and that it should be let out to contract.

Remarks by Rev. Herbert Walker; also by Warren H. Hobbs. After these remarks there was a motion to raise \$12,000. A motion by L. C. Ring to amend this previous motion and raise \$6,000. for High St. This was not voted.

Motion, to raise and appropriate \$12,000. for Town Maintenance, was voted.

STREET LIGHTING

Motion, to raise and appropriate \$8,000. This was voted.

COMFORT STATION

Motion, to raise and appropriate \$3,000. This was voted.

LIBRARIES

Motion, to raise and appropriate \$1,200. This was voted.

TOWN POOR

Motion, to raise and appropriate \$2,000. This was voted.

MEMORIAL DAY

Motion, to raise and appropriate \$150. Remarks made by Warren H. Hobbs were to turn the money raised over to the Winnicummett Council No. 3, Jr. O. U. A. M., to carry out Memorial Day exercises. This was voted.

RED CROSS

Motion, to raise and appropriate \$1,600. A motion to change this appropriation from the Red Cross to the Health Department, and that the management of the Community Nurse shall be by the Health Department of the Town. This was voted.

BAND

Motion, to raise and appropriate \$2,500. This was voted.

PARKS AND PLAYGROUNDS

Motion, to raise and appropriate \$2,000. This was voted.

DAMAGE AND LEGAL EXPENSES

Motion, to appropriate \$20,000. Remarks by H. D. Munsey, Edgar Warren, W. H. Hobbs, and Ernest G. Cole. This motion was not carried.

Motion, to raise and appropriate \$20,000. This was voted.

CEMETERIES

Motion, to raise and appropriate \$700. This was voted.

SEWER MAINTENANCE

Motion, to raise and appropriate \$2,000. This was voted.

INTEREST

Motion to raise and appropriate \$5,000. This was voted.

HIGHWAYS AND BRIDGES

Motion, to raise and appropriate under State Aid, \$2,800. Remarks by Mr. Walker and Mr. Munsey.

SIDEWALKS

Motion, to raise and appropriate \$1,000. After some discussion this motion was withdrawn.

Motion, to take up this article under Article 8. Motion.

BREAKWATER

Motion, to raise and appropriate \$2,000. This was voted.

INDEBTEDNESS

Motion, to take A and B together, which was to raise and appropriate \$11,500. This was voted.

STATE TAX

Motion, to raise and appropriate \$11,500. This was voted.

COUNTY TAX

Motion to raise and appropriate \$10,000. This was voted.

RECESS FOR 30 MINUTES

Article 5. Motion, to give selectmen power to borrow money in anticipation of taxes. This was voted.

At this time Mr. Walker made some very fitting remarks in regard to the death of ex-President William Howard Taft. The meeting was requested to rise in his honor. This was followed by prayer by Mr. Walker. On motion of Warren H. Hobbs it was voted to keep all flags in town at half mast for thirty days in honor of the death of William Howard Taft.

Article 6. Motion, to raise and appropriate \$700. This was voted.

Article 7. Motion, to raise and appropriate \$3,000. to build a bridge over Taylor River and grade hollow on Hampton side of bridge. This was voted.

Article 8. This was previously taken up.

Article 9. Motion, to raise and appropriate \$2,100. This was voted.

Artcle 10. Motion, to raise and appropriate \$1,000. to purchase fire hose. This was voted.

Article 11. Motion, to instruct the Road Agent to build this road and the costs to be taken from Highway Appropriation. Remarks by Warren H. Hobbs. Amendment to first motion was voted. Then a motion was made to raise and appropriate \$600. This motion was voted.

Article 12. Motion to give selectmen power to make a contract for three years. This motion was voted.

Article 13. Motion by George Ashworth to instruct the selectmen to take up with the Water Co. in regard to water pressure.

Motion, to raise and appropriate \$150. to continue fire alarm boxes up the Exeter Road.

Motion, to refer back to Article 3 under Fire Department. This motion was voted.

Motion, under Article 3, to raise and appropriate \$150. for one fire alarm box on Exeter road in front of Wingate Place. This motion was voted.

Motion, to instruct selectmen to place stop sign on Mill Road at the intersection on High Street, and to place a signal on High Street. This motion was voted.

Motion by Harold E. Noyes, that candidates for Town Offices be required to file a petition with the Town Clerk six days before the date of election; said petition to bear the endorsement of twenty-five legal voters of Hampton, and that such a petition shall be the only requirement necessary to have the candidate's name printed on the ballot. Remarks by Warren H. Hobbs, John W. Perkins, Herbert Walker, and Edgar Warren. A motion to indefinitely postpone was not voted.

Then the original motion was voted.

Motion, by Herbert E. Lamprey, to pay men working for the Town \$4.00 per day of eight hours. This was voted.

Motion, by Irene J. Trefethen, to remove two posts from Elmwood Corner and to erect a sign marked "Boston" was voted.

Voted to adjourn at 2 P. M.

Pursuant to a notice to the voters the Direct Primary was held in the Town Hall at Hampton, N. H., County of Rockingham on Tuesday, September 9, 1930, beginning at ten o'clock, for the nomination of candidates for the following officers: Governor, United States Senator, Representative in Congress, Councillor, Senator, Sheriff, Solicitor,

County Treasurer, Register of Deeds, Register of Probate, 3 County Commissioners, Representative to the General Court, Moderator, Supervisors of the Check List, Delegates to State Convention. (Election).

The meeting was called to order by the Moderator, Dean B. Merrill, at 10 o'clock in the forenoon, who read the notice to the Voters calling the meeting, after which it was voted to close the polls at 6 o'clock P. M. The Moderator appointed Francis C. Dennett, Clinton H. Durant, William Gilpatrick and Harold E. Noyes as ballot clerks.

The Moderator then called for and received the ballots from the Town Clerk which were distributed to the Ballot Clerks and the votes were then called for. To the inhabitants of Hampton qualified to vote for senators in said state:

You are hereby notified to meet at Town Hall in said Town on the Fourth day of November next at ten o'clock in the forenoon for the following purposes: To bring in your votes for Governor; to bring in your votes for United States Senator and Representative in Congress; to bring in your votes for Councilor, State Senator, and one or more persons to represent the Town in the Geneal Court of the State for the ensuing two years; to bring in your votes for County Sheriff, Solicitor, Treasurer, Register of Deeds, Register of Probate and three Commissioners; to bring in your votes for Supervisors of Check List, a Moderator and any other officers to be chosen for the ensuing two years.

To bring in your votes on the following questions submitted to the qualified voters of this State by the Convention to revise the Constitution, in session June 4 to June 13, 1930.

- 1. Do you approve of giving the General Court power to provide for voting by absentees at biennial elections?
- 2. Do you approve of empowering the Legislature to impose an estate tax equal to such credit as may be allowed by Federal Estate Legislation?
- 3. Do you approve of giving the Governor the right to disapprove or reduce items or parts of items in any legislative bill appropriating money?
- 4. Do you approve of giving the General Court power to exempt from any income tax so much income as they deem just, provided that no tax upon income shall be assessed at a rate greater than the average rate of taxation?
- 5. Do you approve of electing members of the House of Representatives for the first six Hundred inhabitants of any town, ward or place, and an additional representative for each additional fifteen hundred inhabitants, provided that a town, ward or place having less than six hundred inhabitants may elect a representative a proportionate part of the time, but not less than once in ten years?

TOWN WARRANT For Annual Meeting, March 10, 1931

(L. S.) STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Hampton, in the county of Rockingham, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Town of Hampton on Tuesday, the Tenth day of March next, at Ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes and three Auditors.

Article 2. To choose all other necessary officers for the ensuing year.

Article 3. To raise and appropriate such sums of money as may be necessary for Town Officers' salaries and expenses, election and registration, municipal court, care and supplies for town hall, police department, fire department, moth department, health department, highways and bridges, street lighting, library, town poor, Memorial Day, parks and playgrounds, cemetery, sewer department, sidewalks, comfort station, breakwater, town notes, Hampton Beach and all other necessary charges arising within the Town.

Article 4. To see if the town will vote to give the selectmen power to borrow money in anticipation of taxes.

Article 5. To choose a wire inspector and a building inspector for the ensuing year, whose reports shall appear in the annual town report.

Article 6. To see if the town will vote to reduce the building permit fee from Ten Dollars to One Dollar.

- Article 7. To see if the town will vote to revise the building code and wiring rules, and to combine them in one set of ordinances, and to appoint a committee for the same.
- Article 8. To see if the town will vote to require a permit for electricians, and charge a fee of Twenty-Five Dollars; this fee to revert to the town.
- Article 9. To see if the town will vote to raise and appropriate the sum of Five Hundred Dollars to be expended for lighting the tennis courts at Tuck Memorial Field.
- Article 10. Upon a petition signed by Mathew A. Cregg and twenty-six others to see if the town will vote to raise and appropriate money to build a wooden approach from the main Boulevard to the water's edge to take the place of the concrete approach that was destroyed.
- Article 11. Upon a petition signed by E. D. Spinney and fifty others requesting the selectmen to install a fire hydrant at Five Corners for the protection of the community. This to be installed as soon as possible. To see what action will be taken.
- Article 12. To see if the town will vote to raise and appropriate \$250.00 to illuminate the town clock on four sides.
- Article 13. To see if the town will vote to give the selectmen power to provide a skating rink 200 ft. by 75 ft., by having four inchs of loam scraped off, of the above size, on the east side of the park.
- Article 14. Upon a petition signed by Edgar Warren and Ten others requesting the following article to appear in the town warrant for the annual meeting in March:

To see if the Town will vote to raise and appropriate the sum of Two Hundred and Fifty Dollars for the purpose of installing a fire alarm box at or near the junction of the Little River and the Black Swamp roads in the town of Hampton.

Article 15. To see if the town will vote to raise and appropriate the sum of Ten Thousand Dollars for a breakwater at North Beach, this amount to be raised as follows: Five Thousand Dollars this year and Five Thousand in the year 1932.

The above article to be contingent on the passing of a bill now being introduced in the State Legislature, which calls for a like appropriation of Ten Thousand Dollars to be spent by the State for this purpose.

Article 16. A petition signed by Mrs. Sarah Ash and forty-one others respectfully requests that steps be taken to grade and otherwise improve Island Path. The petitioners are anxious that proper action shall be taken at this meeting to the end that their request may be granted.

Article 17. To see if the town will authorize the selectmen to recommend to the State Forester a person to act as tree warden.

Article 18. To see if the town will vote to accept as a public highway, by warrantee deed from the Hampton Associates, Inc., that tract of land which forms an extension of Dearborn avenue to Ann's Lane.

Article 19. To see if the town will vote to raise and appropriate the sum of \$15,000.00 for the purpose of constructing a building at Hampton Center to be used as a fire station and for the storage of highway equipment.

Article 20. To see if the town will vote to authorize the selectmen to sell the following property which the town owns under tax deeds. Property of Corrine Bigley contains one acre of Collins Lot No. 181 Sheet I. ½ acre of Brown Common.

Property of Charles Taylor contains 4 acres of spring marsh. Property of William Parsons ½ acre Home Place and Buildings. Property of George Felch Jr. ½ acre tenement and store, 3 cottages, one house lot.

- Article 21. To see if the town will vote to authorize the Selectmen to take action, according to the terms of leases, against certain or all lease holders, leasing land from the town of Hampton, who have not paid their ground rent or taxes or both.
- Article 22. To see if the town will vote to raise and appropriate the sum of \$500.00 to extend the drain from Charles H. Brown's to the residence of Adna D. Garland.
- Article 23. (Section A). To see if the town of Hampton will vote to create a Parks and Playgrounds Commission which shall have charge of all matter pertaining to the Parks and Playgrounds of the Town of Hampton.

(Section B). This commission shall be composed of three members, one of whom shall be elected at each annual Town Meeting for a period of three years.

(Section C.) The first commission shall be elected from the floor and their terms of office shall be one, two, and three years respectively.

Article 24. To transact any other business that may legally come before said meeting.

Special activities during the year:

January

I took several suspicious underweight children to the T. B. and Underweight Clinic at Exeter, N. H. The Clinic was held under the direction of Dr. Kerr.

May

May 1st was observed as National Child Health Day in the schools. Health songs, conundrums, games and discussions pertaining to health were the feature of the day.

June

June 4th was the dedication of the Tuck Memorial Athletic Field. I observed that date by entering a float to represent the Hampton Health Department. I also had my class in Home Hygiene and Care of the Sick, dress in Red Cross costumes and carry the American Flag as well as the Red Cross Banner. June 12th I had a vaccination Clinic at the Centre School. We had fifteen applications for vaccination. June 28th, assisted by Miss Eunice Hardy of the State Dept. of Infancy, Maternity and Child Hygiene we put on a Child Health Conference.

September

I had simple exercises for the presentation of the Red Cross Certificates of the three classes that I taught last Spring.

Dr. Fernald did the annual examination of the children as usual during September and October.

October

I attended the Institute for the school Nurses at Concord, N. H. I found this very interesting as well as beneficial. There were many points brought up that I have used a great deal in my work here.

November

J,

Dr. G. Arthur Danforth of Manchester came to us and started our dental clinic which is still going on. During the year I have given several talks in the clubs and lodges around town.

Mr. Roy W. Gillmore, Superintendent of Schools, Hampton, N. H.

Each morning we served the undernourished, and any others that desired it, milk and cookies. This has done a great deal to increase the weight of those who were below normal. There has been a noon lunch served during the winter months under the direction of Miss Eleanor Janvrin. This has also helped to build up many little bodies that otherwise would have had to eat a cold lunch.

I wish that we might have a little more cooperation in carrying out our vaccination law. It seems to be something that most people dread. I will say that it is merely a safe-guard for the prevention of small pox. The state law requires that all children shall be vaccinated unless excused because of physical reasons. I hope that we will have the cooperation of every parent in this matter so that we may have a hundred percent when schools open in September.

This has been a very eventful year, and in spite of the many changes I will say that it has been a very interesting one. The few months that I was under the supervision of the Hampton Red Cross were very pleasant and I miss the contact very much, although the place was very ably filled with our Health Officer, Mr. William Brown. I have found both him and the other officers of the Town of Hampton very co-operative, loyal and willing to assist me at all times in any trouble that might arise.

I wish to take this opportunity to thank everyone who has assisted me in my work here and in looking forward to another year I hope that the residents of Hampton will realize that I am here to be of service to each and every one of them.
