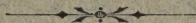

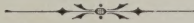

REPORT

—OF THE—

COUNTY CONVENTION.

DOVER, N. H., Oct. 30, 1889.

The Strafford County delegation met in convention Oct. 30, 1889, at Walker's Hall, Dover, N. H., in response to the call of the County Commissioners which was as follows :

To the Members of the County Convention of Strafford County,
N. H.

By virtue of authority in us, the County Commissioners of said County, under the provisions of the General Laws of New Hampshire, Chapter 23, Sec. 12, you are hereby notified that there will be a meeting of said County Commissioners on Wednesday, Oct. 30, 1889, at 11 o'clock in the forenoon at Walker's Hall, Dover, N. H., for the purpose of taking action by said Convention relative to the funding of the County debt.

The meeting was called to order by the Chairman.

The Clerk read the call for the meeting.

The roll was called by the Clerk and the following members were present, being all the members of the Convention :

Mr. Demeritt, County Commissioner, made some remarks in relation to the condition of County affairs.

Mr. Welch of Dover asked for a statement from Mr. Hough and ex-Treasurer Cartland in regard to the best way of disposing of the County debt.

Mr. Hough and Mr. Cartland each addressed the Convention.

Mr. Seavey of Somersworth, asked if the County Commissioners were not already authorized, by a previous vote of the Convention, to issue bonds to the amount of forty-one thousand dollars on account of the new court house.

The County Solicitor read the resolutions previously passed by the County Convention authorizing the Commissioners to raise the forty-one thousand dollars for the erection of a court house by bonds, notes or other obligations.

On motion of Mr. Ritchie of Somersworth voted a recess until 2 o'clock P. M.

Convention met at 2 P. M.

The Convention called to order by the Chairman.

Mr. Steele, Mr. Welch and others of the Convention made remarks.

Mr. Torr moved that the Convention take a recess until Thursday at 2 P. M.

Mr. Bennett amended the motion by making it 11 o'clock A. M.

The motion as amended adopted.

DOVER, N. H., Oct. 31, 1889.

The Convention met at 11 o'clock.

The Chairman called the meeting to order.

Mr. Welch of Dover offered the following resolution :

Resolved, by the County Convention of the County of Strafford, That the County Commissioners be and they are hereby authorized and instructed to raise the sum of fifty-nine thousand dollars upon the credit of said County for the purpose of funding its notes outstanding, by the issue of its bonds at a rate

of interest not exceeding 4 per cent. per annum, interest payable semi-annually, said bonds to be dated December 2, 1889, and payable as follows :

Mr. Seavey of Somersworth motioned to amend the resolution of Mr. Welch as follows :

Voted that the County Commissioners are hereby authorized to bond thirty-four thousand dollars (34,000) of the County debt, together with the forty-one thousand dollars (41,000) previously voted for the new court house, so that the entire issue of new bonds shall be seventy-five thousand dollars (75,000) and at a rate of interest not exceeding 4 per cent. per annum, and payable as follows semi-annually.

The motion as amended was accepted and adopted, six members voting in the negative and sixteen in the affirmative. On motion of Mr. Ritchie voted to adjourn.

REPORT

OF THE

COUNTY COMMISSIONERS.

The Commissioners of the County of Strafford hereby submit their annual report for the year ending April 30, 1890, together with the reports of the Superintendent of the County Farm, Chaplain, Sheriff, Physician, Jailer, Solicitor, Treasurer, Auditors and Clerk of Supreme Court.

FINANCIAL CONDITION OF THE COUNTY.

The County delegation voted to issue 4 per cent. bonds to the amount of seventy-five thousand dollars (75,000), forty-one thousand (41,000) to build new court house and thirty-four thousand dollars (34,000) for floating debt; the bonds were sold for \$77,141 67.

We have paid ten thousand dollars (10,000) four per cent. bonds due December 1, 1889. See Treasurer's report for more detailed information.

NEW COURT HOUSE.

The new court house is practically completed, the interior arrangement of which is very convenient. The material used in the construction of the interior of the building and the workmanship, is first-class; the amount expended to date is \$34,678 79.

PAUPERS OFF THE FARM.

There has been an increase in the support of this depart-

ment of \$8,131.04, mostly on account of the workings of the Soldier Aid law.

COUNTY FARM AND ALMSHOUSE.

The institution has remained under the superintendence of Mr. and Mrs. Stiles, this being their third year which is a guarantee that their services have been acceptable to the Commissioners and, we think, to the public. The improvements made the last year are the laying of a new cellar wall, building brick piers, and putting in new sills under the main barn; the buildings have been painted on the outside throughout; the total expense for these improvements has been one thousand dollars (1000.) CHAPLAIN'S REPORT.

The accustomed duties have been performed as in past years. Services have been held every Sunday afternoon except when omitted on account of the weather or some other necessary hindrance. I have visited the sick and the aged in the infirmaries and their rooms. I have officiated at the funerals of the Protestant dead who were buried at the Farm. At Christmas the usual festivities were held, the arrangements being perfected by a club of young ladies. Miss Sophy Lutolf and other ladies have assisted me in the music.

Patrick Farley died Apr. 12, 1890; the following extracts are from a notice that appeared in the DOVER REPUBLICAN at the time:

“He was a shrewd, honest, kindly hearted, faithful and good tempered man. He could not read nor write yet he made up for these deficiencies by a retentive memory, keen observation, and ready wit. He was a faithful member of the Roman Catholic church, attentive to his religious duties, loyal to his church and to his priest. He received the last ministrations of his church before he died. Recently the County Commissioners put him on regular wages and struck his name off the pauper list. “Pat” did not die a pauper nor ought he at any time to have been so considered, he was for many years as hard a working man as we have in the County; by his gratuitous services he saved the County many hundreds of dollars in all these years.”

PHYSICIAN'S REPORT.

TO THE HON. COMMISSIONERS OF STRAFFORD COUNTY :

During the past year there has been more sickness, perhaps, in the Institution than any preceding one. Apart from the usual number of constitutional diseases generally found in such an institution, we had to deal with pneumonia, diphtheria and la grippe. During the past year we had some fifteen cases of diphtheria ; cause unknown. In January la grippe made its appearance ; during its brief stay some forty inmates were affected, which, however, passed away without any serious result. Generally the health record of the institution is good. The sanitary condition of the almshouse is excellent. The asylum however needs extensive repairs and its sanitary condition could be much improved.

I would respectfully call the attention of the Commissioners to the absolute necessity of providing a separate building for all children over two years of age, until such time as it may be convenient for them to leave the institution ; at present their associations are morally unhealthy. Any extra expense would be more than repaid in the consciousness that justice had been done them and that the county, which is responsible for their moral and intellectual training, had done its duty.

I take this opportunity of expressing my thanks to the matron, Mrs. Stiles, for the able and efficient manner in which she has always been willing to assist in caring for the sick, and for her faithfulness in the execution of all orders left in her charge.
