



## TOWN MEETING WARRANT State of New Hampshire

To the inhabitants of the Town of Wentworth, in the County of Grafton, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Town Hall in said Wentworth, on Tuesday, the 10th day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary town officers for the ensuing year.
  - 2. To choose delegates to the National Convention.
- 3. To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations of the same.
- 4. Article B. To see if the Town will accept State Aid Construction of the Class II road known as North Dorchester Road, and raise and appropriate or set aside for said purpose the sum of \$790.50; or will accept State Aid for Construction of Class V roads and appropriate or set aside for said purpose the sum of \$483.85.
- 5. To see how much money the Town will vote to raise and appropriate for Town Highways and Bridges.
- 6. To see how much money the town will vote to raise and appropriate for snow removal.
- 7. To see how much money the Town will vote to raise and appropriate for street lights.
- 8. To see how much money the Town will vote to raise and appropriate for the support of the library.

- 9. To see how much money the Town will vote to raise and appropriate for the care of the fire engine.
- 10. To see if the Town will vote to raise and appropriate a sum of money for repairing town buildings.
- 11. To see if the Town will vote to authorize the Selectmen to sell either at public auction or private sale to such purchaser and for such price as they may determine any real estate acquired by the Town through Tax Collector's deeds, and until such sale is made to administer such property in the interests of the town.
- 12. To see how much money the Town will vote to raise and appropriate for support of town poor.
- 13. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes, if necessary.
- 14. To transact any other business that may legally come before said meeting.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

#### February 15, 1936

To the School Board and Citizens of the Wentworth School District:

I hereby submit my sixth annual report as Superintendent of Schools.

During the summer the village school was enlarged and remodeled to take care of the increased enrollment. The building originally a one room school has for a long time been inadequate and particularly so the last few years. The building was lengthened approximately 22 feet and now there are 2 rooms ample for 40 pupils each and 45 can be accommodated. There is plenty of wardrobe room for children to hang up their clothes and keep their lunch boxes. Heretofore they have left them in the cold front hall. The vestibule has been enlarged and additional toilets can be installed if necessary. A new heater was installed in the primary room and the rooms are very comfortable. It is the purpose of the Board to equip the building with electricity in the spring. The district received \$50 from the state on this project and will continue to do so each year as greater amounts will be approved for the larger and improved building. The Board found that in working on the original building a great deal of unanticipated repair work had to be done and it was reasonable to do this at this time, while working on the addition. Consequently approximately \$135 was expended on general repairs incident to the addition but not coming under the special appropriation. This was financed out of currents funds and no further appropriation is needed.

Ruth M. Douglas resigned her position at the Foster School January 31. Dorothy G. Veysey was

transferred from the Buffalo school to the Foster school and the children of the Buffalo school were placed in the village school until February 12, when the Foster school was destroyed by fire. The entire Foster school was then transported to the Buffalo school to finish out the year and 4 children there recently sent to the village placed again in the Buffalo school.

The above arrangement does not seem expedient for permanency. The distance is too far. The Board is advised that a substantial building will cost approximately \$3,000 which with the insurance would make a net investment of \$2,400. At present there is no assurance of federal aid but should an opportunity arise before summer it might be advisable to apply for same.

It might be advisable to move the Buffalo school to the Foster district which could probably be done at a considerably lower figure than the erection of a new building.

It is my recommendation throughout this supervisory union that the honor roll for perfect attendance be discontinued after the present year. Originally intended to increase attendance I am firmly convinced that, at the expense of health, it defeats its own ends. Children with hard colds, sore throats. etc. often forerunners of contagious diseases, expose the entire school to illness in their zeal to maintain perfect attendance. The state board of health says that when contagious diseases are prevalent such children should stay at home. These children often times should not be sent out in stormy weather, and there are probably times when small children, tired or nervous, may well be kept at home a day or two. The whole matter of school attendance is one of common sense. When children are well and able they

must attend, and when they are sick and ailing they should stay at home. The children on honor rolls would probably attend regularly anyway, and those of poor attendance are not motivated to attend any more regularly.
