## INTRODUCTION

### SELECTMEN'S REPORT

During 1983, all taxable property in the town of Sullivan was reappraised by appraisors of the State of New Hampshire Department of Revenue Administration. The new appraisal values reflect the true and full value of Sullivan property and have equalized the property tax burden among Sullivan taxpayers.

As identified in last year's report, a plan for upgrading present highway equipment has been developed through the cooperative efforts of the Budget Committee members, Selectmen, Road Agent and others. Sullivan voters will have the opportunity via the hearing process and town meeting, respectively, to express their views and act on the proposal.

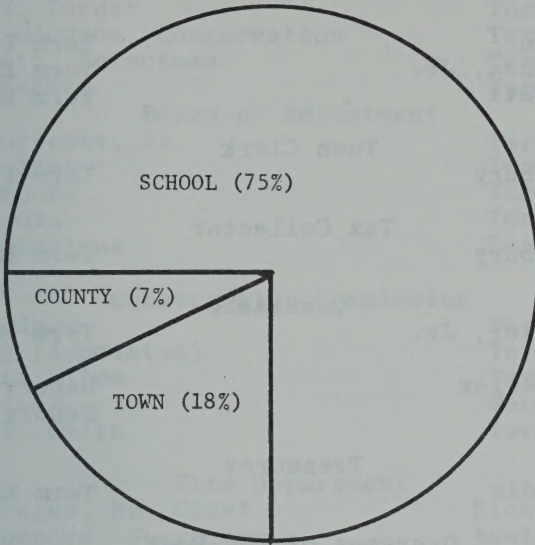
Improvements to town buildings during the year included adding insulation and an oil-fired heating system to the firestation, constructing a new chimney at the highway garage, and painting the exterior stage area of Community Hall. The planning committee for improving Community Hall has recommended the installation of a holding tank to replace the one-holer. The selectmen have accepted the recommendation, authorized design specifications, and are awaiting design approval from the New Hampshire Water Pollution & Supply Control.

Effective July 1, 1983, the New Hampshire Department of Public Works and Highways initiated a new block grant program. The block grant program consists of two parts: Apportionment A, which is a consolidation of former "TRA", "Highway Subsidy", and "Additional Highway Subsidy" programs; and Apportionment B, which is the former "Duncan Fund". For the first year under the block grant program, Sullivan is to receive slightly more in total dollars than under the former programs.

Within the guidelines provided by town meeting, a continuing effort is being made to seek the most value for the dollar expended. The town continues to participate in group purchasing of fuel supplies through the Southwestern New Hampshire Regional Planning Commission, and where alternatives exist in other areas of expense, the most cost-effective practical solution is sought.

Analysis of the 1983 Sullivan Tax rate shows the town portion of the tax burden to be 18% as shown in the following figure. With the school share at 75% and the county accounting for the remaining 7%, it should be evident that voter involvement is important in school, town, and county affairs.

Voted, by voice vote, to raise and appropriate the sum of \$38,231.50 to defray Town Charges for the ensuing year.

ARTICLE 4

Voted, by voice vote, to authorize the Selectmen to contract for computer services for the maintenance of its tax records as prescribed by RSA 8-C;11 and raised and appropriated the sum of \$600.00 for this purpose.

ARTICLE 5

Voted, by voice vote, to raise and appropriate the total sum of \$37,193.02 for the maintenance of highways and bridges and construction of the same for the ensuing year as follows:

\$23,392.11 to be raised by taxes  
 \$13,800.91 to be withdrawn from the Revenue Sharing Fund established under provisions of the State and Local Assistance Act of 1972.

ARTICLE 6

Voted, by voice vote, to accept and appropriate the sum of \$10,081.98 that being Highway Subsidy and Additional Highway Subsidy for the maintenance of highways and bridges and construction of the same for the ensuing year.

ARTICLE 7

Voted, by voice vote, to table Article 7 until later in the meeting.

ARTICLE 8

Voted, by voice vote, to raise and appropriate the sum of \$503.15 for Town Road Aid in order to receive the full State's share of \$3,354.37.

ARTICLE 9

Voted, by voice vote, to raise and appropriate the sum of \$2,500.00 for the operation of the Police Department and the purchase of maintenance of equipment for the Police Department.

#### ARTICLE 10

Voted, by voice vote, to accept the gift of a 1968 Cadillac Rescue Vehicle from the Town of Sound Beach, Long Island, New York and designated the vehicle for use by the Sullivan Fire Department.

#### ARTICLE 11

Voted, by voice vote, to raise and appropriate the sum of \$9,202.50 for the operation of the Fire Department for fire protection and purchase and maintenance of equipment and building for the Fire Department and/or other Fire Department expenses.

#### ARTICLE 12

Voted, by voice vote, to raise and appropriate the sum of \$4,339.00 to provide and maintain public library service and authorize the Library Trustees to receive and use supplemental funds as provided.

#### ARTICLE 13

Voted, by voice vote, to raise and appropriate the sum of \$700.00 for the care and maintenance of Town Cemeteries.

#### ARTICLE 14

Voted, by voice vote, to table Article 14, temporarily.

Voted, by voice vote, to return to Article 7.

#### ARTICLE 7

Voted, by voice vote, to amend - insert - Selectmen are not authorized to make withdrawals from the Capital Reserve Fund for Major Equipment Purchase for the Highway Department until the voters vote on it at next annual Town Meeting.

Voted, by voice vote, to establish a Capital Reserve Fund for Major Equipment Purchase for the Highway Department and place therein the sum of \$2,000.00 and designated the Selectmen as Agents of the Town authorized to make withdrawals from said fund to carry out the purpose for which it was established.

ARTICLE 14

Motion to amend: Raise and appropriate the sum of \$4,000.00 for the purpose of revaluation of the Town was defeated by voice vote.

Voted, by voice vote, to raise and appropriate the sum of \$4,000.00 for the purpose of revaluation of the Town to be added to the existing Capital Reserve Fund and designated the Selectmen as agents of the Town authorized to make withdrawals from said fund to carry out the purpose for which it was established.

ARTICLE 15

Voted, by voice vote, to amend Article 15, by dropping in the fourth line - therein the amount of \$2,500.00 and insert -Appropriation therein.

Voted, by voice vote, to raise and appropriate the sum of \$2,500.00 for capital improvements to the East Sullivan Community Hall and to establish a Capital Reserve Fund for the same and place the appropriation therein and designated the Selectmen as Agents of the Town authorized to make withdrawals from said fund to carry out the purpose for which it was established.

ARTICLE 16

Voted, by voice vote, not to pass over Article 16.

Voted, by voice, to discontinue, subject to gates and bars, the so-called Boulder Road beginning at the junction of Nurse Path and leading to Sullivan-Stoddard Town line.

ARTICLE 17

Voted, by voice vote, to discontinue the so-called "Bingham Road" beginning at the junction of the same and Gilsum Road leading west to the beginning of the formerly discontinued portion of said "Bingham Road".

ARTICLE 18

Voice vote in question. Show of hands  
In favor 48  
Opposed 26

Voted by a show of hand, to discontinue the so-called "Old Ellis Mill Road", subject to gates and bars, beginning at the junction of Ellis Road and Old Ellis Mill Road leading to the West side of the Otter River

and to include that section of the so-called "Warren Road" from the Nowill place (#115) to the Old Ellis Mill Road.

#### ARTICLE 19

Voted, by voice vote, to accept the following Cemetery Trust Funds:

#### ARTICLE 20

Voted, by voice vote to amend to read - Esther Winch Town Forest.

Voted, by voice, to establish the Winch Trust Woodlot as a Town Forest under RSA 31:110-114 thereby making the Town eligible to receive assistance from the Division of Forests and Lands of the New Hampshire Department of Resources and Economic Development for the preparation of a forest management program consistent with the original provisions of the Winch Trust.

#### ARTICLE 21

Voted, by voice vote, to authorize the Selectmen to appoint the Trustees of Trust Funds to serve as the Forestry Committee to be responsible for the management of the Esther Winch Town Forest.

#### ARTICLE 22

Voted, by voice vote, to go on record in support of immediate actions by the Federal Government to control and reduce acid rain which is harmful to the environment and economy of Sullivan and to the health and welfare of the people of Sullivan. These actions shall include:

1. Reduce by at least half the major cause of acid rain, sulfur dioxide emissions, by the year 1990.
2. Conclude negotiations and adopt a treaty with the government of Canada that will commit both nations to this same goal.

#### ARTICLE 23

Voted, by voice vote, to authorize the Selectmen to sell and convey any real estate acquired by the Town during the period until the next Town Meeting and that the Selectmen be authorized to sell and convey such real estate by auction, sealed bid, or in any manner as justice may require.

ARTICLE 24

Voted, by voice vote, to authorize the Selectmen to apply for and to accept, on behalf of the Town, and to expend any and all gifts, grants or other funds which may now or hereafter be forthcoming over and above the total appropriations voted by the Town.

ARTICLE 25

Voted, by voice vote, to authorize the Selectmen to borrow money in anticipation of taxes.

ARTICLE 26

Voted, by voice vote, to accept the reports of the Agents, Auditor and Committees as printed in the Town Report.

ARTICLE 27

A standing ovation was given to Becky B. Cummings in appreciation for her service to the Town during the past three years, as Selectman.

21. To vote to accept the reports of the Agents, Auditor and Committees as printed in the Town Report.

22. To transact any other business which may legally come before this meeting and to listen to opinions of a purely advisory nature in regard to the conduct of Town affairs for the ensuing year.

## **NOTICE TO PROPERTY OWNERS**

A new law effective April 1, 1978 imposes a penalty for failure to file a fully completed inventory form.

"RSA 74:7-a Penalty for Failure to File. Any person who fails to file a fully completed inventory form on or before April 15, unless granted an extension under RSA 74:8, shall pay a penalty of one percent of the property tax for which he is liable. In no case, however, shall the penalty be less than \$10 or more than \$50. Any person who fails to file an inventory form and who becomes liable to pay the penalty specified in this section shall lose his right to appeal any matter pertaining to the property tax for which he is liable or exemptions to which he may be entitled. This penalty has all the force of taxation and shall be treated as incident to the tax."

Inventory blanks are mailed before March 25 as required under RSA 74:5, but if for any reason you fail to receive one, you should contact the Selectmen to obtain one and complete it as required above.

The Town of Sullivan still requires the use of inventory forms. Current Use, Veteran, and Elderly Exemptions must be applied for annually on the reverse of the inventory.

## REPORT OF THE PLANNING BOARD

The rate of land subdivision slowed in 1983, there being only one subdivision application considered by the Planning Board. Mr. Briscoe asked to subdivide one lot on the Gilsum Road making three separate lots. This was approved.

In the 1983 session of the General Court, all New Hampshire planning law was rewritten. While the actual changes made were minor, a complete review of all Town ordinances relating to planning and zoning will be needed and the local laws updated to conform to the new law before January 1, 1986. This will occupy the attention of the Planning Board during 1984.

Our Chairman, Neil Henry resigned in December because his work now takes him out of town during the week. The Town should be grateful for his patient, conscientious leadership during the past two years. The Board will miss Neil Henry.

## SULLIVAN PUBLIC LIBRARY REPORT

It is encouraging to find that the number of books loaned, requests received and interest in the Sullivan Public Library steadily increases each year.

The circulation for 1983 was 5,060. Adult fiction loaned - 1,411 books; adult non-fiction loaned 887 books; and juvenile fiction and non-fiction loaned 2,496 books. There were 44 special request loans made from the N.H. State Library.

We average 200 patrons per month (50 per week) during the eight weekly hours that the library is open. Attendance at our monthly evening programs averages 26 people for slide shows and topics that have included Managing Your Woodlands, trips to Alaska, Iceland, the Eskimos in the Canadian Sub-arctic, Around the World in 80 Days, Herbs for the Holidays, and the Sullivan Archeological Dig.

Our money raising projects this year have included the sale of discarded books, Sullivan cookbooks, Holiday Craft Bazaar, Sullivan maps, notepaper, historic booklets, and town histories.

The N.H. State Library Bookmobile has been discontinued which is a great loss to small public libraries such as ours. They supplied us with well over 600 books per year which were exchanged every six months. This is one reason why our budget for 1984 has increased slightly, the first time in several years.

Five hundred and seven books were added to our shelves this year: 331 were new and the remainder were books donated by townspeople and out-of-town friends. We are most appreciative of donations of any kind and hope they will continue.

A project being considered for 1984 by the library trustees is the addition of new bookshelves.

#### SULLIVAN FIRE DEPARTMENT

Sullivan Fire Department had a fairly quiet year this year with only five calls. There were:

- 1 Chimney Fire; 2 Vehicle Fires;
- 1 Brush Fire; 1 Structure Fire

The Department would like to commend the people in town for their attentiveness regarding safe wood stove procedures. Your carefulness shows in the fact that there was only one chimney fire all year. Due to the quick response of Sullivan and several area towns the one brush fire we had on Route 9 was contained to only one half acre. This is keeping with the State of New Hampshire average of only one half acre per burn.

We are sorry to say that the one house fire we had was a total loss due to the remote location of the building. Without the services of Mr. Strickland in the Pitcher Mtn Fire Tower the fire could have spread to the surrounding woods doing much more damage.

We are pleased to report through the hard work and dedication of the officers in the department we were able to receive a \$500.00 grant from the State of New Hampshire. This was used to purchase some much needed forestry equipment. We hope with this new equipment and the re-outfitting of our brush vehicle (M4) we will be able to better handle all forest fires.

The fire department still offers chimney cleaning for donations and we hope that the townspeople will continue to take advantage of this service.

We would like to thank all the townspeople for their generous donations and hope that we have a safe and quiet 1984.

## SULLIVAN RESCUE SQUAD

## ROAD AGENT'S REPORT

In addition to regular annual maintenance (plowing, patching, ditch cleaning, etc.), the following improvement projects were completed on Sullivan Class V roads during 1983:

1. brush cutting/roadside mowing - all roads
2. graveling/grading (approximate footage)
  - Ferry Brook Road - 5280 ft
  - Price Road - 1640 ft
3. oil sealing (approximate footage)
  - Hubbard Road - 4780 ft
  - Gilsum Road - 863 ft
  - South Road - 3350 ft
4. road shimming (approximate footage)
  - Apple Hill Road - 870 ft
  - Gilsum Road - 1560 ft
  - South Road - 1190 ft

With limitations on resources ( money and equipment) the present effort is to make lasting improvements to road areas most in need of repair. Identified as in need of improvement and where future effort should be placed are the two bridges on Old Concord Road and selected areas on the Valley Road.

Up until August, no major repairs to highway equipment were required; however, since then the following repairs have been necessary: frame repair to International 1800, block replacement in the Trojan loader, clutch repair in the Dodge 3/4 ton. As in prior years, major repairs have used up "repair appropriations" and resulted in a fair amount of vehicle "out of service" time.

During the summer months, the Highway Department participated in Southwest Employment Training Program. Under this program the Town received 192 hours of labor at no cost while a Sullivan youth benefitted from Summer employment.

In an effort to make the Highway crew's functioning easier, residents are requested to keep the right-of-way for Town roads free and clear of parked vehicles or other objects.
