The State of New Hampshire

L. S. Town Warrant

To the Inhabitants of the Town of Enfield qualified to vote in town affairs:—

You are hereby notified to meet at Whitney Hall in said town of Enfield on the TWELFTH day of MARCH next at NINE of the clock in the FORENOON of said day to act on the following subjects:

Art. 1 To choose by ballot and major vote, a Town Clerk, one Selectman for three years, a Treasurer, Overseer of the Poor, one Library Trustee for three years and one, or more, highway agents: and a Tax Collector.

2. To choose by ballot one Trustee for three years for the purpose of holding all trust funds of the town.

3. To choose by major vote, surveyors of lumber, fence viewers, constables, measurers of wood and bark, weighers of hay and straw, cemetery agents and such other officers and agents as the town may judge necessary to be chosen

4. To see what action the town will take in regard to the compensation of the collector of taxes, and the limitation of time of settlement with the town.

5. To see what action, if any, the town will take in regard to giving a discount on taxes.

6. To see if the town will vote to raise such sums of money as may be necessary to defray town charges, including maintenance of the poor, salaries and expenses of the town officers, expenses of Municipal Court, health department, forest fire department, cemeteries, driving hearse

7. To see what action the town will take with regard to the election of a police officer, or police officers.

8. To see if the town will raise One Hundred dollars for the eradication of blister rust.

9. To see if the town will vote to authorize the Selectmen to purchase the Silent Policeman, or Beacon, now in Market Square, so-called, and raise or appropriate Two Hundred Ninty dollars to pay for the same

10. To see if the town will vote to authorize the Selectmen to borrow such sum, or sums, of money as they shall deem necessary in anticipation of taxes and the sums so borrowed to be paid during the ensuing year.

11. To see how much money the town will vote to raise for the support of highways for the ensuing year.

12. To see how much money the town will vote to raise for the repair of bridges, including Shaker Bridge, for the ensuing year.

13. To see how much money the town will vote to raise for the repair of sidewalks for the ensuing year.

14. To see how much money the town will vote to raise for the support of the Public Library

15. To see if the town will take any action with regard to the delivery of blank inventories.

16. To see how much the town will vote to raise to grade the road from Ernest Bailey's to Harry Bailey's mill through Enfield Center and including the road at the head of the lake, or take any action thereon

17. To see if the town will vote to raise \$2,700 00 to pay on the town debt, or act thereon.

18. To see how much money the town will vote to raise to pay interest on the town debt, or act thereon.

19. To see if the town will vote to raise \$2,000 00 for street lights for the ensuing year, or act thereon.

20. To see if the town will vote to raise \$50 00 for the proper observance of Memorial Day in addition to the amount already raised by vote of the town as a perpetual fund, or act thereon.

21. To see if the town will vote to raise \$2,769 00 for State Aid Construction, or act thereon.

22. To see if the town will vote to raise \$3,000 00 for State Aid Maintenance, or act thereon.

23. To see if the town will vote to raise \$5,000 00 for Trunk Line Maintenance.

24. To see how much money the town will vote to raise for snow removal to be expended under the supervision of the Selectmen, or act thereon.

25. To see how much money the town will vote to raise, if any, to be expended in cutting bushes.

26. Pursuant to a petition of ten legal voters: To see if the town will vote to raise, or appropriate, a sum not exceeding One Thousand dollars to pay its Selectmen for the ensuing year, which said sum shall be in full payment for all services rendered by said Board of Selectmen and to be apportioned among the Board as said Board may determine, or act thereon.

27. Pursuant to a petition of ten legal voters:
To see if the town will vote to abolish the Enfield
Municipal Court, or act thereon

28. Pursuant to a petition of 10 legal voters:
To see if the town will vote to raise, or appropriate, a
sum not exceeding Two Hundred dollars to pay a po-
lice officer, or police officers, whether said officer, or
officers shall be elected or appointed, and out of which
fund full payment shall be made for all services rend-
ered, except that such officer, or officers, shall be en-
titled in addition thereto the legal fees as provided by
law.

29. Pursuant to a petition of ten legal voters to
see if the town will vote to extend the street lights from
Mrs. D. H. Harvey to George Hill Corner and raise
money for the same.

30. To hear the reports of Agents Auditors,
Committees, or other officers heretofore chosen and pass
any vote relating thereto.

31. To transact any other business that may
legally come before said meeting.


