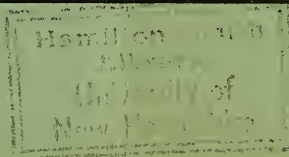

## STATE OF NEW HAMPSHIRE

---

To the inhabitants of the Town of Colebrook, in the County of Coos, in the State of New Hampshire, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Town of Colebrook, on Tuesday, the 14th day of March next, at 10 o'clock in the forenoon to act upon the following subjects:

1. To choose by ballot and major vote a Town Clerk for the year next ensuing.
2. To choose by ballot and major vote one Selectman for the next three years ensuing.
3. To choose by ballot and major vote a Trustee of Trust Funds for the three years next ensuing.
4. To choose by ballot and major vote a Library Trustee for the three years next ensuing.
5. To choose by ballot and major vote one or more Highway Agents for the year next ensuing.
6. To choose by ballot and major vote a Tax Collector for the year next ensuing.
7. To choose by ballot and major vote one or more Auditors for the year next ensuing.
8. To see if the Town will instruct its Selectmen to appoint all other Town Officers as required by law.

9. To see if the Town will vote to approve Town Charges as shown by the Budget and raise money for the payment of same.
10. To raise such sums of money as may be necessary for the support of the Poor.
11. To raise such sums of money as may be necessary for the support of the Town Library.
12. To raise such sums of money as may be necessary for the construction of Highways and Bridges:
  - (a) To see what sums of money the town will raise and appropriate for summer and winter maintenance of Town Roads.
  - (b) To see if the Town will raise the sum of \$354.77 for Town Road Aid, in which event the State will contribute the sum of \$1,419.07.
  - (c) To see what sum of money the Town will raise and appropriate for the purchase of snow fence.
13. To see what sums of money will be raised for
  - (a) Sewer Maintenance
  - (b) New Construction
14. To raise such sums of money as may be necessary for the observance of Memorial and Armistice Days and the care of monument lots.
15. To raise such sums of money as may be necessary for the care of Cemeteries.
16. To see what sum of money the Town will vote to raise towards the maintenance of a free skating rink.
17. To see what sum of money the Town will vote to raise for tarring streets.
18. To see what sums of money the Town will vote to raise for the construction and repair of sidewalks.


19. To raise such sums of money as may be necessary for Police.
20. To see what sums of money the Town will raise and appropriate for Civilian Defense.
21. To see if the Town will vote to authorize the Selectmen to appoint a Town Historian whose duties will be to keep complete and accurate records of all members of the Armed Forces of World War 2, serving from Colebrook, and to raise money for that purpose.
22. To raise and appropriate to the White Mountains Region Association for its program of advertising, etc., as a part of the cooperative investment by regional towns, an amount equal to 10 cents per \$1,000 of the assessed valuation of the Town for 1943.
23. To see if the Town will vote to give free use of Town Hall to Public Schools in said Town, for school purposes, including heat, light, and janitor service, whenever such use does not conflict with the best interests of the Town, for the year next ensuing.
24. To see if the Town will vote to authorize its Selectmen to borrow money to defray the expenses of the Town in anticipation of taxes, for the year next ensuing.
25. To see if the Town will vote to authorize its Selectmen to sell at public auction, any real estate acquired by the Town through Tax Collector's Deeds, and until such sale is made to administer such property in the interests of the Town.
26. To see if the Town will vote to accept, ratify and confirm the reports of Agents, Selectmen, Auditors, Committees and all other Town Officers as contained in the annual report of said Town for the year January 31, 1944, A. D.

27. To transact any other business which may legally come before this meeting.
