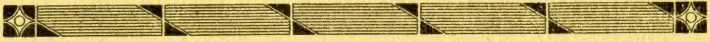

## THE STATE OF NEW HAMPSHIRE

---

To the Inhabitants of the Town of Wilmot in the County of Merrimack, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Wilmot on Tuesday, the 13th day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To see how much money the Town will vote to raise and appropriate for the maintenance of Town Highways.

4. To see if the Town will vote to accept State Aid Construction on the Fourth New Hampshire Turnpike, and raise and appropriate \$504.00 for this purpose.

5. To see if the Town will vote to accept State Aid Construction on the road leading from Wilmot Flat to the Fourth New Hampshire Turnpike and raise and appropriate the money necessary for this purpose. (Requested.)

6. To see if the Town will vote to raise and appropriate \$100.00 for the purpose of continuing the widening of the road between the residence of Walter H. Morgan and the cottage of Daniel M. Cleveland. (Requested.)

7. To see if the Town will vote to raise and appropriate any money for Old Home Day.

8. To see if the Town will vote to raise and appropriate any money for Memorial Day purposes.

9. To see if the Town will vote to raise and appropriate \$1,000.00 to pay on the Tractor and Snow Plow note.

10. To see if the Town will vote to authorize the selectmen to borrow money in anticipation of taxes, and to negotiate the extension or renewal of the notes securing such loans when this is necessary.

11. To see if the Town will vote to authorize the selectmen to administer or dispose of any real estate acquired by the town through tax collector's deeds.

12. To see if the Town will vote to elect the Highway Agents by districts, to be candidate for and elected as Highway Agents for their respective districts only.

13. To see whether beer or other lawful alcoholic beverages shall be manufactured or sold locally as permitted by Chapter 99 of the Laws of 1933.

14. To transact any other business that may legally come before said meeting.
