TOWN WARRANT

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To see if the Town will vote to allow a discount on property taxes paid on or before the first Saturday of July next.

4. To see how much mony the Town will vote to raise and appropriate for both fire companies.

5. To see if the Town will vote to authorize the Selectmen to buy liability insurance on town labor and pay for same out of the highway department.

6. To see if the Town will vote to accept State construction or State aid on class 5 maintenance and raise money for same.

7. To see if the Town will vote to raise and appropriate the sum of \$58.00 to the Lake Region Association of New Hampshire for the issuance and distribution of printed matter calling attention to the resources and natural advantages of the Town in co-operation with other towns in the Lake Region. (By Request).

8. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of Taxes.

9. To see how much money, if any, the Town will vote to raise and appropriate for White Pine Blister Rust Control. (By Request.)

10. To see if the Town will authorize the Selectmen to pay for a new furnace or any repairs on the old one that may be necessary; also to pay for a new motor or any necessury repairs on the pump, or water system, of the Foss Public Library and make an appropriation for the same. (By Request.)

11. To see if the Town will vote to raise and appropriate the sum of \$200.00, more or less, for Huggins Hospital. (By Request).

12. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Municipal accounting division and to make an appropriation to cover the expense of such audit. (By Request).

13. To see if the Town will vote to have two Road Agents instead of one. (By Request).

14. To see of the Town will appropriate the sum of \$200.00 for July and August maintenance of White Oak Road and Narrows Road in vicinity of Suncook Ponds. (By Request).

15. To transact any other business which may legally come before said meeting.

в Administrative Problems

At the last session of the New Hampshire legislature a law was passed making it compulsory upon school districts after September 1, 1939 to "provide educational facilities for handicapped children". In order to comply with the law in this respect Pittsfield and Wolfeboro are each furnishing transportation to school for one child living less than two miles from school who is unable to walk to school because of a seriously weakened heart. Barnstead is transporting one child who has suffered from a very weak heart from birth and who is able to attend school during the forenoon session only. New Durham is paying a teacher to visit the home of one child to furnish instruction to him for two hours per week until such time as he is able to attend school. It is expected that in the state aided districts. Pittsfield, Barnstead, and New Durham, the state aid will be adjusted to take care of the necessary expense.

Whenever schools have been closed for a day because of bad weather it has always been impossible to get word to all pupils by the usual means of whistles, bells and telephone, and it still is but this year a plan has been adopted to help with the problem. No-school announcements for Pittsfield, Wolfeboro, and Alton are now given also over radio station WHEB at Portsmouth, N. H., at intervals from 7:15 to 8 A.M. and without expense to the districts.

PART II. EDUCATIONAL POLICY

"The bulwark of a democracy is education." The happiness of the individual members of a democracy is based upon understanding. The success of a democracy is dependent upon the understanding each member has of the objectives and the workings of that democracy. At no point in a democracy is ignorance or lack of understanding beneficial to either the individual or to the whole group. Freedom to learn the accumulated knowledge of the human race is the inalienable right of every eitizen of a democracy. The children of America must learn how to search out the truth. The school must do its part in giving them this ability. It is the objective of every school in this supervisory union to make it possible for every child in attendance to share to the limits of his capacity the blessings derived from an understanding of all the facts discovered and known by the countless generations of man.

The preparation of the budget for 1940-41 has been a very difficult task and the result of the best efforts is still filled with many uncertainties. The chief difficulties center around the problem of predicting the amount of aid received each year from the state. The policy of the State Board of Education has been to approve of two teachers for a school if the enrollment keeps above 35 pupils, and if the school has been receiving approval on two teachers and if the enrollment does not drop below 30 pupils aid will continue. When aid has once been discontinued on one of the two teachers because of the enrollment going below 30. it will not be given again on the second teacher as long as the enrollment stays below 35.

As has been stated in previous reports, aid on two teachers at the Parade was discontinued a few years ago but due to the fact that the maximum capacity of the larger room is only 28 it has been thought advisable to continue with two teachers. At the Center the enrollment has been well above 35 ever since the building was remodeled into a two-room building in 1929, until this fall when only 33 pupils were in attendance at the opening of school and only 29 after the two Swain and the two Haves children moved away. At the time the budget was prepared in January it seemed very doubtful if the enrollment in this school would be any greater next year than at present so it was thought advisable to plan on having only one teacher, as either room is large enough to accommodate 30 pupils with reasonable satisfaction. Therefore, the budget was planned on the basis of the operation of both rooms at the Parade, one room at the Center, and the three other schools. Other plans might appear to a majority of the voters as more desirable. The following have been considered: (1) saving still more than with the adopted plan by moving a partition at the Parade to make one room large enough to accommodate 35 pupils, and discontinuing the other room so that five one-room schools would care for all pupils in the district; (2) closing the Shackford's Corner school, transporting those pupils to the Center and continuing the two teachers there; (3) closing all three of the one-room schools and transporting all pupils to the two two-room schools at the Parade and Center; and (4) closing the Shackford's Corner and Beauty Hill schools and continuing the Parade, Center, and South as they now are.

PART V. SCHOOL PLANT

During the past summer the necessary shingling and painting was done at South and Shackford's Corner, and in the latter building electric lights were installed last December. No other major repairs have been made since the last report.

Before school opens next fall, it is imperative that the brick chimney at the Parade school be rebuilt from the ground up.

Other repairs that should receive attention are (1) the painting of the ceilings, or ceiling if only one room is used next year, at the Parade school and (2) the painting of the wood trim in the elassrooms, or elassroom if only one is used, at the Center.All three of these items can be taken care of at small expense.

PART VI. CHILD ACCOUNTING AND STATISTICS

A. Promotions to High School

All of these pupils entered a secondary school last fall.

B. High School Pupils

Forty-one tuition pupils, as compared with thirty-eight last year and thirty-three the year before, were enrolled in secondary schools last fall as follows:

Alton High School: Shirley Prescott, grade ten; Joseph Hillsgrove and Charlotte Marsal, grade eleven; and Virginia Prescott, grade twelve. Pittsfield High School: Marjorie Atwell, Robert Bunker, Marguerite Davis, James Eastman, Ruth Golden, Lillian Haynes, Reihold Knirsch, Shirley MacPherson, William Powers, Leonard Smith, Richard Stock, Etta Swain, Phyllis Wheet, Elthan Whittier, and Ronello Whittier in grade nine. Ernest Davis, Robert French, Marion Gray, Lorraine Hanson, Lincoln Heywood, Virginia Kidder, Ralph Kristoferson, Shirley Otis, and Gertrude Swain in grade ten. Beatrice Gray, Mildred MacPherson, Betty Pitman, Arthur Stock, John Varney, and Ada Wakefield in grade eleven. Roland Bunker, Dorothy Gray, Vilma Knirsch, and Paul Tasker in grade twelve.

Of these forty-one pupils four have already left school and two have moved from the district.

Of the thirty-five now in school five are seniors. As there are now ten in the eighth grade it is likely that forty pupils will be enrolled in high schools next fall so that \$3,000.00 will be needed for tuition.

PART VII. AUXILIARY ACTIVITIES AND SPECIAL REPORTS

A. Report of School Health Work Ruth S. Langille, R. N.

A measles epidemic disrupted the school attendance in several of the schools this Fall but was not as serious as the epidemic of ear, sinus and mastoid infections which made it necessary for seven pupils to miss a great deal of the Spring term of school last year.

The crippled girl who has been under treatment for three years in a Boston Institution has had the necessary orthopedic surgery so that she is now able to walk with braces. She had a serious illness and a bad set back in the Spring but recovered and was able to be graduated with her class from the eighth grade in Boston. Her education has continued steadily there and she has been able to complete five years of school work in the three years that she has been confined to the hospital, though she was in bed a large part of the first two years. She was able to visit relatives and friends in Barnstead last Summer and was happy to be able to get about in the town again.

The American Legion Auxiliary once again is offering to sponsor the school dental clinic and although the amount of money available makes it necessary to limit the work to \$1.00 per pupil, the parents in many cases are glad to have the remaining amount of work done at clinic rates. Last year 58% of the pupils receiving dental treatment were able to have all the necessary work completed. In the Shackford's Corner school the Parent-Teacher's Association of that district sponsored the completion of the work for those pupils so that all the pupils in the school were able to have the work done. At Beauty Hill 100% of the pupils attended the clinic but were unable to manage a 100% correction for lack of enough money to complete the work. This clinic is proving of great benefit to the pupils and the bad dental conditions noticeable in every school are gradually improving.

Six children were fitted to glasses last year,—four of them in school clinics. There were no tonsil and adenoid operations although thirty six children show the need for this to be done.

I wish to thank those who are helping so much with

their interest, influence and generosity in the school health work. The American Legion Auxiliary has made the most far seeing contribution to the health of the Barustead children that it is possible to make. Thanks to their generosity many children will grow up with better teeth as well as good habits and attitudes towards this most necessary health measure.

B. Surplus Commodities

On August 29, 1939, your superintendent of schools wrote to the Federal Surplus Commodities Corporation at Washington requesting that surplus agricultural commodities be made available to the schools of this supervisory union to supplement the local hot lunch programs in the schools. As a result of the request, there have been delivered to the schools this fall and winter two lots of foods consisting of twelve bushels of apples, 1,010 oranges, thirty pounds of raisins, four cases of canned peaches, there cases of canned grapefruit juice, and thirty-five pounds of butter. Some of this food has been made available to all pupils and some is used in the preparation of, and as a supplement to, the hot lunches served to those who do not go home at noon. This service has certainly been greatly appreciated by the pupils.
