District Warrant

STATE OF NEW HAMPSHIRE—ROCKINGHAM, SS.

To the Inhabitants of Little Boar's Head District, a village district in the Town of North Hampton, organized under provision of Chapter 196, Session Laws of 1905, qualified to vote in District affairs:

You are hereby notified to attend the annual meeting of said District to be held at the residence of William P. Fowler, on Atlantic Avenue in said District, on the first Tuesday of September next (the 5th day of the month), at eight o'clock in the evening (8.00 P. M.) for the following purposes:

1. To elect a moderator, a clerk, three commissioners, a treasurer, and an auditor for the ensuing year.

2. To hear the reports of the clerk, treasurer, and other officers of said District, and to take such action as may be desired in regard to same.

3. To take such action as you may desire in regard to allowing the same discount on district taxes as is allowed by the Town of North Hampton on town taxes.

4. To raise such sum of money as may be needed for the extinguishment of fires, the lighting of streets, the planting and care of shade and ornamental trees, the supply of water for domestic and fire purposes, the construction and maintenance of sidewalks and main drains or common sewers, the construction, maintenance and care of parks or commons, the maintenance of activities for recreational promotion, the appointing and employing of watchmen and police officers, the enacting and enforcing of zoning regulations, and all other district expenses.

5. To take such action as you may desire in regard to giving the Treasurer of the District authority to borrow money in anticipation of taxes collectible during the ensuing year.

6. To transact such other business as may legally come before said meeting.

Commissioner's Report

1943 - 1944

The effect of the war on our village district is shown in curtailed activities and a low point in expenditures. Owing to the labor shortage, little has been undertaken beyond the usual hydrant and sidewalk maintenance, and winter watchman service.

Your commissioners effected a great saving in sidewalk expense by leaving the plankwalk at Bass Beach in place all winter, with rocks put on top of it to keep more of it from being blown off than had already been done last fall by a heavy wind. Fortunately there were no severe storms last winter to wash the walk away.

The past year saw the end of restrictive military regulations on our coast, — including the removal of the Army watch-house on the Head, the welcome return of streetlights, and the ending of the blackout and of air-raid drills. In consequence, more of our houses are occupied this summer than in several years.

Through our Zoning Ordinance, we remain assured of the continuing residential character of our community. Edward R. Hale was re-appointed our Zoning Inspector for the past year, and William P. Fowler was re-appointed a member of the Zoning Board of Adjustment for a five-year term.

The District Tax Rate, voted a year ago, was \$2.60 a thousand dollars' valuation. Although we spent less than \$1,200 this past year, our normal budget should be a little over \$2,000. Our surplus of \$3,429.33 will leave us some to spare next summer, when we may expect to receive whatever is voted at the coming meeting. It is recommended that our tax rate be reduced to \$1 a thousand this year. This will provide us with a little over \$2,000 a year for the next two years.

A change in the method of tax receipts for our District was made this past year. Heretofore the receipts came directly from the Town Tax Collector, whereas starting in 1944, these are being remitted to us by the Town Treasurer in the full amount of our appropriation. This is done in conformity with the recommendations of the State Tax Commission.
