### STATE OF NEW HAMPSHIRE

(L. S.) To the Inhabitants of the Town of Shelburne, in the County of Coos, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Shelburne on Tuesday, the eleventh day of March next, at Nine of the Clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the ensuing year.

2. To hear the reports of town officers heretofore chosen and pass any vote relating thereto.

3. To hear the report of the budget committee and act thereon.

4. To raise such sums of money as may be necessary to defray town charges for the year ensuing and make appropriation of the same.

5. To see what sum of money the town will vote to raise and appropriate for the maintenance of town highways and bridges.

6. To see what sum of money the town will vote to raise and appropriate for Town Road Aid construction of highways.

7. To see what sum of money the town will vote to raise and appropriate for police.

8. To see what sum of money the town will vote to raise and appropriate for fire protection.

9. To see what sum of money the town will vote to raise and appropriate for fire trails.

10. To see what sum of money the town will vote to raise and appropriate for insurance.

11. To see what sum of money the town will vote to raise and appropriate for the library.

12. To see what sum of money the town will vote to raise and appropriate for public welfare.

13. To see if the town will vote to observe Old Home Week during 1952 and raise and appropriate a sum of money therefor. 14. To see what sum of money the town will vote to raise and appropriate for general care and upkeep of the town Memorial Forest.

15. To see what sum of money the town will vote to raise and appropriate for the care of cemeteries.

16. To see what sum of money the town will vote to raise and appropriate for the town's share of co-operative participation in the White Mountains Region.

17. To see what sum of money the town will vote to raise and appropriate for the use of the Roadside Improvement Committee for the care, improvement and upkeep of the roadsides.

18. To see if the town will vote to adopt a plan for extending to employees of the town the benefits of title II of the Federal Social Security Act (Old-Age and Survivors Insurance) as authorized by Chapter 234 of the Laws of 1951 and to raise and appropriate a sum of money to defray the town's share of the cost thereof.

19. If the foregoing article is adopted, to see if the town will authorize the selectmen to execute on behalf of the town the necessary agreement with the State of New Hampshire to carry into effect the plan and to see if the town will designate the Town Treasurer as the officer to be responsible for the administration of the plan.

20. To see if the town will vote to authorize the selectmen to administer or dispose of any real estate acquired by the town through tax collector's deeds.

21. To see if the town will vote to authorize the selectmen to distribute the inventory blanks when taking inventory.

22. To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes.

23. To transact any other business that may legally come before said meeting.

# **REPORT OF SUPERINTENDENT**

To the Superintending School Committee and the Citizens of the Shelburne School District:

#### Foreword

Life's greatest mistake, according to a recent Gallup poll, is in not getting enough education. Pollers found that more men and women listed that omission than any other, as being responsible for their hardships.

In these trying times our schools should devote themselves directly to the great fundamental purposes of education—the preparation of intelligent citizens who understand, believe in, and practice the ideals of democracy—the preservation of national unity; the development of a sense of responsibility for common welfare; and the maintenance of sound, wholesome community life.

Education for all the people is America's noblest contribution to civilization. Today there is a mounting tide of sentiment in behalf of better education. As surely as children grow, the schools must go on. Education cannot wait.

#### Teacher

The teacher, this year, is Marie Daley. Mrs. Daley has been with us for the past 6 years.

#### Enrollment and Attendance

There are, at this writing, 22 enrolled in the school. This represents a decrease of one from the same period last year. You may recall that our enrollment a year ago was somewhat larger due to the pipeline construction. The percentage of attendance for 1950-51 was 97.11. There were but two cases of tardiness for the year. The State Department of Education considers, a percentage of attendance of, 97 per cent or better as worthy of special commendation. The pupils, teacher, and parents are to be commended for the especially fine at tendance record.

#### Tuition

There were, during the fall, 18 attending school in Gorham. Eleven were in the elementary grades and seven in the high school.

The tuition rate for 1950-51 in Gorham is \$125.00 for elementary and \$200.00 for high school.

#### School Calendar

It is proposed that the school board adopt the following school calendar for 1952-53.

September 3, Wednesday, School Opens November 26, Wednesday, Closing 12:30 November 27, 28, Thanksgiving Recess December 19, Friday, School Closes

#### Notes on the Budget

The school board's total budget for 1952-53 is \$9,631.00 as compared with \$9,047.00 for last year. It will be remembered that the 1951-52 figure contained a deficiency appropriation of \$600.00. The requested appropriation for this year is \$584.00 more than the total appropriation for last year.

By looking at the budget you will notice that the largest single increase is the item tuition. With but two in the Senior class at Gorham and with seven new ones to enter it would appear that the number of tuition pupils would definitely be larger. The tuition rate is, also, higher.

#### Conclusion

It has been said that the people of the United States could be divided into three groups—the small group who makes things happen—the large group who watch things happen—and the enormous group who do not know what happens. I hope that the educational opportunities of our schools are such that our boys and girls will become a part of that small group who make things happen.

I take this opportunity to express my appreciation to the members of the school board, parents, teacher, and eitizens for their support in our common effort to maintain good schools.
