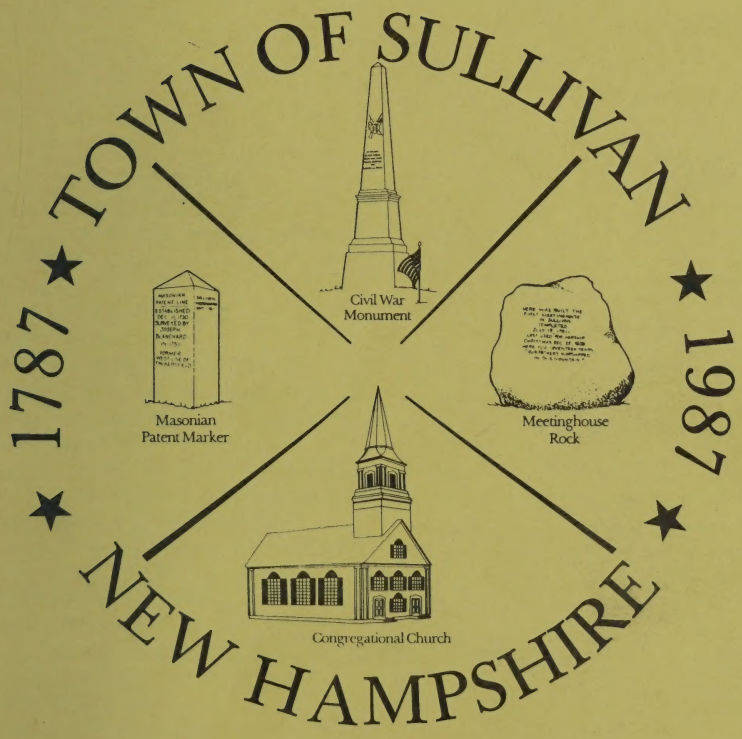

SELECTMEN'S REPORT

During 1986 work progressed on the town building projects authorized by the Town Meeting. The wooden fire escape at the Town Hall has been replaced with a metal structure which should prove more durable. The front steps with a new ramp has been constructed to provide handicapped access to the Town Hall. The furnace room has been built and provided with a fire door. At this writing the bathroom is ready to hook up to the water supply. Flood damage included the destruction of the Town Hall oil burner. This has been replaced and a drain installed to carry the water outside. We expect this work will be paid for under the storm damage formular: 75% Federal, 12½% State and 12½% Town. The oil burner for the library authorized by the 1985 Town Meeting was installed early in 1986.

With Town Meeting approval, it is planned to paint the outside of the Town Hall, Library, and Hearse House and the doors and trim on the Fire Station. A warrent article asks for the appropriation of \$6500.00 for the purpose to be used along with the \$1400.00 appropriated in 1986 for paint. The goal is to have the Town as presentable as possible for the Bicentennial Celebration. It is hoped that private property owners will "spruce up" their yards and buildings for the occasion. The Board of Selectmen will cooperate in any way possible to make Sullivan look its' best this summer and to make the celebration a success.

The property and liability insurance for the Town has been changed from a private carrier to a Trust formed by the cities and towns of New Hampshire. This move was prompted in part by the instability of the market for municipal insurance and in part as an economy measure. Under the trust agreement the Town will be responsible for it's own losses up to \$1000.00 for each accident. Therefore, safety and loss preventuion become very important--It's our own money we are trying to save.

The Moderator, Mr. Richard Cummings, opened the polls at 1:00 PM, in the afternoon, of March 11th, at the Community Hall, to bring in ballots, for the Town Officers, for the ensuing year. Polls closed at 7:00 P.M. The checklist was duly posted and used in the election of Town Officers. The checklist contained 320 names. Total number of ballots cast were 157. Article 2

Voted by ballot - 57 NO

68 YES for the adoption of the ordinance relating to Building within the Special Flood Hazard Area as proposed by the Planning Board.

At the Community Hall, the Town Meeting was called to order, by the Moderator, Mr. Richard Cummings, at 7:00 P.M., on March 12th, to elect a Budget Committee member for three years and to act upon the Warrant Articles.

Article 3

Voted, by voice vote, to raise and appropriate the sum of \$58,865.00 to defray Town Charges for the ensuing year.

Article 4

Voted, by voice, to raise and appropriate the total sum of \$74,100.00 for the maintenance of highways and bridges and construction of the same for the ensuing year as follows:

\$43,980.00 to be raised by taxes

23,408.00 to be designated from the Highway Block Grant

6,712.00 to be withdrawn from the Revenue

Sharing Fund established under the provisions of the State and Local Assistance Act of 1972.

Article 5

Voted, by voice vote, to raise and appropriate the sum of \$2,800.00 for the operation of the Police Department and the purchase and maintenance of equipment of the police department.

Article 6

Voted, by voice vote, to raise and appropriate the sum of \$4,857.00 for the operation of the Fire Department for fire protection and purchase and maintenance of equipment and buildings for the fire department.

Article 7

Voted, by voice vote, to raise and appropriate the sum of \$3,600.00 to provide and maintain Public Library service and authorize the Library Trustees to receive and use supplemental funds as provided.

Article 8

Voted, by voice vote, to raise and appropriate the sum of \$1,000.00 for deposit to the Capital Reserve for Revaluation.

Article 9

Voted, by voice vote, to raise and appropriate the sum of \$2,500.00 for deposit to the Capital Reserve for Major Highway Equipment Purchase.

Article 10

Voted, by voice vote, to raise and appropriate the sum of \$500.00 for deposit to the Trust Fund for Forest Fire Fighting Liabilities or the purchase of Forest Fire Fighting Equipment.

Article 11

Voted, by voice vote, to raise and appropriate the sum of \$700.00 for the care and maintenance of Town Cemeteries.

Article 12

Voted, by voice vote to accept the following Cemetery Trust Fund: Maurice F. Swett and Helen E. Swett
\$200.00

Article 13

Voted, by voice vote, to rescind the action taken by the Town Meeting of 1983-Wherein it was voted "to discontinue, subject to gates and bars, the so-called Boulder Road beginning at the junction of Nurses Path and leading to Sullivan-Stoddard town line".

Article 14

Voted, by voice vote, to discontinue the section of the Old Apple Hill Road starting at a point 160 feet up the hill from the center line of Route Nine (9) to a point 270 feet down the hill from the center line of the New Apple Hill Road.

Article 15

Voted, by voice vote, to raise and appropriate the sum of \$1,000.00 to be used by the Sullivan Bicentennial Committee for planning the Towns Bicentennial.

Article 16

Voted, by voice vote, to accept a gift of \$2,000.00 for Jewett Park from the heirs of Stanley Dvorachek, deceased, and to establish a trust fund-The Stanley Dvorachek Memorial Trust Fund-and place therein the \$2,000.00 for the purpose of Additions and up-keep to Jewett Park and designated the Selectmen as agents of the Town authorized to make withdrawals of principal and interest from said trust fund to carry out the purpose for which it was established.

Article 17

Voted, by ballot vote, 4 NO

61 YES, to accept the provisions of RSA 53-3:1 to 11 inclusive providing for the establishment of a regional refuse disposal district together with the towns of Chesterfield, Harrisville, Marlboro, Nelson, Roxbury, Surry, Swanzey, Troy, Westmoreland and the City of Keene, and the construction, maintenance, and operation of a regional refuse disposal facility by said district in accordance with the provisions of a proposed agreement filed with the Selectmen.

Article 18

Voted, by voice vote, to appropriate the sum of \$764.00 to fulfill the terms and conditions required by the Ashuelot Valley Refuse Disposal District for new members entering the district.

Article 19

Voted, by a unanimous voice vote, to appropriate from current surplus, if available, the amount of \$3,500.00 to complete the bathroom facilities in the Town Hall.

Article 20

Voted, by voice vote, to amend--add \$600.00 for a handicap ramp.

Voted, by voice vote, to appropriate from current surplus, if available, the amount of \$8,035.00 to meet the Fire Marshalls recommendations as concerns the Town Hall:

Article 21

Voted, by voice vote, to raise and appropriate the sum of \$1,400.00 for the purpose of purchasing paint, as needed, for use on Town Buildings.

Article 22

Voted, by voice vote, to authorize the Selectmen to apply for, and to accept, on behalf of the Town, and to expend, any and all gifts, grants or other funds which may now or hereafter be forthcoming over and above the total appropriation of the Town.

Article 23

Voted, by voice vote, to pass over Article 23. To see if the Town will vote to authorize the Selectmen to sell and convey any real estate acquired by the town during the period until the next Town Meeting and that the Selectmen be authorized to sell and

convey such real estate by auction, sealed bid, or in any other manner as justice may require.

Article 24

Voted, by voice vote, to authorize the Selectmen as agents of the Town to borrow money in anticipation of taxes.

Article 25

Voted, by voice vote, to accept the reports of the Agents, Auditor and Committees as printed in the Town Reports.

Article 26

The Town Meeting extended "thanks" to Mr. Neil A. Henry for serving his community on the Planning Board and various Town Committees, with a minute of silent prayer.

Town of Sullivan received a Certificate of Appreciation from the American Red Cross for the Town's assistance during hurricane Gloria. This Certificate was presented to Philip Gladu, Chief of the Fire Department.

Voted by a voice vote, to accept a resolution-to oppose the burial, storage and transportation of high level radioactive waste in the Town of Sullivan and the State of New Hampshire; and to call upon Congress to conduct an independent investigation with full public participation into the feasibility and prudence of the U.S. Department of Energy's (DOE's) present plan to dispose of radioactive waste and into the DOE's competence to carry out such a plan.

Voted, by a voice vote, to adjourn.

1987 Town Warrant

To the inhabitants of the Town of Sullivan in the County of Cheshire in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Sullivan Town Hall in said Sullivan on Tuesday, the Tenth (10th) day of March, next, at 1:00 PM of the clock in the afternoon to act upon the following by written ballot: the polls not to close before 7:00 PM.

1. To choose all necessary Town officers for the year ensuing.
2. To vote on the following question: Are you in favor of rescinding our existing ordinance relating to building within the special flood hazard area and adopting the State recommended Flood Plain Development Ordinance?

You are hereby notified to meet at the Sullivan Town Hall on Wednesday, the Eleventh (11th) day of March next, at 7:00 PM of the clock in the evening to act on the following subjects:

3. To vote to raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same.
4. To vote to raise and appropriate the sum of \$73,550.00 for maintenance of highways and bridges and construction of the same for the ensuing year as follows: \$42,567 to be raised by taxes
\$25,887 to be designated from Highway Block Grant
\$ 5,096 to be withdrawn from the Revenue Sharing Fund established under the provisions of the State and local Assistance Act of 1972, or take any action relating thereto.
5. To see if the Town will vote to raise and appropriate the sum of \$3,175.00 for the operation of the Police Department and the purchase and Maintenance of equipment of the police department; or take any action relating thereto.
6. To see if the Town will vote to raise and appropriate the sum of \$4,475.00 for the operation of the Fire Department for fire protection and purchase and maintenance of equipment and buildings for the Fire Department; or take any action relating thereto.

7. To see if the Town will vote to raise and appropriate the sum of \$3,900.00 to provide and maintain Public Library service and authorize the Library Trustees to receive and use supplemental funds as provided; or take any action relating thereto.

8. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the care and maintenance of Town Cemeteries; or take any action relating thereto.

9. To see if the Town will vote to raise and appropriate the sum of \$6,500.00 for the purpose of painting the Town Buildings as follows:

Library	\$2,450.00
Hearse House	500.00
Fire Station	500.00
Town Hall	3,050.00

or take any action relating thereto.

10. To see if the Town will appropriate \$16,312 for the purchase of a one ton heavy duty four wheel drive truck equipped with a plow, to be paid for by raising \$8,312 by taxes in 1987 and authorizing the Selectmen to withdraw \$8,000 from the Capital Reserve Fund for Major Highway Equipment; or take any action relating thereto.

11. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for deposit to the Capital Reserve for Major Highway Equipment Purchase; or take any action relating thereto.

12. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for the Deposit to the Capital Reserve for Revaluation; or take any action relating thereto.

13. To see if the Town will vote to raise and appropriate the sum of \$500.00 for deposit to the Trust Fund for Forest Fire Fighting Liabilities or the purchase of Forest Fire Fighting Equipment; or take any action relating thereto.

14. To see if the Town will vote to establish a Trust Fund to be known as the Insurance Trust Fund for the purpose of paying losses suffered by the Town which fall within the \$1,000 self insured retention of the Towns' contract with the Property-Liability Insurance Trust, Inc. and to designate the Selectmen as Agents of the Town authorized to make withdrawals of principal and interest from said Trust Fund to carry out the purpose for which it was established; or take any action relating thereto.

15. To see if the Town will raise and appropriate the sum of \$2,000 and place this amount in the Insurance Trust Fund; or take any action relating thereto.

16. To see if the Town will vote to accept the following Cemetery Trust Fund.

Harlow Maguire and Irene Maguire \$200.00

17. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 to be used by the Sullivan Bicentennial Committee for the Town's Bicentennial; or take any action relating thereto.

18. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the purpose of Landscaping at the Town Hall. This is to include a cement drive/walkway in front, the planting of shrubs and trees and seeding certain areas.

19. (By Petition) To see if the Town will vote to raise and appropriate the sum of \$500.00 for deposit to the Capital Reserve for Major Highway Equipment Purchase, this being the sum that it is expected the Highway Department will realize as income from other governmental entities for plowing, sanding and other road maintenance; or take any action relating thereto.

20. (By Request of the Planning Board) To see if the Town will vote to add two Alternate Members to the Planning Board as permitted by RSA 673:6 and authorize the Selectmen to appoint one alternate for a term of two years and one alternate for a term of three years with both alternates to have three year terms thereafter; or take any action relating thereto.

21. (By Request of Planning Board) To see if the Town will vote to change the Residential Building Ordinance under Section 2 Requirements A-1 to 3 to be as follows:

1. Lot Size: All lots shall be of sufficient size to provide adequate area for water supply and sewage disposal facilities and be of not less than two acres in area.

2. Frontage: Each lot shall have a minimum of two hundred (200) feet of frontage on a Class V or better highway or street laid out and maintained by the Town or the State of New Hampshire.

3. Existing Lots: Residential buildings may be erected on lots existing at the time of passage of this amendment which do not meet the size and frontage requirements providing all other requirements imposed by this ordinance are met and the lot is of sufficient size to accomodate adequate water

supply and sewage disposal facilities.

22. (By Petition) To see if the Town will vote to establish a Sullivan Highway Study Committee, to consist of seven (7) members: two (2) members appointed by each of the Selectmen and one (1) appointed by the Town Moderator, for the purpose of studying the method of selecting a road agent; the results of such study to be submitted to the Selectmen by January 7, 1988; or take any action relating thereto.

23. To see if the Town will vote to instruct the Town's representative to the General Court to take all necessary measures to insure that no low level radioactive waste shall be stored or disposed of within this Town of Sullivan unless and until the proposed site of the proposed storage or disposal has been approved by the voters of the Town at the annual Town Meeting by written ballot; or take any action relating thereto.

24. To see if the Town will vote to authorize the Selectmen to apply for, and to accept, on behalf of the Town, and to expend, any and all gifts, grants or other funds which may now or hereafter be forthcoming over and above the total appropriation of the Town.

25. To see if the Town will vote to authorize the Selectmen to sell and convey any Real Estate acquired by the Town during the period until the next Town Meeting and that the Selectmen be authorized to sell and convey such Real Estate by auction, sealed bid, or in any other manner as justice may require.

26. To see if the Town will vote to authorize the Selectmen as Agents of the Town to borrow money in anticipation of Taxes.

27. To see if the Town will vote to accept the reports of the Agents, Auditor and Committees as printed in the Town Report.

28. To transact any other business which may legally come before this meeting and to listen to opinions of a purely advisory nature in regard to the conduct of Town affairs for the ensuing year.

NOTICE TO PROPERTY OWNERS

A new law effective April 1, 1978 imposes a penalty for failure to file a fully completed inventory form.

"RSA 74:7-a Penalty for Failure to File. Any person who fails to file a fully completed inventory form on or before April 15, unless granted an extension under RSA 74:8, shall pay a penalty of one percent of the property tax for which he is liable. In no case, however, shall the penalty be less than \$10 or more than \$50. Any person who fails to file an inventory form and who becomes liable to pay the penalty specified in this section shall lose his right to appeal any matter pertaining to the property tax for which he is liable or exemptions to which he may be entitled. This penalty has all the force of taxation and shall be treated as incident to the tax."

Inventory blanks are mailed before March 25 as required under RSA 74:5, but if for any reason you fail to receive one, you should contact the Selectmen to obtain one and complete it as required above.

The Town of Sullivan still requires the use of inventory forms. Current Use, Veteran, and Elderly Exemptions must be applied for annually on the reverse of the inventory.

Juvenile Fiction and Non-Fiction loaned 2,568
There were 2,094 patrons during the year, and 27 request loans from Keene.

There were 428 new and donated books added to the shelves, and 266 discarded. A new set of Science and Technology Encyclopedias was added.

Magazines by subscription or donated, are Yankee, Country Journal, Country Living, Colonial Homes, Early American Life, National Geographic, Farm and Ranch, Harrowsmith, Rodale's Organic Gardening.

Money raising projects included; a used book sale at the Bi-Centennial Bazaar; the annual Holiday Craft Bazaar and Luncheon; plus a small sum from the sale of Sullivan cook-books, post cards, notepaper, town maps and histories; and conscience fines from over-due books.

The Library was used in 1986 for Regular Library Hours; Planning Board Meetings; Bi-Monthly blood pressure clinic; Library Trustee Meetings; Bi-Centennial Committee meetings.

There was one evening program sponsored by the Trustees; Slides and talk on Home Health Care and Community Services to Sullivan on Nov. 12. There were 12 in attendance.

A detailed account of the Library's activities and programs is included in each issue of the Sullivan Community Newsletter.
