# WARRANT.

## STATE OF NEW HAMPSHIRE.

*To the Inhabitants of the Town of Woodstock in the County of Grafton in said State, qualified to vote in town affairs.*

You are hereby notified to meet at the Town House in said Woodstock on Tuesday, the 13th day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.
3. To see if the town will authorize the Selectmen to hire such sums of money as may be necessary to pay town debt.
4. To see what sum of money the town will raise for support of roads and bridges.
5. To see how much money the town will raise in addition to what the law requires for the support of schools.
6. To see what sum of money the town will raise to decorate soldiers' graves,
7. To see if the town will pass any vote relating to amending by-laws and regulations of the water system.
8. To see if the town will vote to exempt the Free Baptist church and Parsonage from water tax.

9. To see if the town will take any action in regard to observing its one hundred anniversary and pass any vote relating thereto.

10. To see what action the town will take on T. P. Cheney's bill.

11. To transact any other business that may legally come before this meeting.

## REPORT OF SCHOOL BOARD.

---

We respectfully submit the following report:

The schools for the past year have been divided into ten terms, with the object in view, to give each scholar in town an equal chance. But we have met with some reverses in making this attempt. So far as the schools are concerned outside of our business management, we feel justified in saying we thing them a success, and feel that our teachers were all well qualified to fill the positions they occupied.

### North Woodstock School.

The terms of school at North Woodstock :Summer term of eight weeks; Mrs. Nina R. Pelton, teacher. Roll of perfect attendance: Bernice Beard, Alfreda Chates, Lillian Fifield, Susie Tucker, Ray Dearborn, Leon Emery, Bertie Fraser, Fred Fraser, Peery Goodwin, Raymond Gordon Warren Pease. Frank Willoughby, John H. Wood, Eugene Woodbury, Scott Woodbury, Eveleen Tucker.

Fall term of eight weeks, Mrs. Carrie Bartlett, teacher. Roll of perfect attendance: Ray Dearborn, Bert A. Frazer, Percy R. Goodwin, Warren C. Pease, Albert D. Tappan, Harold W. Tilton, Frank P. Willoughby, John H. Wood, Susie L. Tucker, Eveleen Tucker.

Winter term of seven weeks, Mrs. Carrie Bartlett, teacher: It should be said, owing to whooping cough in the school, it made it hard for teacher and scholars, and also shows cause for small average attendance. Mrs. Bartlett maintained her reputation as an efficient teacher.

For this school, we experienced difficulties in securing a teacher for the summer term, for which we, without doubt, got our share of the blame. In Miss Wells we think we got a good teacher for the fall and winter terms. The school showed well considering the long recess from winter to fall term.

### Tannery School.

Summer term, nine weeks; fall term, nine weeks. Miss Gertrude Kendall, teacher. Miss Kendall had taught this school before and as usual it was successful in every way. It is needless for us to make comments on a teacher so well known as Miss Kendall. Roll of perfect attendance first term, Omar Sawyer; second term, Hattie Connor.

Our schools have been shortened this year on account of funds, and would have been still more had not the state paid the town a proportion fund, (one hundred and thirty-one dollars) making our total funds about seven hundred dollars. For the benefit of the voters we will say that the total amount of school money to be raised as provided by law the coming year is about three hundred and forty dollars and a local fund of thirty-five dollars. Should the town

receive the same from the state as this year, and the same dog license fund, it would amount to about six hundred dollars, total school fund. There is, however, no guarantee that we will receive as much from the state.

This explanation is made that due consideration may be taken in considering what sum of money may be necessary in addition to what the law requires for school purposes.
