TOWN WARRANT

STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Atkinson, in the county of Rockingham in said State, qualified to vote in town affairs:

You are hereby notified to meet at Grange Hall in said town on Tuesday, the eighth day of March next at nine o'clock in the forenoon, to act upon the following subjects.

1. To choose all town officers that are voted for by ballot and major vote.

2. To choose all other necessary town officers for the ensuing year.

3. To raise and appropriate such sums of money as may be necessary to defray town charges for the ensuing year.

4. To raise and appropriate such sums of money as may be necessary for repairing town highways.

5. To see if the town will raise and appropriate in addition to the \$444.00 required by state law, the amount of \$222.00 to secure state aid of \$666.00 for state aid construction. One thousand dollars of this appropriation to be used to pay the second note falling due on loan used in permanent road construction on Main Street.

6. To see if the town will vote to raise and appropriate the sum of \$1,800.00 for State Aid Maintenance of highways and thus receive \$2,700.00 from the State.

7. To see if the town will vote to raise and appropriate the sum of \$80.00 and receive \$120.00 from

the State for the purpose of building a bank wall around the pound.

8. To see what sums of money the town will vote to raise and appropriate for snow pathing the high-ways.

9. To see if the town will take any action in regard to Old Home Week and vote to raise and appropriate money for the same.

10. To see if the town will vote to raise and appropriate the sum of \$400.00 to receive the sum of \$100.00 from the state for the purpose of continuing the eradication of the White Pine Blister Rust.

11. To see what sum of money the town will vote to raise and appropriate for the care of cemeteries.

12. To see what sum of money the town will vote to raise and appropriate for Memorial Day.

13. To see if the town will authorize the town treasurer with the approval of the Selectmen to hire such sums of money as the town may need in anticipation of taxes.

14. To see what sum of money the town will vote to raise and appropriate above that required by law for the support of the Public Library.

15. To see if the town will authorize the selectmen to transfer unexpended appropriations of previous years into the general fund of the town.

16. To see if the town will vote to establish a day within the time prescribed by law for advertising delinquent resident taxes.

17. (By petition of C. E. Kinney and others) To see if the town will vote to fine each Selectmen fifty dollars (\$50.00) for misplacing appropriations.

18. (By petition of C. E. Kinney and others) To see if the town will vote to discontinue street lights and raise and appropriate necessary money to install lights on Main St. from Page Brothers to Hampstead town line.

19. (By petition of C. E. Kinney and others) To see if the town will vote to raise and appropriate necessary money to finish the direct road into the new cemetery.

20. To hear reports of town officers and committees, act on same and transact any other business that may legally come before this meeting.

**BY-LAWS OF THE TOWN OF ATKINSON ADOPTED
MARCH 9, 1926**

(1). If any person or persons shall place, leave or cause to be left, in or near a highway, street, alley or public place, any garbage, tin cans, glassware or other refuse material, such person or persons shall be fined not exceeding \$10.00

(2). Any person or persons running a public dance in Grange Hall or other public place in this town must obtain a permit to run such dance from the selectmen. Persons violating this by-law shall be fined not exceeding \$10.00.

To the School Board and Citizens of Atkinson:

REPORT OF SUPERVISOR OF MUSIC

To the Superintendent and School Board of Atkinson:

I herewith present my annual report as supervisor of music in the Atkinson Schools.

The work in this department seems to grow from year to year. To-day the teaching of music does not mean simply the development of the voice, and the reading of notes. While these subjects are being carried on as successfully as ever much stress is laid upon the appreciation of music.

The work in this line usually proves very interesting to the few who can not sing, and the boys with changing voices. The pupils are given a list of the instruments in the orchestra, divided into four groups as follows: strings, wood-winds, brasses and percussion. With the aid of the victrola the tone of each instrument is listened to separately and then in combination. Pictures are used to show the shape of each one, and method of producing tone. The records used for this purpose have been carefully chosen from some of the world's best known classics.

Even a very young child is susceptible to the sounds of beautiful music. His ear is alert and registers conceptions very early, so the little people too have their listening lessons in music.

Sometimes the story of the music is told before the record is played and the children are allowed to raise their hands when they hear something the teacher has told them to listen for. Very often nothing is told about the music played, but the children show the

teacher just what it tells them to do. In this way better than any other the study of rhythm is developed.

Although the number of pupils at the Academy is small, the four-part chorus work is being carried on as usual. The male quartette which was organized last year had to be dropped as two of the boys left school.

To the Superintendent, School Board and Teachers I wish to express my appreciation of the cordial co-operation given me in my work.
