STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Epsom in the County of Merrimack, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Town Hall, in said Epsom, on Tuesday, the eighth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same, in accordance with House Bill No. 234 as passed by the Legislature of 1935 and as submitted by the Budget Committee.
3. To see if the town will accept State aid for the construction of the Class II road known as Short Falls Road and raise and appropriate or set aside for said purpose the sum of \$1,126.50 or will accept State aid for construction of Class V roads and raise and appropriate or set aside for said purpose the sum of \$554.92.
4. To see if the town will vote to allow a discount of two per cent on all property taxes paid previous to July 1, 1938.

5. To see if the town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes.

6. To transact any other business that may legally be brought before said meeting.

The New Hampshire Library Association awarded a scholarship to your librarian this year. This scholarship enabled her to attend the Library Summer School which was held in Manchester in July. Much practical help was received in all branches of library work.

Early in the fall, Miss Catherine Pratt, field worker from the New Hampshire Library Commission, visited our library and assisted the librarian in weeding out useless and unused books, that they may be removed from the shelves, to make room for other books.

Several book exhibits have been held during the year.

The books for high school students have been segregated and placed in a section by themselves.

A suggested purchasing list has been kept and the new books have been ordered from this list. The librarian welcomes any help given in book selection.

Since Miss Carter's work under the National Youth Administration came to an end early in the year the assistant librarian, Miss Dorothy Bartlett, took over the work of book mending. She has done very well in mending and resewing the books needing repairing, thus prolonging the life of the books that prove most popular, since those are always the first to wear out.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Epsom :

The schools are this year joining in the 150th anniversary of the Constitution of the United States, which was put into effect when New Hampshire cast the deciding vote for ratification, June 21, 1788. Our form of "government of the people, by the people, and for the people" is a regular subject of instruction in eighth grade civics and senior high school constitutional history.

Over 25,000 correspondence courses are now available for those who can attend higher institutions of learning. Many of these courses are valuable, while some are not so reliable. Persons wishing to avail themselves of such instruction would do well to consult the Superintendent of Schools or the National Home Study Council, Washington, D. C.

The reduction in the School Board's budget of a year ago has resulted in an estimated deficit for the current year, which can only be averted by the most strenuous efforts, if at all. The School Board has put earnest thought into preparing the estimate for the annual meeting. The estimated amount is needed, in their judgment. Any unexpected surplus next year may be used to cancel the debt, as authorized by the District, or used to reduce taxation next year.

The work of the School Nurse has been most valuable during the recent prevalence of contagious disease. Her report for last year is presented herewith.
