Town Meeting Warrant

State of New Hampshire

To the inhabitants of the Town of Wentworth, in the
County of Grafton, in said State, qualified to vote
in Town affairs:

You are hereby notified to meet at Town Hall, in
said Wentworth, on Tuesday, the ninth day of March
next, at nine of the clock in the forenoon, to act upon
the following subjects:

1. To choose all necessary Town Officers for the
year ensuing.

2. To raise such sums of money as may be neces-
sary to defray town charges for the year and make ap-
propriation of the same.

3. To see how much money the Town will vote to
raise and appropriate for town highways and bridges
for the ensuing year (summer and winter).

4. To see if the Town will vote to accept State Aid
Construction of Class V roads and raise and appropri-
ate or set aside for said purpose the sum of \$451.53,
State will contribute \$1,806.10, unless changed by the
Legislature.

5. To see how much money the Town will vote to
raise and appropriate for street lights.

6. To see how much money the Town will vote to raise and appropriate for the maintenance of the library.

7. To see how much money the Town will vote to raise and appropriate for the fire department.

8. To see if the Town will vote to raise and appropriate a sum not exceeding one one-hundredth of one percent (1-100 of 1%) of the assessed valuation based on the assessment of 1942 for the purpose of publicizing and promoting the natural advantages and resources of the town, together with other towns in the Dartmouth—Lake Sunapee Region. (\$44.52)

9. To see if the Town will vote to raise and appropriate the sum of \$400.00 for the white pine blister rust control.

10. To see if the Town will vote to petition the State Tax Commission to have an audit made by the municipal accounting division and to make an appropriation to cover the expense of such audit.

11. To see if the Town will vote to give a discount on real estate and personal property taxes (total or partial) paid before July 1 and add 20c to Poll Taxes not paid before December 1.

12. To see if the Town will vote to authorize the Selectmen to hire money in anticipation of taxes if necessary.

13. To see what action the Town will take in regard to letting the town hall for Roller Skating.

14. To see if the Town will vote to discontinue subject to gates or bars that part of the Ellsworth Hill Road leading from the Francis Randall place to N. D. Johnson place so called.

15. To see if the Town will vote to discontinue subject to gates or bars, that part of road leading from the Rowentown road towards Town Line Pond.

16. To see if the Town will vote to discontinue subject to gates or bars, that part of Saunders Hill road leading from the foot of the hill above the Gove landing to the Peter Veaudry place so called.

17. To see if the Town will vote to discontinue subject to gates or bars, the road leading from Hooper Hill road on the meadow to Saunders Hill road at a point where it joins the road just below the Pratt place so called.

18. To transact any other business that may legally come before said meeting.
