To the Inhabitants of the Town of Wilmot in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Wilmot on Tuesday, the eighth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To see how much money the Town will vote to raise and appropriate for the maintenance of Town highways.

4. To see if the Town will vote to raise and appropriate any money for Memorial Day.

5. To see if the Town will vote to raise and appropriate any money for Old Home Day.

6. To see if the Town will vote to raise and appropriate any money for the control of White Pine Blister Rust.

7. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes and negotiate the extension or renewal of the notes securing such loans, when it is necessary.

8. To see what action the Town will take in regard to real estate taken over by the Town for non-payment of taxes.

9. To see if the Town will vote to raise and appropriate \$481.50, the State to contribute \$1,000.00 for State Aid Construction on the Fourth New Hampshire Turnpike

or

To see if the Town will vote to raise and appropriate \$472.61, the State to contribute \$1,890.46 for Town Road Aid on Class V Highways.

10. To see what action the Town will take in regard to Town History Committee.

11. (Requested) To see if the Town will vote to raise and appropriate any money for the use of the Dartmouth-Lake Sunapee Region.

12. To bring in ballots for delegate to the Constitutional Convention.

Many excellent books have been purchased. These books provide a wide variety of information and interest and are carefully chosen in order that limited resources may be made to produce best literary revenue.

The many friends of Wilmot, both resident and non-resident, have continued to bear in mind the growing needs of the Library and have been generous in contributing books and magazines.

The schools of the town have maintained their splendid interest and have used freely the finest literary and reference material which the Library has to offer. Especial mention should be made of the "School on the Mountain" and the constant interest of teacher and pupils in good reading. Though the school is not large these boys and girls have read 356 books during the past year. REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens:

After a short period of teaching in the Kearsarge School of Practice over thirty years ago, it is an interesting experience to now have the opportunity to become acquainted with the public schools of Wilmot.

The change in superintendents here is only one of the changes necessitated in carrying out the last Legislature's policy of retrenchment here and there. I wish to express my appreciation of the courtesy and consideration shown by the School Board and others in accepting the change not of their seeking.

Five months is too short a time to determine what is the most important need of your schools. The toilets at the Center are out of repair. A jacket around the stoves at the Mountain and North Road Schools would be helpful. Books are always wearing out and becoming out of date. Buildings need something done every year to merely prevent deterioration.

By comparing the attendance record for the fall term just completed with that of the previous fall I note that the enrollment is the same and that there is considerable improvement in attendance and tardiness.

In the School Board's Estimate for the coming year they ask for Support of Elementary Schools \$14.99 more than asked last year; for Other Statutory Requirements \$335.82 less, due to a lower estimate for High School Tuition. Estimated income is \$82.14 less than last year. This leaves the total to be raised \$238.69 less than was asked for last year.

The cut made at the last year's district meeting in High School Tuition was more than met by balances due from past appropriations. The State Aid for December, 1937, and December, 1938, is reduced because the total demands of the many districts in the state which have

qualified have exceeded state appropriations. The policy of raising year by year the bare \$5 tax for elementary schools is likely to result in a deficit.

I respectfully submit the following report as School Nurse of Wilmot, from Jan. 1, 1937, to Jan. 1, 1938.

Inspection in Wilmot showed the following defects:

- 73 pupils were examined

- 4 pupils had enlarged or diseased tonsils
- 19 pupils were in need of dental care
- 1 pupil had defective speech

Girl from Mountain School taken to Dr. Dunbar's office in Lebanon for eye examination and fitted with glasses.
