TOWN MEETING WARRANT

STATE OF NEW HAMPSHIRE

*To the inhabitants of the Town of Littleton, in said State,
qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall and Police Court Room, in the Town Building, on the 14th day of March next, being the second Tuesday of March, at eight o'clock in the forenoon, to act upon the following subjects:

ARTICLE 1. To choose a Town Clerk, one Selectman for the term of three years, a Town Treasurer, a Collector of Taxes, an Overseer of the Poor, an Agent to prosecute violations of the liquor law, three members of the Board of Trustees of the Public Library, each for the term of three years, one Trustee of Trust Funds, a Constable and two Road Agents.

ARTICLE 2. To raise and appropriate such sums of money as may be necessary for the laying out, construction and repairing of highways and bridges, for town building maintenance, for election and registration expenses, for Memorial Day, for Municipal Court expenses, for the Police Department, for the Health Department, for vital statistics, for the Community House, for advertising purposes, for miscellaneous expenses, for street lighting, for band concerts, for cemeteries, for damages and legal expenses, for protection of the farms on the Ammonoosuc River, below the village, from flood and other water damage, for White Pine Blister, for payment of the town debt, and interest, for the Community Nurse, for the skating rink, and for all other town charges.

ARTICLE 3. To see what action the town will take for the purpose of securing State Aid for construction of highways

in this Town under the provisions of an act to provide State Aid and for expenditure of other public monies in the construction of highways throughout the State in accordance with Chapter 17 of the Laws of New Hampshire for 1935, or any amendments thereto, or an allotment for expenditure of funds upon its Town highways.

ARTICLE 4. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's deeds.

ARTICLE 5. To see if the Town will vote to adopt the Non-Partisan Ballot system for the election of Town officials as provided in the Revised Laws of New Hampshire.

ARTICLE 6. To see if the Town will vote to petition the State Tax Commission to have the audit of the Town accounts made annually by the Division of Municipal Accounting, and to dispense with the annual election or appointment of a town auditor or auditors.

ARTICLE 7. To see if the Town will authorize its Board of Selectmen to borrow monies, from time to time, for current indebtedness of the Town for the ensuing year, in anticipation of taxes to be collected for the year 1944, and to be paid therefrom.

ARTICLE 8. To see if the Town will vote to raise and appropriate the sum of \$400.00 to the White Mountains Region Association, being 1/100th of one percent of the town valuation, for the purpose of issuing and distributing printed matter, newspaper and magazine advertising, and otherwise calling attention to the resources and advantages of the Town, in cooperation with the other 45 towns in the White Mountains Region.

ARTICLE 9. To hear the reports of agents, auditors, com-

mittees, or officers heretofore chosen and pass any vote relating thereto.

ARTICLE 10. To choose any other necessary Town Officers for the year ensuing and to choose or elect any agents or committees which may be necessary to carry into effect any vote that may be passed under this warrant.

ARTICLE 11. To transact any other business that may legally come before the meeting.

Gentlemen:

Submitted herewith is the report of an audit and examination of the account of the Town of Littleton which has been made by this Division in accordance with the vote taken at the last annual town meeting. Exhibits and Schedules as hereafter listed are included as part of the report.

Scope of Audit

Included in the audit and examination were the accounts of the selectmen, treasurer, tax collector, town clerk, trustees of trust funds, municipal court, overseer of the poor, road agent, library treasurer and park commission, for the fiscal year ended January 31, 1944. The accounts of the Water and Electric Department of the town and the Littleton Village District were also audited and separate reports are being made for each of these divisions.

Finances

Comparative statements showing the Indebtedness, Valuation and Taxes assessed during the ten year period ending January 31, 1944, are presented in Exhibits V and VI. A decrease in Net Debt from \$57,614.74 to \$33,779.30, was made during the fiscal year ending January 31, 1944. The average local tax rate was reduced from \$2.68 per hundred in 1942 to \$2.60 in 1943. This compared with an average rate for the whole state of \$3.23 and \$3.03 for the same years.

The outstanding debt and annual maturities of the Town of Littleton, Littleton Village District and the Water and Electric Department, are shown in Exhibits II-A, II-B and II-C, respectively.

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended January 31, 1944, are included in Exhibits III and IV. A net excess of actual over estimated revenues of \$925.53, and a net unexpended balance of appropriations of \$3,824.83, resulted in a net budget surplus for the year of \$4,750.36.

Audit Procedure

The accounts and records of all town officials charged with the custody of and who receive or disburse public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from the depository banks.

Tax Accounts

The 1943 tax warrant of Collector Simons was audited and balanced as indicated by Schedule B. Activity in the war-

rant accounts for the levies of 1942 and 1941, was also checked as noted in Schedules B-1 and B-2.

Tax sale accounts were examined and the activity therein for the fiscal year is indicated in Schedule B-3.

Town Clerk

Motor vehicle permits and dog licenses issued by the town clerk during the year were examined. All funds received from these sources were properly accounted for through remittances to the treasurer.

General Comments

Upon our recommendation the tax collector's books were closed on January 31st and all taxes remaining unpaid on this date were included in the list published in the annual report. It is necessary that the collector's accounts be actually closed on this date in order that his report be in agreement with that of the treasurer.

The collection of interest on delinquent taxes is required by state law which provides that interest at the rate of 8% shall be charged on taxes paid after December 1st, and at the rate of 10% on redemptions from the date of tax sale to the time of payment. Abatements of interest should be made by the selectmen in the same way as any tax abatement is made,—viz: by a regular abatement order.

Any property sold to the town for taxes on account of the levy of 1940 or prior years' levies, from which sales no redemption has been made, should be deeded to the town. The law provides that a deed shall be executed to the purchaser of property at a tax sale after two years from the date of sale, provided that no redemption is made within the two year period.

It is recommended that fiscal officers of the town make monthly remittances to the treasurer of all funds received to

date of remittance as required by law and that all funds be remitted to the treasurer before the close of the fiscal year.

The selectmen's book of classified receipts and expenditures should be kept posted up to date in order that the actual cash balance of the town may be determined at any time and also that the relation of expenditures to appropriations may be kept on a current basis. It is also suggested that the classification of expenditures be given careful consideration in order to avoid a "miscellaneous" classification, except when it appears that the expenditure definitely cannot be classified under one of the regular accounts.

It was noted that several of the library trust funds were held by the treasurer of the library. These funds should be turned over to the town trustees of trust funds as the law requires that "The trustees of trust funds shall have the custody of all trust funds held by their town."

With exceptions, as noted herein, the financial accounts and records of all town officials which were examined were found to be in good condition and in accordance with prescribed methods.

In accordance with the provisions of Section 31, Chapter 211, of the Laws of 1939, this report or a summary of its essential features should be published in the next annual town report.

We extend our thanks to the officials of the town for the assistance rendered and information furnished while engaged in making this audit.

Annual Report of the Librarian Is Herewith Submitted:*

Judged by the last issuing of ration books for the town, the population of Littleton has decreased since the 1940 census to about 4,000. Percentages shown in the statistical report are based on that figure. War aid activities outside the home continue to fill the leisure time of many people, and the gasoline shortage discourages those who live some distance away from borrowing books regularly. These are the reasons, it is believed, for a slightly lower circulation than last year. The percentage of juvenile books loaned remains high. To provide reading for children as recreation and as a source of information is an important function of a public library. The children of today become the adult readers of tomorrow.

Circulation of books loaned to the classrooms of the Apthorp and Kilburn Schools alone amounted to 2,500 or twice the 1942 count. This service of the library is an important one for it brings books to children living too far from the library to come often. To carry on this work the children's collection must be added to as extensively as possible; the increased demand leaves the shelves greatly depleted.

A thorough checking of the adult fiction shelves resulted in the discard of a large number of old novels that had outlived their usefulness. Books that had not been borrowed for five years or more, and those with small, unreadable print or in a dirty, torn condition were removed to make room for the new.

A successful Book Week in November featured an "Army" reading contest for the fifth and sixth grades. More than forty children joined and eighteen became "Generals" having read and reported on thirteen books new to them.

Exhibits included an attractive display for national Music Week of material on New Hampshire musicians arranged by the

Music Lovers' Club. A collection of fine reproductions of famous paintings was borrowed from the State Library at Concord. At Christmas Mrs. McLane of St. Mary's in-the-Mountains School very generously lent the library a similar collection of paintings of the Madonna, the Nativity and other religious subjects. During the year the librarian gave book talks at meetings of the Garden Club, the Colonial Club, and the Girl Scouts.

Gifts of books and money were especially numerous this year. The library is indebted to Mrs. Sylvia Boardman, Miss Edith Glode and Reverend Harvie Zuckerman for their very generous gifts. Our thanks go to them and to all who made gifts.

The librarian takes this opportunity to thank the trustees and patrons of the library for their help and interest during 1943.

Littleton, New Hampshire
Gentlemen:

In accordance with the vote taken at the annual meeting of the Town of Littleton, an audit of the Electric and Water Department has been made by the Division of Municipal Accounting of the State Tax Commission. We submit herewith our report consisting of Exhibits A to E and Schedules A to F.

Scope of Audit

The audit and examination covered the period of twelve months ending December 31, 1943. The examination consisted of:

- (1) An inspection of certain Plant Fixed Assets and Inventories.
- (2) An analysis of Current Assets of the Water and Electric Departments.
- (3) An examination of Customers' Deposits and Investments.

- (4) An examination of the vouchers, cancelled checks and supporting data.
- (5) A review of the accounting system and an examination of the Income and Operating Accounts.

While the Water and Electric Department is operated as one unit, for the purpose of this report we have treated them separately to show the operations of each department.

ELECTRIC DEPARTMENT

EXHIBIT A

FIXED ASSETS

An analysis of this account indicates:

Total Fixed Assets	\$277,735.92
Less: Depreciation Reserve	81,447.36

Total Depreciated Assets	\$196,288.56

Depreciation Reserve appears to be adequate and amounts to 31%. However, this figure does not include the cash reserve set forth in this exhibit under the title of Replacement Fund in the sum of \$27,693.63.

RESERVES

While the reserves appear to be adequate it is our opinion that they should be broken down into their appropriate divisions in order that the accounts reflect the amount of reserve applicable to each division of fixed capital, such as Hydro Generating Equipment Reserve, Transmission and Distribution System Reserve, General Equipment Reserve, etc. This can only be done by a study of fixed capital which should be worked out some time in the future. When accomplished, rates of depreciation applicable to different classes of assets may then be applied and reserves to date be known for each unit of fixed capital.

CURRENT ASSETS

CASH

The Treasurer's account was examined in detail and the bank account reconciled with the cash book balance at December 31, 1943 (Schedule A-1). It will be noted that cash on hand and in banks amounted to \$32,153.01, not including Replacement Fund Cash.

REPLACEMENT FUND \$27,693.63

This fund consists of cash in Deposit in Littleton Savings Bank which we have examined and verified.

We would suggest that the purpose of this fund be clarified to some extent. It is not quite clear to us as to whether or not the fund is to be used for replacements *only* or whether or not it is to be used for new construction also.

Electric Department

The analysis indicates that approximately 94% of the accounts are in a current position. It would seem advisable, however, to set up a small reserve for possible loss on uncollectable accounts.

INVENTORIES

Inventories of supplies and materials on hand in the Electric Department have not been recorded in the records as balance sheet assets. Practice in prior years was to charge these to expense accounts. The present management feels that when an inventory of such materials and supplies is finally concluded, it should be recorded on the records and credited to the proper accounts. We suggest that this be done within the next calendar period.

CUSTOMERS' DEPOSITS

Original deposits to this account at December 31, 1943 amounted to \$3,088.85. Interest credited to the fund amounted to \$278.80, a total of \$3,367.65.

INVESTMENTS

During the year the department purchased a \$1,000.00 United States Savings Bond, Series G.

CURRENT LIABILITIES

Other than amounts due Collector of Internal Revenue for the last quarter withholding taxes, current liabilities are negligible. Accounts of Liberty Mutual Insurance Company, New England Telephone & Telegraph, and Connecticut River Power Company were examined and compared with the same situation at the end of the previous year. Of the following accounts we have included only the amount due the Collector of Internal Revenue:

Net profits for the year in the Electric Department amounted to \$43,962.56 after deducting depreciation charges and pro-rated share of general expenses. For the purpose of a division of general expenses between the two departments, it was decided that the Electric Department should be charged with at least 75% of all general expenses.

The above appears to be a reasonable division in our opinion, particularly if it is compared to the sales ratio of the

two departments, or respectively:

The bulk of depreciable assets in this department is represented by transmission mains in the sum of \$274,439.48 and Water Supply Land, the latter item not subject to depreciation. In view of the fact that mains have a long life, the reserve set up at present appears to be adequate. However, until further study of fixed assets is completed, and reserve account divided among the various units of assets, it is not known to which unit the reserve applies. Present reserve amounts to 28% of Fixed Depreciable Assets.

CURRENT ASSETS

CASH

All cash receipts and payments account of the Water Department are contained and reflected in the Electric Department balance sheet, Exhibit A, with the exception of \$2,467.11, which is retained.

Long term debt was reduced by \$3,695.51. Final payment of \$2,695.51 on Blandin Tract Bonds was made during the year, and Sedimentation Tank Bonds reduced by \$1,000.00. All cancelled bonds and notes were examined.

SURPLUS (EXHIBIT D)

Profit in the Water Department amounted to \$8,504.55 for year ended December 31, 1943. Of this amount \$5,902.62 was utilized as a contribution to Electric Department surplus, and the balance retained. The net increase in surplus amounted to \$2,601.93.

General Comments

FIXED CAPITAL AND RESERVES

In connection with the above account we believe that fixed capital should be sufficiently analyzed for the purpose of ascertaining the units of equipment and their corresponding reserves. Depreciation rates may then be established and applied through the life of the equipment.

We suggest in connection with accounts receivable that a small reserve for uncollectable accounts be set up. While this does not need to be large, it should be considered.

INVENTORIES

Materials and supplies should be released from stock on

properly authorized requisitions, priced by the management before charges are made to expense or capital accounts, as the case may be. The present practice does not, in our opinion, conform to good accounting practice.

ACCOUNTS PAYABLE—BILLS

Care should be exercised that all purchases made are scrutinized carefully for the purpose of controlling charges to expense and capital. It is comparatively simple to analyze purchases for proper charges to—

- (1) Fixed Capital
- (2) Inventories
- (3) Operating Expenses

SURPLUS ACCOUNTS

Inasmuch as it is necessary to divide this account between Water Surplus and Electric Surplus for the purpose of Public Service Commission Reports, it would be advisable to make this division as of December 31, 1943.

REPLACEMENT FUND CASH

The purpose of this account should be discussed and clarified by the Commissioners, and, if the account is to be used for general purposes, the title of the account should be changed.

EXEMPTIONS FROM FEDERAL AND STATE TAXES

Under the provisions of the 1942 Revenue Act, states and subdivisions of local government are exempted from the payment of excise taxes levied on purchases of certain commodities by the federal government. The exemption also applies to the transportation of property and certain services.

Municipalities should continue to secure the exemptions to which they are entitled from the federal excise taxes. As a general rule, cities and towns should not pay the taxes but

they should file a properly executed certificate of exemption with the merchant or dealer from whom they make the purchase. They should also require that invoices show the gross price, the amount of the tax, and the net price to the municipality. The exemption certificate is routed back to the person or firm which paid the tax, and with the certificate the original taxpayer is able to secure a refund.

GENERAL ACCOUNTING SYSTEM

We believe the accounting system in use, subject to the foregoing suggestions and exceptions, is adequate and well carried out by the management and personnel.

PUBLICATION OF REPORT

The provisions of Section 31, Chapter 211, Laws of 1939, require that this report or a summary of its essential features shall be published in the next annual town report. This letter of transmittal should be included in its entirety, but the inclusion of schedules is optional.

CONCLUSION

We extend our thanks to the officials and employees for the time and cooperation given during the course of our audit.

Report of Board of Education

To the Citizens of Littleton:

We herewith submit the annual school report. The report includes treasurer's report for the fiscal year July 1, 1942 to June 30, 1943, the report of the Division of Municipal Accounting of the State Tax Commission, an itemized statement of expenditures for that year; the budget for the present school year and for the next year; statement of estimated receipts for these two years; and written reports by the superintendent of schools and by the headmaster of the high school.

The appropriation last year of \$66,000.00 was not enough to meet the rising costs of salaries, fuel and other school materials. The proposed budget for next year is \$70,231.00. With an estimated deficit of \$1,335.00 the total demand for school purposes is \$71,566.00. The estimated receipts total \$3,075.00. The difference is \$68,491.00. We recommend that the district raise the sum of \$68,500.00 for all school purposes.

Superintendent's Report

To the School Board:

I am pleased to submit the following report relative to your schools:

The enrollment of pupils this year is the smallest for many years. The enrollment to date is, 598. Last year, not including the kindergarten, the enrollment was 658, and the year before that it was 710. The high school enrollment this year is 209 and last year it was 243. The enrollment by grades follows:

The enrollment in Littleton schools will not increase during the war period. Last year I wrote that the decrease in enrollment was so uniformly spread through the grades and buildings that no consolidation of grades or elimination of high school classes had seemed wise. The situation in the elementary buildings seems the same this year. In the high school building the additional teacher time given to the physical education program for the boys and the girls has been equal to the time saved by combining groups because of reduced membership. If it becomes necessary to reduce the number of teachers to save money you will have to decide whether you will omit this new, vitally important physical fitness program or whether you will omit from your regular program some of the subjects important for college preparation or some of the practical arts subjects. I would strongly urge the continuance of the physical fitness program as long as you can secure well trained teachers for it and no important change in the regular curriculum during the immediate future. The town's population and the school enrollment may return to higher levels after the close of the war. Some new subjects may replace some now in the courses of study but the teacher need will doubtless be as great as at present or as during the most recent years.

The report of the school nurse shows the following: Number of pupils examined 591, pupils underweight 129, defective vision 63, defective hearing 1, defective teeth 81, diseased tonsils 11, miscellaneous ailments 13. Pupils receiving treatment during the last school year included: dental care 188, vision 65, hearing 1, cardiac disease 5, pulmonary disease 6, other ailments 2. The following clinics were held: tonsil, vision, dental, orthopedic, and T. B. chest. Special physical examinations were given the members of the athletic teams.

Milk was served in all schools in accordance with the Penny Milk plan of the Federal Food Distribution Administration. The milk program of last year is being continued this year.

Undernourished children who cannot pay for the milk get it free. The Community Nursing Association from its milk bottle collections makes up the deficit of the free milk.

Last year the Food Distribution Administration sent to the schools apples, canned grapefruit, evaporated milk, and some other food products. This year no surplus food products are available. Provision has been made, however, to furnish hot soup or cocoa to those pupils in the high school and Kilburn buildings who stay during the noon hour.

The teacher situation has been a serious problem during the past year. Thousands of trained teachers have been inducted into the armed forces or have entered other types of employment. To secure well trained teachers has become extremely difficult. The schools in Littleton have been more fortunate than many in securing the necessary replacements. The high school has six new teachers this year. Mr. Winfred E. Stoddard, a graduate of the University of Maine, with several years of successful experience in Maine, is teaching chemistry, aeronautics and history. Mr. Antoine A. Fournier, a graduate of the University of New Hampshire, is teaching history, civics, and general science. Mr. Otis G. Martin, a recent graduate of Keene Teachers College, is teaching woodworking.

Mrs. Ellen C. B. Miller, with degrees from Mt. Allison University and McGill University and several years of experience in high school and college teaching, was selected to teach English. After a few weeks in Littleton Mrs. Miller was forced to retire because of ill health. Mrs. Ruth R. Lewis has resigned from membership on the school board and has accepted this position.

Miss Ethel M. Eastman, a graduate of Plymouth Teachers College, with summer courses at McGill University and the University of California, and with experience in Meredith and Bristol High Schools, is teaching French and Latin.

Miss Annette L. Stoehr was secured for the other English

position. Miss Stoehr is a graduate of Bates College where she had major courses in English and in physical education. She has charge of the physical education program for the girls.

Two vacancies had to be filled in the Apthorp School. After Miss Cree's resignation Miss Dorothy B. O'Neill was appointed principal of the building. Miss Pauline A. Spitzner, a Plymouth graduate with several years of experience in Campton and Groveton, was selected to teach in grades seven and eight. Miss Barbara Tracy, also a Plymouth graduate with several years of experience in Conway, was secured for grades three and four. Miss Tracy has since resigned and Mrs. Ruth Stafford Colby is completing the year.

In the Kilburn building Miss Dorothy A. Jacques, a graduate of last year's class in Plymouth, was selected to teach in grade four.

The schools had no music supervisor until the first of November. Mrs. Ruth Ellingwood Wells then returned to Littleton for the duration of the war and accepted the position. Mrs. Wells is a graduate of the music supervisory course of Keene Teachers College and taught music very successfully in Lancaster for several years.

The Army and Navy since the beginning of the war have urged high schools to offer an elementary course in aeronautics, to extend as much as possible their courses in science and in mathematics, and to emphasize the need of mastery of these subjects by all boys about to enter the armed services. Your high school already had in its program four years of science and four years of mathematics. For the benefit of those seniors who had not taken advantage of all their opportunities the school organized two groups in mathematics during the last half of last year—one in functional algebra for those who had previously taken algebra and one in general mathematics for those who had taken no courses in mathematics in high school. The school also organized a short course in elementary electricity and one in radio instruction.

This year an attempt has been made to bring as many of the boys as possible into the regular mathematics classes and to meet in the advanced classes the army and navy requirements as completely as possible. This has also been done in the courses in chemistry and physics. The course in aeronautics is being repeated, with additional equipment. A new pre-induction course in the fundamentals of machines and electricity is being given this year, open to boys in the senior and junior classes. The course in U. S. Constitutional History is being given to juniors as well as seniors in order that all boys may have it before induction.

Some other courses have reduced enrollments this year because of the emphasis on the above. The course in economics is not being given. Sociology is being offered to seniors. Some changes in the high school curriculum will need to be considered if the emphasis on science and mathematics continues after the war. With the present subject requirements the high school pupil of average ability does well in four subjects each year. English has been and should be a required subject. How large shall the school's offering outside of English and science and mathematics be? Some changes will doubtless be needed.

The recommended program in physical education for physical fitness was very well organized last year by Mr. Toll. He has extended that program somewhat this year. The benefits are already plainly evident. This program should continue. It should be an integral part of the school's program after the close of the war. While it has not been required of all boys, ninety-five per cent of them have profited from it. The girls' physical fitness program was also organized last year. That is being extended very much this year. Over eighty per cent of the girls voluntarily take this course and profit therefrom. Health, physical fitness, is as important for girls as for boys.

Last year I related some of the efforts of schools in the

civilian defense program. Teachers and pupils continue to assist whenever possible in helping win the war. Teachers with the help of some other citizens conducted the registration for War Ration Book II and for War Ration Book IV during the past year. The sale of stamps and bonds continues at a noteworthy pace in the schools. Red Cross Home Nursing courses have recently been started in some of the home economics classes. The collection of waste paper is being emphasized at the present writing. Teachers in all the schools are trying to relate the different activities of the war program to their classroom subjects. Current events papers are provided for all of the schools. Classroom discussion and evidences of patriotic living show that even the youngest school pupils realize to some degree how near to them and how grim this war is coming to be. They have brothers and sisters or neighborhood heroes in action. They, too, try to serve.

Since last year's report was written you have revised your action relative to granting high school diplomas to boys in service who have completed more than three years of school work. Regular diplomas were given to the four seniors who entered the army or navy during last school year. Your present plan is to give a special war certificate diploma, showing number of units completed at time of leaving school, to those members of the senior class who are inducted into the armed services. You have cooperated with the Army and with the Navy in providing for examinations and in sponsoring special correspondence courses for the seniors who have passed these examinations. You have also voted to give diplomas in accordance with the Vocational Agricultural Program of the University of New Hampshire. By that plan a high school boy who has completed two or three years of work may enroll for this course in agriculture, complete certain required high school subjects at the University, while pursuing courses in agriculture, and be granted his diploma by the high school upon completion of those subjects.

Government regulations for school transportation have not changed materially since a year ago. The survey of conditions in New Hampshire revealed but little duplication of distance and relatively minor changes were required. No routes have had to be abolished in this union. Strict rationing of gasoline and tires is effective. Transportation agents have cooperated with the school officials in trying to furnish adequate transportation for all pupils legally entitled to same with a minimum use of gasoline and with proper care of tires and equipment.

Last summer the corridors and three classrooms were painted at the Apthorp building and the home economics rooms at the high school building. Some work was done to improve the heating systems at the Apthorp building and at the high school building. Other minor repairs were made. An attempt was made to improve the grounds at the Kilburn and high school buildings. The bank on one side of the high school grounds was badly washed out during a heavy rain. Adequate protection against further erosion has been provided but the job of grading and returfing has not been completed at this writing. The major items for improvements you should consider next year are the painting of the exterior of the high school building and further improvement to the grounds at Kilburn and the high school.

The budget you adopted a year ago for the present school year has had to be revised in several items. Higher salaries have been necessary. Fuel and the cost of repairs and school materials have been somewhat increased. The appropriation last year was \$66,000.00. It was not enough to complete this year with its rising costs. The school year may close in June with a deficit as much as \$1,335.00. The budget for next year totals \$70,531.00. With the deficit the demand may be as much as \$71,866.00. The estimated receipts total \$3,200.00. The adoption of this budget would require your recommending an appropriation of \$68,500.00 if the accounts are to balance in June 1945.

The outstanding bonds amount to \$16,000.00. In two more years the bond issue for the high school building will be entirely paid.

Again, I am deeply grateful for your cooperation and your kindness throughout the year.

Headmaster's Report

To the Superintendent of Schools:

I present this, my sixth annual report to you, with the hope that in its paragraphs you may find that which will reflect wholesome progress and sincere endeavor which our high school has made to keep faith with its boys and girls in this world at war.

REGISTRATION

The following table presents a comparison of the total registration for the last two and one-half years:

The decrease of 34 in the senior high and of 6 in the junior high can be accounted for by boys entering the service and by the shift in our town's population due to the war. It can be expected that the current year's total may be increased by a few new registrations during the last half of the present year.

CURRICULUM AND TIME-TABLE

In the senior high school we are giving two one-unit pre-induction courses this year; one in Aeronautics, taught by Mr. Stoddard, and the other in Machines and Electricity taught by the headmaster. The last is a new course this year. To give time for these, eleventh grade Economics has been discontinued for the duration.

Upon recommendation of the State Department of Education, United States Constitutional History is now given in the junior year as well as the senior year. In the modern language department French I has been advanced from the sophomore year to the junior year, with a corresponding advance of French II from the junior year to the senior year.

A standard thirty-hour Red Cross unit in home nursing has been incorporated in the senior home economics course, and a similar unit is being given to the eighth grade girls of our junior high, the Aphthorp School and St. Rose of Lima School. The former is being taught by Mrs. John Hall and the latter by Mrs. William Houle, both registered nurses. These two nurses are generously giving this service to our pupils without remuneration.

There have been no changes in the time-table since last year.

THE WAR PROGRAM

In addition to the two pre-induction courses previously mentioned all of our boys and girls, unless excused by parents' written request, take part in the physical fitness program inaugurated last year by Mr. Toll. A total of 104 boys and 120 girls are enrolled, the former under Mr. Toll and the latter under Miss Stoehr. The program has made rapid and wholesome growth since its start. An outdoor obstacle course has been built at Remich Park and additional gymnasium equipment has been purchased.

One period weekly is devoted to war guidance for seniors. Mrs. Kane has charge of it for the girls and Mr. Toll for the boys.

OTHER WAR ACTIVITIES

The National Honor Society continues to conduct its weekly sale of war savings stamps and bonds. In 13 weeks of the current year the total sales have amounted to \$2,746.70. The highest was \$1,165.20 for the week of January 17, and the lowest \$45.60 for the week of December 13. The average for these 13 weeks is \$211.28 per week.

Last year, in the 30 weeks that the sales took place, a total of \$4,851.00 was realized. The success of our war savings stamp program has given us the *Schools at War* flag, flown daily from our flag pole, as well as several citations from the U. S. Treasury Department.

The junior class in Home Economics is devoting one period per week to surgical dressings, and the foods that are used for laboratory purposes were canned by several of the classes of this department.

Over 80 of our pupils will receive the United States Crop Corps certificates for their patriotic service on farms and assistance in harvesting food crops during the summer and fall months.

Both our English and Social Science departments have been particularly active in emphasizing the ideals of democracy towards the goal of bringing a better comprehension of the peace problems which will confront all of us after this war.

BOYS IN THE SERVICE

Twenty of the thirty boys who graduated last June are in the armed forces of our country.

Four seniors have enlisted in the V-5 program since school

opened last September. Russell Buker, Miles Quigley and Norman Simons are members of this program in the Air Corps and will be allowed to finish their high school course before taking the intensive training that leads to commissions. Joseph Sulham is a member of the Navy V-5 program and is taking his second semester's high school work via state-approved correspondence courses. He expects to complete his school work in February and will begin the navy's intensive program in March.

Four other boys, three seniors, Millard Bresnahan, Richard Duval and George Herbert, and one sophomore, Herbert Blodgett, have joined the armed forces since September.

ATTENDANCE

A comparison of our high school's 1942-43 attendance with the average of all high schools in the state is shown in the following table.

Mrs. Ellen Miller started the present year but was forced to retire in November because of ill health.

ATHLETICS

Our high school firmly believes that the values received from athletics are important and fundamental in the war

effort. Consequently the athletic council provided an athletic program as extensive as possible under war conditions.

A football schedule of five games was played which resulted in five victories over traditional rivals. Large scores were rolled up by our team while its own goal line was crossed but once.

At the date of this report we have completed 7 games of basketball in an 11 game schedule. We have won 6 games and lost 1.

Seventh and eighth grade boys of the Apthorp School, St. Rose of Lima School and our junior high have been organized into teams and hold two weekly practice periods under the direction of Mr. Stoddard.

An intensive intramural girls' basketball program is being conducted by Miss Stoehr, who likewise directed a very successful girls' bowling league during the fall months. The latter, in which about 70 girls participated, was made possible through the courtesy of Mr. John Eames and Mr. Roland Thompson who donated the alleys free of charge.

A winter sports' program is underway and baseball and track are planned for the spring months.

There is approximately a 90 percent school membership in the athletic association with several classes reaching 100 percent.

An important factor in athletics this year has been the girls' "pep" squad, an organization of 15 girls under head-cheerleader Virginia Lee and advised by Miss Stoehr. This squad of 15 cheer leaders have added much to the enthusiasm shown at our varsity contests.

NON-ATHLETIC STUDENT ORGANIZATIONS

The following non-athletic organizations are important in the student life of the school. All are carrying out active

programs similar to those of other years which have been described in previous reports. They are: The Record, the school paper; the orchestra under the directorship of Mr. Wentworth; the glee clubs under Mrs. Wells, and the Littleton Chapter of the National Honor Society.

Physical and health examinations of all pupils have been completed by Dr. Page, assisted by Miss Bryant.

As in past years, hot noon lunches are being served by the home economics department during the winter months. These are available to both the pupils of the high school and the Kilburn School.

Approximately 115 bottles of "Penny Milk" are served to pupils daily.

On Saturdays and school holidays the school gymnasium is extensively used by informal groups of pupils who play basket-

ball and similar indoor games. Teachers on a voluntary basis are present and assume responsibility for these periods.

SCHOLARSHIP AND SCHOOL APPROVAL

In war times as in peace times a high grade of scholarship is a first prerequisite for success in college. Our school enjoys the same approval and certificate privileges as in the past, and, in recent years at least, no pupil has ever been refused college entrance by certificate or similar regular college entrance procedure provided the candidate's record at our school was of certificate grade.
