TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Salisbury in the County of Merrimack in said State, qualified to vote in Town Affairs:

(L. S.)

You are hereby notified to meet at Town Hall in said Salisbury on Tuesday, the eleventh day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To elect one Selectman for three years.

4. To see if the Town will vote to dissolve the present "Board of Trustees of Trust Funds" and elect one "Trustee of Trust Funds" for the ensuing year.

5. To raise and appropriate such sums of money as may be necessary for the Town Budget.

6. To see if the Town will vote to authorize the Selectmen and Town Treasurer to borrow money on notes of the Town in anticipation of taxes.

7. To hear reports of agents, auditors and officers heretofore chosen.

8. To see if the Town will vote to raise and appropriate a sum of money for the control of White Pine Blister Rust. (Estimate \$400.00)

9. To see if the Town will vote to raise and appropriate the sum of Forty-five Dollars (\$45.00) for the purpose of publicizing and promoting the natural advantages and resources of the Town together with other Towns in the Dartmouth-Lake Sunapee Region.

10. To see if the Town will vote to request the Selectmen to publish in the Town Report each year the list of Resident and non-Resident taxpayers and amounts assessed to each taxpayer.

11. (1) To see if the Town will vote to accept and maintain the Mills Cemetery as a public cemetery.

(2) To see if the Town will authorize the Selectmen to accept a quitclaim deed to the Town of the Mills Cemetery Tract subject to the rights of the existing lot owners.

(3) To see if the Town will authorize the Trustees or Trustee of Trust Funds to accept the Trust Fund of the Mills Cemetery Association, upon approval by the proper court.

12. To see if the Town will vote to raise and appropriate the sum of \$596.00 to match \$2,384.01 from the State for Class V Highways.

13. To see if the Town will vote to raise and appropriate the sum of \$500.00 to be added to the Capital Reserve Fund.

14. To see if the Town will vote to accept a set of weights and measures donated to the Town of Salisbury by the late Chas. A. Green of this Town.

15. To see if the Town will vote to raise and appropriate a sum of money not to exceed \$5,000.00 for the purpose of procuring increased fire protection in the form of adequate apparatus and housing.

16. To see if the Town will vote to exchange a certain tract of land now the property of the Town of Salisbury, located west of Highway 4 and east in front of the house known as "Knoll Top" now owned by Russell L. and Henrietta E. Splaine, for a certain tract of land now the property of the above named Splaines located to the

west of the Meeting House, Town Hall, Library and Public School House at Salisbury Heights, said land to be used for school purposes; and to authorize the Selectmen, on behalf of the Town, to have the necessary legal papers drawn and executed to consummate the exchange.

17. To see if the Town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting and to make an appropriation to cover the expense of such audit. (Estimate \$100.00)

18. To see if the Town will vote annually to elect a board of five Fire Commissioners and to accept the rules and regulations that the Fire Commissioners make in regard to the duties of the officers and members of the Volunteer Fire Department and give the Commissioners power to enforce said rules and regulations except financial obligations which shall remain with the Selectmen.

19. To transact any other business which may legally come before said meeting.

SCHOOL BOARD'S REPORT

To the Citizens of Salisbury:

During the past year the School Department has re-decorated the South Road School room. In connection with this we wish to express our sincere thanks to Mr. and Mrs. Charles S. Cornwell for the gift of an upright piano. To the men at the Kearsarge Telephone Company we say thanks for moving the piano to the school.

At the Heights School we installed second-hand desks and are pleased to find that the boys and girls under Mrs. Kenevel's supervision have refinished these desks in their spare time and have done an excellent job. The old desks have been taken apart and the iron work is to be sold and the wood used for shelves at the school. Mrs. Cornwell asked for a few of the old desks and we felt in consideration of the gift of the piano she was more than entitled to them.

Also at the Heights School new toilets were installed and the outside of the building painted.

Because we have been unable to secure capable and trustworthy janitors at both schools and no bids for wood have been forthcoming the past few years we installed oil burners and find they have given more uniform temperatures. We believe the oil will cost no more and maybe less.

The budget for 1947-1948 necessarily shows an increase due to an increase in costs of materials and supplies of about 40%. We have more pupils attending elementary schools and more than ever attending high schools and this accounts for the increase in high school tuition as well as the rates being jumped.

The item of Health Supervision is set by the State Board of Education depending on the number of towns in the nurse's district. This District has one less town than in past years and the nurse is asking for an increase in salary.

Bids for transportation are going up every year and the routes are just as many and as far as in past years with more pupils to be transported than in late years due to mills moving in and out of town and new families.

Teachers' salaries have gone up everywhere and the State Board of Education is setting a minimum of \$1500 per teacher without a certificate and \$1800 per teacher who holds a degree. We feel we are very fortunate in having two exceptionally fine teachers and are anxious to keep them with us. Teachers that are graduating from the normal schools this June are asking a minimum of \$1800 and will not accept positions in rural schools.

Under the item of other obligations, we must pay, by State Law, to the Teachers' Retirement Board 5% (maybe 6%) of the salary of any teacher who belongs to this group; we have one such teacher. This item also includes Administration expenses for your School District and Salisbury's share of a clerk and expenses in the superintendent's office at Penacook.

We wish to express our sincere thanks to all who have helped in the programs and entertainments. Also to Mrs. George Beaully who has given two afternoons each week to accompany the children at the piano, and who has helped so much with the music at the South Road School.
