#### TOWN WARRANT

To the inhabitants of the Town of Seabrook, qualified to vote in Town affairs:

You are hereby notified to meet at the Lower Hall of the Seabrook Firemen's Association Building on Collins Street on Tuesday, March 12, 1957 at 10 o'clock in the forenoon to act upon the following subjects:

Article 1. To elect by Australian ballot; a Town Clerk, One Selectman, Assessor and Trustee of the Trust Funds for a term of Three years; Town Treasurer, Tax Collector, Three Constables and any other officers for the ensuing year.

Article 2. To see what sums of money the Town will vote to raise and appropriate for the expense of the General Government, for the protection of Persons and Property, for Health and Sanitation, for Highways and Bridges, for the support of the Town Poor, and all other necessary expenditures for the ensuing year.

Article 3. To see if the Town will vote to allow the Selectmen to borrow money in anticipation of Taxes and to renew and refund Town notes.

Article 4. To see if the Town will vote to purchase a truck and load packer to be used for refuse and garbage removal at a cost not to exceed Nine Thousand Dollars (\$9,000), and to raise and appropriate the sum of Three Thousand Dollars (\$3,000) for the current year, and to borrow the sum of Six Thousand Dollars (\$6,000), and to issue and sell in connection with such borrowing notes or bonds of the Town of Seabrook in the principal amount not exceeding Six Thousand Dollars (\$6,000), said notes or bonds to be issued pursuant to the Municipal Finance Act as amended, payable

exclusively from funds to be raised from taxation, to bear interest at a rate not exceeding Five Percent (5%) per annum payable semi-annually, maturing during a two year period, the first installment to be payable one year from the date of said notes or bonds, to be sold for not less than par, the time and place of payment of principal and interest, the fixing of the rate of interest, the provisions for the sale of the notes or bonds and all other matters in connection therewith to be left to the discretion of the Selectmen; the purchase of the truck and load packer to be under the direction of the Selectmen.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$25,000.00, and issue Serial Notes or Bonds under and in compliance with Chapter 33, New Hampshire Revised Statutes annotated (1955) and amendments thereto, in the principal sum not exceeding \$25,000.00 for the purpose of permanently resurfacing, permanently repairing, and otherwise permanently improving the Highways in the Town of Seabrook and to authorize the Selectmen to determine the time and place of payment of such bonds and the rate of interest thereof and to do whatever may be necessary to the issuance thereof.

Article 6. To see if the Town will vote to authorize the Selectmen to purchase the wing plow which is now being leased by the Town, and to raise and appropriate the sum of \$635.00 therefor.

Article 7. To see what action the Town will take relative to mosquito control for the current year, and to raise and appropriate money for same.

Article 8. To see if the Town will vote to accept from the School District of the Town of Seabrook for the sum of One Dollar the land and buildings on South Main Street, commonly known as the South School.

- Article 9. In the event that Article 8 is adopted, to see if the Town will vote to authorize the Selectmen to put the same to some municipal use or lease the premises for not more than one year.
- Article 10. To see if the Town will vote to authorize the Selectmen to pipe and sell water from the Municipal Water System to that part of Hampton Beach which lies southerly of Hampton River.
- Article 11. To see if the Town will vote to authorize the Selectmen to pipe and sell water to such parts of the Town of Hampton Falls as they may determine.
- Article 12. Inserted at the request of the Seabrook Beach Village Commissioners: To see if the Town will vote to install a street light on each of the following named streets, and to raise and appropriate money for the same: Suncook St., Concord St., Tilton St., and Ashland St.
- Article 13. To see if the Town will vote to install a street light at the Easterly end of Nashua St., and to raise and appropriate money for same.
- Article 14. To see what action the Town will take regarding balances of the following Special Appropriations: Ball Park Special \$34.06, Radio Equipment Special \$28.77, Cross Beach Road Special \$300.00 and Sidewalks Special \$38.92.
- Article 15. To see what action the Town will take regarding the balance of the Special Street Sign Appropriation of \$423.77.
- Article 16. Upon petition of Albert M. Smith and 12 others: To see what action the Town will take in providing a Recreation or Youth Center, and to raise and appropriate sums of money for same.

Article 17. Upon petition of Donald H. Fowler and 26 others: To see if the Town will vote to raise and appropriate the sum of \$1,000.00 (One Thousand Dollars) for construction on Pine Street.

Article 18. Upon petition of Nellie P. Randall and 11 others: To see if the Town will vote to raise and appropriate the sum of Forty Four (\$44.00) Dollars to install a street light on Pole No. 335J on Worthley Avenue.

Article 19. Upon petition of Florence B. Eaton and 10 others: To see if the Town will vote to raise and appropriate the sum of Forty Four (\$44.00) Dollars to install a street light on Pole No. 278J on Washington Street.

Article 20. Upon petition of Marilyn I. Rogers and 20 others: To see if the Town will appropriate the sum of \$44.00 to install and maintain a street light on Walton Street on Pole No. 241J.

Article 21. Upon petition of Bella P. Janvrin and 11 others: To see if the Town will vote to raise and appropriate the sum of Forty Four (\$44.00) Dollars to install a street light on Pole No. 589J located on Boynton's Lane so called.

Article 22. Upon petition of Edward F. Goodwin and 17 others: To see if the Town will vote to install two street lights on Folly Mill Road on Pole Numbers 223J and 375J, and to raise and appropriate money for same.

Article 23. To hear the report of the Planning Board and to act thereon.

Article 24. To hear the report of the Water Committee and to act thereon.

Article 25. To transact all other business that may legally come before said meeting.

## AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from depository banks. Verification of uncollected taxes was made by mailing notices to delinquent taxpayers as indicated by the Collector's records.

#### GENERAL COMMENTS

#### Current Deficit:

The current financial condition of the Town changed from a current surplus of \$538.06 to a current deficit of \$1,045.45 during 1956 as shown by the following statement:

## Closing Accounts:

The accounts of all town officials should be closed as of December 31st, and should not be held open for more than a week or ten days after that date. It is noted that checks dated December 31, 1956, were issued as late as February 11th, 1957. It is also noted that deposits of funds on account of the 1956 fiscal year were made as late as February 13th, 1957.

#### Payment for Tax Sale:

When the Town buys the taxes at the Collector's sale, a check in payment thereof should be given to the Collector immediately ofter the sale is held. The check for the tax sale held in 1956, amounting to \$5,709.07 and dated December 31, 1956, was not actually issued until February 11, 1957. Consequently, the Collector reported this check as cash on hand in making up her statement for the fiscal year of 1956.

#### Reconciliation of Treasurer's Balance:

At the close of each month, the Treasurer should reconcile the bank balance with the cash book balance.

#### Transfers of Funds:

When transfers of funds are made between the general fund account and the water fund account, proper entries covering such transactions should be made in the books of each fund account.

#### Interest on Funds:

Interest received on invested funds of the water account should be recorded as a receipt item in the Treasurer's water fund records.

## REPORT OF BOARD OF SELECTMEN ON THE WATER DEPARTMENT

This past year has seen the Town of Seabrook enter the Water Works Business.

With the aid of the engineers, we have been able to select a waterworks foreman in the person of Douglas Perkins, and to set up also, office procedures, materials and equipment for the operation and maintenance of this new department.

The Board is well aware of its responsibility to the townspeople in the financial management of this town asset and will exercise its authority to see that expenditures will be in the best interest of the town as a whole.

Although the town authorized the expenditure of \$720,000 for the installation of a water works system, due to the town's low valuation, only \$628,000 could be borrowed.

This decrease in available funds caused both the engineers and this board great concern, until the bids that had been prepared by Whitman & Howard engineers of Boston on materials and construction had been opened. By the selecting, and awarding of contracts to all the low bidders, the original plan was installed within the \$628,000 figure as well as extensions that amount to about \$35,000.

Martin Mailet was the low bidder on the pipe main installation and since December 15, 1955 has installed the 19 miles of mains, along with 40,000 feet of service piping to about 600 water takers. It is estimated that within the first year of operation the Water Department will have over 700 customers.

Two local contractors were low bidders on portions of the work. Dow Construction Co., built Standpipe Foundation, and Rodney Girouard constructed the two Pumping Stations, that house the pumps. Pittsburgh-DesMoines was low bidder to furnish and erect our 720,000 gallon storage tank, while Porter & Desmond dug our 2 wells.

The electric pumps at these wells are rated respecttively for 450 and 250 gallons per minute and have auxiliary gasoline engines to take over in case of power failure.

Whitman & Howard, our engineers from Boston, furnished two field men to supervise the water works installation. We are grateful to them for not only their co-operation and personal interest in our town, but also, for their time and energies in teaching our foreman best methods of maintenance and operation and our clerk on office procedure.

The Board extends its sincere thanks to the Police, Fire, and Highway Departments for their help and co-operation throughout various stages of the construction.

To the people in town, who have been inconvenienced by this construction, we offer our heartfelt thanks for your patience and understanding.
