- 6. To see what sum of money the town will vote to raise and appropriate for the maintenance of town highways and bridges.
- 7. To see what sum of money the town will vote to raise and appropriate for police.
- 8. To see what sum of money the town will vote to raise and appropriate for fire protection.
- 9. To see what sum of money the town will vote to raise and appropriate for fire trails and fire roads.
- 10. To see what sum of money the town will vote to raise and appropriate for insurance.
- 11. To see what sum of money the town will vote to raise and appropriate for the library.

- 12. To see what sum of money the town will vote to raise and appropriate for public welfare.
- 13. To see if the town will vote to observe Old Home Week during 1956 and raise and appropriate a sum of money therefore.
- 14. To see what sum of money the town will vote to raise and appropriate for the general care and upkeep of the Town Memorial Forest.
- 15. To see what sum of money the town will vote to raise and appropriate for the care of cemeteries.
- 16. To see what sum of money the town will vote to raise and appropriate for the town's share of co-operative participation in the White Mountains Region Association.
- 17. To see what sum of money the town will vote to raise and appropriate for the use of the Roadside Improvement Committee for the care, improvement and upkeep of the town's roadsides.
- 18. To see what sum of money the town will vote to raise and appropriate for the control of blister rust.
- 19. To see what sum of money the town will vote to raise and appropriate for Civil Defense.
- 20. To see if the town will vote to raise and appropriate for Town Road Aid, the sum of \$3,450.00.
- 21. To see what sum of money the town will vote to raise and appropriate for interest on notes.
- 22. To see what sum of money the town will vote to raise and appropriate for new Equipment for the Town Garage.
- 23. To see if the town will vote to plow all driveways of Citizens over 70 years of age, free of charge.
- 24. To see if the town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by the town through tax collector's deeds.
- 25. To see if the town will authorize the Selectmen to distribute the inventory blanks when taking valuation.

- 26. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

### SCHOOL WARRANT

### THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the School District in the Town of Shelburne qualified to vote in district affairs:

You are hereby notified to meet at the Town Hall in said Shelburne on the 14th day of March, 1956 at 7:30 o'clock in the evening to act upon the following subjects:

- 1. To choose a moderator for the ensuing year.
- 2. To choose a clerk for the ensuing year.
- 3. To choose a member of the school board for the ensuing three years.
  - 4. To choose a treasurer for the ensuing year.
- 5. To determine and appoint the salaries of the school board and truant officer and fix the compensation of any other officers or agents of the district.
- 6. To hear the report of agents, auditors, committees, or officers heretofore chosen, and pass any vote relating thereto.
- 7. To choose agents, auditors, committees, in relation to any subject embraced in this warrant.
- 8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officers and agents, and for the payment of statutory obligations of the district and to authorize the application against said appropriations of such sums as are estimated to be received, the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.
- 9. To see if the District will raise and appropriate \$100.00 to buy a piece of land, located east of and adjacent to the school lot, from Chester Hayes.

- 10. To see if the District will raise and appropriate a sum of money not to exceed \$500.00 to complete approximately one-half of the loaming and grassing of the school playground.
- 11. To see if the District will raise and appropriate the sum of \$400.00 for installation of an oil burner in the school house.
- 12. To see if the district will vote to adopt a plan for extending to employees of the district the benefits of title II of the Federal Social Security Act (Old Age and Survivor's Insurance) as authorized by Chapter 101 of the Revised Statutes Annotated Amended by Chapters 301 and 332 of the Laws of 1955 and to raise and appropriate the sum of \$45.00 to defray the district's share of the cost thereof.
- 13. If a plan for Social Security coverage is adopted, to see if the district will authorize the School Board to execute on behalf of the district the necessary agreement with the State of New Hampshire to carry into effect the plan and to see if the district will designate the School Treasurer as the officer to be responsible for the administration of the plan.
- 14. To see if the district will appoint a committee to study the possibilities of forming a Cooperative School District consisting of Gorham, Randolph and Shelburne, and report back at a later meeting.
- 15. To transact any other business that may legally come before this meeting.

The Supervisory Union Board decides the local share of the superintendent's salary and other union expenses. The district's share of the superintendent's salary for 1954-55 was \$262.50. Other towns in the union contributed as follows: Dummer, \$218.75; Gorham, \$2.625.00; Jefferson, \$568.25; Milan, \$525.00; Randolph, \$223.00. These amounts are more than was raised for this purpose by the 1954-55 budget because of duplication of salary for Mr. Knightly for the month of May, 1955. By state regulations, he was entitled to 30 days leave which he accumulated and the union had to contribute to this cost. The State Treasurer reports the amount of per capita tax. The Teacher's Retirement Board assesses the amount for teachers' retirement and the State Employees Retirement Association assesses the amount for the Superintendent's retirement.

## REPORT OF SUPERINTENDENT

To the Superintending School Committee and the Citizens of the Shelburne School District:

#### Foreword

The aims of our schools cannot be separated from those of society, since education is one of the bases on which society rests. It has been a fundamental principle of American democracy that we should have free public education in this country. Without an enlightened citizenry, our nation would not have grown to its present heights. In New Hampshire we generally agree that schools should provide the best education possible for each child, whatever his ability might be. Since the ability of every child varies, we should provide the best possible education to fit his individual needs. Our schools must make provisions to handle the bright, the dull, the lazy, the industrious, the shy, the bold, the practical and the artistic.

In the short time that I have served as your Superintendent, I would conclude that the schools of Union No. 20 do a good job in teaching the fundamental skills (the three R's). Tests that have been given prove this to be true. We should certainly maintain this good record and, if possible, show some improvement.

There is nothing that will take the place of a firm know-ledge of the skills. However, there are some areas in which we should be doing more than we are at the present time. Students need more aid in the area of guidance—academic, vocation and social. More time could be spent profitably in the fields of music, art and speech. These are not educational "frills" as some people would like us to believe, but are ways in which we can hope to accomplish the aims of education. What are these aims? Very briefly, I would list them as follows:

1. Mastery of the basic skills and tools of knowledge—the three R's.

- 2. Becoming a good citizen.
- 3. Being able to enjoy physical and mental health and understanding the laws of hygiene.
  - 4. Appreciating art, music and literature.
- 5. Being able to provide for needs by employment in the professions, industries, the arts and the sciences.
  - 6. Being able to use increased leisure time wisely.
- 7. Being able to understand the physical aspects of our world—a knowledge of science.
- 8. Being tolerant of others, regardless of race, creed, or color.

These aims mean that we must provide both an academie and realistic atmosphere in our schools. While we cannot neglect the traditional type of education, we must also provide practical learning that will fulfill the needs of those students not going on to schools of higher learning.

With an ever-increasing enrollment in our schools and the holding power of the school growing, we have serious problems facing us. They can be solved only through a sincere interested citizenry who are willing to face the problems and attempt to do something about them.

#### Teacher

Miss Madeline Lary served as teacher again in the Shelburne School. This completes six years of service in our district for Miss Lary by counting the years served between 1944-46.

#### Enrollment and Attendance

There are at the present time 20 pupils enrolled at school. This is the same number as last year but it is well to note that the sixth grade is now attending the Gorham schools. This move was made to decrease the number of different classes that the teacher would have to meet daily. This enables more concentration on the lower grades where there is more demand on the teacher's time. Next year, in keeping with the recommendation of the Citizen's Study Committee, Grade five will also attend the Gorham schools, but we still will have an enrollment increase in the local school. The following is the projected enrollment for the Shelburne school, Grade 1 to 4, based on the last census report:

Percentage of attendance showed an improvement during the past year with a figure of 95.0 per cent. However, the total number of tardinesses also showed an increase, with a total of 13.

#### Tuition

At the present time, we have 22 attending school outside the district, all in Gorham, from grades six through twelve. With only one in the senior class and an entering group of four in grade five next year at Gorham, we can expect about thirty one tuition pupils for the year 1956-57. This represents the largest increase in the budget, but this number should level off some starting the following year as there are 3 in the present eleventh grade.

Tuition rates at Gorham for the year 1956-57 are \$200.00 for the elementary grades and \$300.00 for the high school.

## Notes on the Budget

The amount asked by the school board to be raised for 1956-57 is \$17,157.79, compared to \$14,305.00 raised this last year. As mentioned above under tuition, this figure represents an increase of \$2,375.00. Another item which causes an increase in the budget is new equipment. With the purchase of new desks for the school, the interior of the building should be quite adequate for several years. There is also an increase in the amount asked for repairs and replacements. The building needs a coat of paint, repairs to the front porch and new treads on the indoor stairs.

#### Warrant

The School Board has included several special articles in the school warrant this year. One is for purchase of land east of the building which has been used by the school for many years, and actually has not belonged to the district. The second article is for a sum of money to complete half of the loaming of the playground. As one rides by the school and sees the use of this new playground area by the pupils, one can appreciate its value to the life of the school. Loaming of this area will not only make it a better place to play but will add beauty to the school and will aid in protecting the floors.

An article is included also for the purpose of installing an oil burner in the school. Such an installation would not only provide more even temperature in the room, but would give the janitor more time for cleaning and doing minor repairs about the building. Two articles are included to give district employees coverage under the Social Security program. This would enable district employees, eligible for Social Security, to have some retirement protection not available to them prior to this time. The district is also being asked to appoint a committee to study the possibilities of a Cooperative School District consisting of Shelburne, Gorham and Randolph. This type of organization has advantages to each district and should be investigated. The committee would be instructed to report back its findings at a later meeting.

#### Conclusion

Because this report is being made for the year 1954-55, most of the details happened during the time my predecessor, Mr. Albert Knightly, served as your superintendent. I would like to take this opportunity to say that I was fortunate in following a man of his ability and efficiency. His work certainly gave me a solid foundation on which to look forward to the future in Union No. 20.

I would also like to express my appreciation to the members of the School Board, the parents, teachers, students and friends for their cooperation and help. With the same feeling continuing, I am sure that we can maintain our good schools and also hope to improve them.
