THE STATE OF NEW HAMPSHIRE

TOWN WARRANT

To the inhabitants of the Town of Westmoreland in the County of Cheshire in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Westmoreland on Tuesday, the 10th day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same
3. To see if the Town will vote to accept the budget as submitted by the budget committee under the authority of the municipal budget act. (This budget may be considered item by item or as a whole but may not be increased more than ten percent in any item as a whole.)
4. To hear the reports of agents and auditor and take any action thereto.
5. *To see if the Town will raise and appropriate the sum of \$475.00 as its fair share of the operating cost of the Elliot Community Hospital.
6. To see if the Town will vote for snow removal and sanding on either Class V or Class VI roads or take any other action relating thereto to raise and appropriate money for the same.
7. To see if the Town will vote for Class IV and Class V roads; construction, reconstruction or betterment aid and raise and appropriate the sum of \$704.89 which is 15%

of the State apportionment, and the State contributing \$4,699.30.

8. To see what sum of money the Town will vote to raise and appropriate in addition to what is required by law for highways and bridges.

9. To see if the Town of Westmoreland will vote to accept the sum of \$100.00 to be known as the Jessie N. Ball Joslin Trust Fund for the Lovell G. and Elizabeth Reynolds Keith lot in North Cemetery of Westmoreland, N. H., the income from same to be used for the upkeep and perpetual care of the Lovell G. and Elizabeth Reynolds Keith lot in the North Cemetery.

*10. To see if the Town will vote to require the publishing in the Town Report each year of information concerning timber cut in the town in accordance with Chapter 79 R. S. A. Laws of New Hampshire. Such information to include the name of owner, the amount cut, and the tax paid.

*11. To see if the Town will authorize the Selectmen to publish a complete list of property taxes in the Town Report every year.

12. To see what disposition the Town will vote to make of the income of the Jotham Lord Fund.

13. To see if the Town will raise and appropriate the sum of \$300.00 for the support of the library.

14. To see if the Town will raise and appropriate the sum of \$150.00 for the upkeep of the cemeteries

15. To see if the Town will vote to raise and appropriate the sum of \$125.00 to be spent under the direction of the selectmen for resetting and repairing the monuments in the cemeteries in Westmoreland.

*16. To see if the Town will vote to raise and appropriate the sum of \$250.00 to buy culvert and straighten the sharp corner on the hill of Olin Clayton's road.

*17. To see if the Town will vote to raise and appropriate the sum of \$850.00 to finish the permanent top on London Hill Road to Route #12.

*18. To see if the Town will vote to raise and appropriate the sum of \$250.00 to buy culvert and fix the approach to Cooke's Road from Route #12.

*19. To see if the Town will vote to have the N. H. State Tax Commission reassess the Town's taxable real estate under the Tax Commission's reappraisal program or take any action relating thereto.

20. To see if the Town will raise and appropriate a sum not to exceed \$200.00 for a garbage disposal unit for use in the Town Hall.

21. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to be used with the \$500.00 already raised to widen and repair the Aldrich Bridge on the lower Walpole road.

*22. To see what action the Town will take relative to straightening out and eliminating the hazards on the South Village-East Westmoreland Road starting at Starkey's Corner, Nim's Pond area and Jenkin's Hill.

*23. To see if the Town will vote to relocate the Atherton Bridge, so-called, and straighten the approaches thereto and to raise and appropriate the sum of _____ from current revenues and to borrow to be amortize at the rate of _____ each year and to authorize the selectmen to issue bonds or serial notes for repayment of same.

24. To see if the Town will vote to authorize the selectmen to quit claim to the Savings Bank of Walpole any title and interest that the Town of Westmoreland has in the Perley Lund property on payment by said bank of \$500.69 being the amount of taxes and costs due to the Town.

25. To see if the Town will authorize the selectmen to sell at public auction all lands and buildings acquired by the Town by tax collector's deeds granting the selectmen the power to reject any and all bids to safeguard the best interests of the Town.

*26. To see if the Town will vote to raise and appropriate the sum of \$97.00 (1/100 of 1% of the valuation of

the Town) to the Monadnock Region Association of Southwestern New Hampshire for issuance and distribution of printed matter, newspaper and magazine advertising, and by other means calling attention to the resources and natural advantages of the Town in cooperation with the other thirty-seven towns of the Monadnock Region.

27. To see what action the Town will take concerning the taxation of any business or businesses which might locate in Town and determine the length of tax exemption on real estate.

28. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

29. To see if the Town will vote to authorize the Selectmen to use the 10% of Head Tax granted by the State of N. H. for the listing, assessment and collection of same according to the Laws of New Hampshire Chapter 29:9.

30. To see if the Town will vote to rescind Article 27 adopted by the Town at its meeting March 12, 1957.

31. To see if the Town will vote to elect by ballot at each annual meeting one highway agent for the Town of Westmoreland starting with the annual meeting of 1960.

32. To see if the Town will vote to raise and appropriate the sum of \$500.00 to be used for widening and graveling the road starting at the Cutler place to its intersection with the road leading past Amos Hatt's place.

33. To transact any other business which may legally come before said meeting.

TOWN MEETING

March 11, 1958

The meeting was opened at 9:13 o'clock A.M. by Moderator Paul D. King who read the Warrant. It was moved, seconded and carried that Article 1 would remain open for the duration of the meeting. The polls were declared closed at 6:45 o'clock P.M. by the Moderator.

Articles 2 and 3 were taken up together, item by item. It was voted to raise and appropriate the following sums:

Article 4. It was voted to accept the reports of agents and auditors.

Articles 5 and 16 were taken up together. Mr. A. F. Hudson moved that the Town raise and appropriate \$200.00 under Article 5; seconded by David G. Adams, and carried by voice vote. Under Article 16 David Adams moved not to close Wentworth Road; seconded and carried by voice vote.

Article 6. It was voted to raise and appropriate the sum of \$4,000.00 for snow removal and sanding on either Class V or Class VI roads.

Article 7. It was moved by Hugh A. Shelley, Sr. and seconded by R. E. Perry, and voted to raise and appropriate the sum of \$1,000.00 to put a permanent top on London Hill Road, so-called, from the railroad bridge toward Route No. 12.

Article 8. It was voted to raise and appropriate the sum of \$701.94 for Class IV and Class V roads.

Article 9. A ballot vote was taken on this Article and 114 ballots were cast, 71 favorable and 43 unfavorable. Therefore the Zoning and Building Regulations were adopted. A copy of the Building and Zoning Regulations as submitted to the voters is included as a part of this record.

Proposed Zoning and Building Regulations
for the
Town of Westmoreland, Cheshire County, New Hampshire
Article I

To promote the health, safety, convenience, prosperity and general welfare of the Town of Westmoreland and to protect and enhance the value of its properties, the following regulations are hereby enacted by the voters of Westmoreland, pursuant to authority conferred by Chapter 31, Sections 60 - 89, and Chapter 156, Sections 1 - 5 of the New Hampshire Revised Statutes, Annotated 1955.

Article II

For present purposes these Zoning and Building Regulations shall be effective only to a depth of five hundred (500) feet on each side of all roads and highways in Westmoreland, except that they shall not affect any building now existing or under construction.

For the purpose of these Regulations the Town of Westmoreland is divided into three (3) Districts as shown on the Zoning map filed with the Town Clerk and dated March 11, 1958 and described as follows:

ZONE A Route #63 from River Road to Farrhill Road to be zoned for residence only. Churches and schools permitted in this area

ZONE B Route #63 from Farrhill Road to Pocham Road; East Westmoreland Road — so-called — as far as the Cross Road at Nim's Pond, so-called, and Route #12 from East Westmoreland Cemetery to the Surry Town Line, to be zoned for residences and small businesses and professions and agriculture. Churches and schools permitted in these areas.

ZONE C All other roads, and sections of roads not included in Zones A and B, to be zoned for residential and agricultural purposes.

Article III Provisions

- A. Every dwelling house to be established on the roads and highways specified in Article II, within 500 feet from the center line of any such road or highway shall be set back from the center line of the road or highway a distance of at least 50 feet, and shall be set back at least 10 feet from the side and rear property lines. They shall have a minimum ground floor area of 600 square feet, approximately 20 feet by 30 feet for each family unit. Exception: This provision shall not affect the size of floor area of motels or cabins used for guests staying overnight or by the week.
- B. Every dwelling house, camp, other building, or additions to presently existing dwellings or buildings is to be finished on the exterior in a permanent manner, and is to be painted on the outside, whenever the same is of wood or a material customarily painted.
- C. All chimneys shall be constructed of stone, brick, cement or cinder block to the ground; each shall be lined with tile and extend at least two feet above the roof to which it belongs and shall have a cleanout opening at the base. All entrances to chimneys shall be of fire-proof construction. Chimneys shall not be used to support beams or timbers in any manner. No smoke pipe shall be installed so as to be within twelve inches of any combustible floor or ceiling, unless amply protected with non-combustible material. No smoke pipe shall be installed which passes into or through partitions or walls of combustible material, except when guarded by a double collar of metal with air space of at least five inches or by at least five inches of brick or other non-combustible material between the pipe and the combustible material.
- D. No roof of any building shall be covered or recovered in whole or in part save with non-combustible or fire-resistant roofing material.
- E. Sewage disposal systems for new dwellings or other

- buildings designed for human occupancy shall consist of an approved septic tank and will follow the requirements of the Health Laws of the State of New Hampshire. The disposal area for effluent from any septic tank shall be no nearer than seventy-five (75) feet of a public body of water, except where special permission is granted by the Town Health Officer.
- F. No owner or occupant of any land within said areas shall permit any building or fire ruins thereon to be left unfinished or incomplete on the exterior, but shall finish or remove the same within two (2) years. This section shall not apply to any existing building or buildings under construction.
 - G. No junk yard or place for the storage of discarded machinery, vehicles or scrap material shall be permitted in any zoned area of the town.
 - H. Trailer camps and mobile home subdivisions shall not be permitted in the town until approval has been granted by the Board of Adjustment, after a public hearing.
 - I. Outdoor advertising signs shall not be permitted in the town until approval has been granted by the Board of Adjustment. Exception: Owners of land may erect small signs of not over 12 square feet in size on their own land for advertising their own products or goods raised or made on the premises.

Article IV Enforcement

- A. It shall be the duty of the Board of Selectmen and the Board is hereby given power and authority to enforce the provisions of the Ordinance.
- B. There shall be an Inspector of Buildings, and the Board of Selectmen shall be and is hereby empowered to appoint an Inspector of Buildings.
- C. The Inspector of Buildings shall issue any and all building permits requested, when such permit is in accordance with the provisions of this ordinance or legally authorized by the Board of Adjustment, and then only. The applicant shall pay a fee for the issuance of a permit based on the full value of the project involved, said fee to be retained by the Inspector of Buildings

as compensation for his services.

Fees shall be in the following amounts :

Less than \$1,000.00 in value — \$2.00; \$1,000.00 to \$5,000.00 in value — \$5.00; over \$5,000.00 in value — \$7.00.

A permit issued under the provisions of the ordinance shall expire and become invalid three years from the date of issuance.

- D. Permits. After passage of this ordinance, it shall be unlawful to erect any permanent building or alter the bulk of any building or permanently relocate any building in any district, without first obtaining a building permit from the Inspector of Buildings. Matters regarding safe practice and building design not specifically provided for in this Ordinance, shall be governed by the National Building Code, recommended by the National Board of Fire Underwriters. Installation of wiring and fixtures for electricity in buildings or structures must comply with the New Hampshire Fire Underwriters Code.
- E. No permit shall be required for remodeling or repairing the exterior of any building, when the total cost of such work including materials will not exceed \$500.00.
- F. Upon any well founded information that this Ordinance is being violated, the Selectmen shall on their own initiative take immediate steps to enforce the provisions of this Ordinance by seeking an injunction in the Superior Court, or by any other legal action.

Article V Board of Adjustment

Within thirty days after the adoption of this Ordinance and thereafter as terms expire or vacancies occur, the Board of Selectmen shall make appointments to a Board of Adjustment of five (5) members, conforming in duties to the provisions of Chapter 31 of the New Hampshire Revised Statutes Annotated 1955. Thereafter as terms expire or vacancies occur, the appointing Authority shall be responsible for filling vacancies and maintaining full membership in the Board of Adjustment. The Board of Adjustment here provided shall conform in membership and term of office to the provisions of Section 67, Chapter 31 of the

New Hampshire Revised Statutes, Annotated 1955.

In addition to the general powers granted said Board of Adjustment by said Chapter 31, it may in harmony with, and subject to its provisions:

- A. Allow slight variances from the specific terms of this Ordinance, where it can be shown that unnecessary hardship would otherwise result.

Article VI Penalties

Every person, persons, firm or corporation violating any of the provisions of this Ordinance shall, upon conviction, be fined not more than ten dollars (\$10.00) for each day of said violation.

Article VII Validity

The invalidity of any section or provision of this Ordinance shall not invalidate any other section or provision thereof.

Article VIII Amendment

This Ordinance may be amended by a majority vote at any legal Town Meeting when such amendment is published in the Warrant calling for the meeting, and when such amendment has received a public hearing, which hearing has been advertised and given a legal fifteen day notice.

Article IX Effective Date

This Ordinance shall take effect upon its passage.

Article 12. It was voted to use the income from the Jotham Lord Fund for the support of the Town Library.

Article 13. It was voted to close, subject to gates and bars, the old Route No. 12 road, starting from the East side of the new route No. 12 by the Ox-Yoke on the Walpole Town line.

Article 14. It was voted to close, subject to gates and bars, the road known as the Old Post Road, from the barn of Roy Bosworth to the road leading to Olin Clayton, and from the Clayton barn to its junction with Route No. 12.

Article 15. It was voted to raise and appropriate the sum of \$300.00 for the support of the Library.

Article 16. Taken up with Article #5.

Article 17. It was voted to raise and appropriate the sum of \$150.00 for upkeep of Cemeteries.

Article 18. It was voted to authorize the Selectmen to borrow money in anticipation of taxes.

Article 19. A ballot vote was taken on this Article. There were 70 ballots cast — 52 favorable, 18 unfavorable, therefore the Article was approved.

Article 20. A ballot vote was taken on this Article. There were 78 ballots cast — 37 favorable, 41 unfavorable, therefore the Article was not approved.

Article 21. It was voted to raise and appropriate the sum of \$400.00 for White Pine Blister Rust Control.

You are hereby notified to meet at the Town Hall, in said district, on the 14th day of March, 1959, at 2:00 o'clock in the afternoon to act upon the following subjects:

1. To choose a moderator for the ensuing year.
2. To choose a clerk for the ensuing year.
3. To choose a member of the school board for the ensuing three years.
4. To choose a treasurer for the ensuing year.
5. To determine and appoint the salaries of the school board and truant officers, and pass any vote relating thereto.
6. To hear the reports of agents, auditors, committees or officers chosen, and pass any vote relating thereto.
7. To choose agents, auditors, and committees in relation to any subject embraced in this warrant.
8. To see if the district will vote to rescind the action to accept the minority report of the building committee voted at the August 2, 1958 Westmoreland School District Meeting.
9. To see if the district will vote to raise and appropriate a sum not to exceed \$82,600.00 for the purpose of erecting in that part of town known as the South Village additional elementary facilities either as an addition or as a new elementary school and furnish and equip the same, and the grading of the lot, and the acquisition of any real property that may be necessary for its location; to use part of the sum raised and appropriated to accomplish altera-

tions and improvements in the present village elementary school; to accept and use such funds of the district as are now available; and gifts which may be received to reduce the amount of the appropriation; and whether the district will vote to raise such sum through the issuance of serial notes or bonds upon the credit of the district for all or any portion of the sum so raised and appropriated; and to authorize the school board to determine the terms and conditions upon which the notes or bonds shall be issued including their sale and the time and place of payment of principal and interest, in accordance with the provisions of the Municipal Finance Act, N. H. Revised Statutes Annotated, Chapter 33, and any amendments thereto.

10. To see if the district will vote to authorize the school board to execute any and all contracts or agreements necessary, proper and advisable in connection with the construction of additional elementary facilities either as an addition or as a new elementary school and for the purchase and furnishings for same or to take any action thereon.

11. To see what sum the district will vote to authorize the school board to transfer to the capital reserve fund from the unencumbered surplus funds remaining on hand at the end of the school year 1958-1959.

12. To see what sum of money the district will vote to raise and appropriate for the support of schools, for the salaries of school district officers and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state equalization fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

SCHOOL MEETING

March 8, 1958

The meeting was called to order by the moderator, John Terry, who read the school warrant. The articles were then acted upon.

Article 1. John Terry was elected moderator for the ensuing year, with the clerk casting one ballot.

Article 2. Dorothy Rhodes was elected clerk for the ensuing year, with the moderator casting one ballot.

Article 3. Ruth Hatt was elected school board member for the ensuing three years, with the clerk casting one ballot.

Article 4. Marjorie Hudson was elected treasurer for the ensuing year, with the clerk casting one ballot.

Article 5. Robert Moore, Jr. made the motion, which was seconded and voted, that we take up Article 5 with

Article 10 or Article 11. Thomas Barrett made the motion that we take up Article 16 at this time.

Article 16. Mrs. Kirk Aldrich made the motion, which was seconded and voted, that the school district adopt the non-partisan Australian ballot system as a method of voting for the election of school district officers. Motion carried.

Article 6. Marjorie Hudson gave a report on the Hot Lunch program for this year, which was accepted and placed on file.

Article 7. Charles Adams was elected auditor for the ensuing year, with the clerk casting one ballot.

Article 8. Ruth Churchill made the motion, which was seconded and voted, that the district vote to raise and appropriate the sum of \$70,000.00 for the purpose of erecting in that part of town known as South Village an elemen-

tary school and furnish and equip the same, and the grading of the lot and the acquisition of any real property that may be necessary for its location; to accept and use such funds of the district as are now available and gifts which may be received to reduce the amount of the appropriation; and that the district vote to raise such sums through the issuance of serial notes or bonds upon the credit of the district for all or any portion of the sum so raised and appropriated; and to authorize the school board to determine the terms and conditions upon which the notes or bonds shall be issued including their sale and the time and place of payment of principal and interest, in accordance with the provision of the Municipal Finance Act, N. H. Revised Statutes Annotated, Chapter 33, and any amendments thereto.

Before voting by ballot, the following ballot clerks were named: Walter Dunn, Mary Fredette, John Watkins, and Hugh Shelley.

By a ballot vote there were 89 yes, 76 no, and 1 blank ballot. Not having the necessary two thirds vote, the motion was not carried.

Article 9. Carl Messer made the motion, which was seconded and voted, to take no action under this article.

Article 11 and Article 5. Carl Messer made the motion which was seconded and voted, that the district vote to raise and appropriate the sum of \$58,235.50 for the support of schools (using the proposed Budget B figures) for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the State equalization fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

Article 12. Cameron Paine made the motion which was seconded and voted, that the district vote to authorize the school board to make application for and to receive and use in the name of the district, such advances, grants in aid or other funds for educational purposes as may now or

hereafter be forthcoming from the United States government or any department or agency thereof, or from any state or private agency.

Article 13. Thomas Barrett made the motion which was seconded and voted, that the district vote to authorize the School Board to negotiate a tuition contract with the Keene School District.

Article 14. The motion was made, seconded and voted, that the district vote to authorize the School Board to negotiate a tuition contract with the Walpole School District.

Article 15. Carl Barrett made the motion, which was seconded and voted that the school district adopt as its check-list, the Town check-list, as provided in RSA 197: 12a, as inserted by Laws of 1957, Chapter 57; this provision to be effective for the 1959 and subsequent annual district meetings.

Article 17. Lucy Paine made the motion which was seconded and voted, that a committee be appointed to study the school plant needs for Westmoreland and recommend action.

40—no 21—yes. Motion not carried.

Carl Messer made the motion that the old committee, appointed two years ago, continue to work with the school board. This was amended by Carl Barrett, to add three new members.

The motion made, seconded and voted was that the old committee, appointed two years ago, continue to work with the school board and to add three additional members, the committee to be appointed by the moderator. Motion carried.

Meeting adjourned.

The clerk, moderator, treasurer, and school board member were then sworn in.

The special school district meeting was called to order at 2:10 P.M. by moderator, John H. Terry, Jr., who read the warrant.

As the clerk, Mrs. Dorothy Rhodes was absent, the moderator called for nominations for a clerk Pro Tem. Mrs. Ruth D. Hatt nominated Fenn B. Newell. Mr. Cameron Paine seconded the nomination, and moved that the nominations be closed, and the moderator instructed to cast one ballot for Fenn B. Newell to act as clerk Pro Tem. The motion was carried, the ballot cast and Fenn B. Newell was sworn in by the moderator as clerk Pro Tem.

Captain M. T. Farrar moved that Article 2 in the warrant be taken up first, and spoke at some length as to his reasons for his motion. The motion was seconded, and by a show of hands vote was carried by 17 to 16.

Under Article 2 — Captain Farrar discussed and explained in great detail the newest plans and specifications of the building committee for additional classrooms and facilities to the Westmoreland Village School. Miss Gerould moved that it is the opinion of this meeting that we do add adequate additional facilities to the Westmoreland Village School. Seconded by Mrs. Allan Thorne. Carl Barrett moved to amend Miss Gerould's motion to add the words "for the 6 elementary grades" after the word school. This motion to amend was seconded by Mrs. Provencher. A ballot vote was called for and taken on Mr. Barrett's motion to amend. There were 75 ballots cast, 19 favorable and 56 unfavorable. Hence the amendment was defeated. Therefore the original motion was carried.

Article 1 was then taken up. It was moved, seconded and carried by voice vote that no action be taken on this article.

Article 3. Mr. L. H. Russell, Sr., moved that the school board be instructed to petition the Superior Court, as soon as practicable, to authorize a special school district meeting for the purpose of voting to build and finance adequate educational facilities to the Westmoreland Village School. John Watkins moved to limit the cost of the additions to \$55,000.00. Seconded by L. H. Russell, Sr.

Miss Gerould then moved to amend the amendment to limit the cost to \$60,000.00 including the Capital Reserve Fund. Miss Gerould's amendment was seconded by Mrs. Thorne and adopted by a show of hands vote, 26 to 24.

Mr. Russell's amended motion was then adopted by a voice vote.

Article 4. Charles Adams moved that the school board be urged to get permission from the selectmen to use the Town Hall for the 6th and 7th grades for the school year 1958-1959, or until additional facilities are completed. Mr. William Van Warren pointed out that the furnaces in the Town Hall were in such poor condition that it would be unsafe to use them continuously, as it would be necessary if the Hall was used for school purposes.

By a voice vote Mr. Adams motion was lost.

The meeting was adjourned at 5:10 P.M.

The meeting of the Westmoreland School District was held at the Town Hall on Saturday afternoon, August 2, at 2 P.M.

The meeting was called to order by the moderator, John Terry, who then read the warrant, the petition to the Superior Court, the permission from the court, and the recommendation of the Budget Committee.

The minutes of the previous meeting was read by the clerk.

The moderator explained if anyone objected to his decisions they could appeal, if it was seconded it could then be voted on.

A report of the majority committee was given by Charles Adams, which is favored by the building committee 5 to 1.

Captain Farrar then gave the minority report. A discussion of both plans followed.

Charles Adams made the motion, which was seconded, that the majority report be accepted. Captain Farrar made

the motion that this be amended to the minority report, or Reid plan. This was seconded. The amendment was voted on by ballot.

Yes—65 No—58 Motion carried.

The moderator then put the main motion as amended. Lucy Paine objected to the ruling of the moderator. This was seconded. Hugh Shelley made the motion that the moderator's ruling be upheld. This was also seconded. By a show of hands, Yes—68 No—39. Motion carried.

The moderator again put the main motion as amended. By a ballot vote, Yes—69 No—56. Motion carried.

Ballot clerks appointed to assist in counting the ballots were Thornton Paine, Helen Cousens and Lois Leach.

Frances Aldrich made the motion, which was seconded, that the district vote to raise and appropriate a sum not to exceed \$60,000.00 for the purpose of erecting in that part of town known as South Village additional elementary facilities either as an addition to the present elementary school or as a new elementary school attached or connected to the present elementary building and furnish and equip the same, and the grading of the lot and the acquisition of any real property that may be necessary for its location; to use part of the sum raised and appropriated to accomplish alterations and improvements in the present Village Elementary School; to accept and use such funds of the district as are available, and gifts which may be received to reduce the amount of the appropriation and whether the district will vote to raise such sums through the issuance of serial notes or bonds upon the credit of the district for all or any portion of the sum so raised and appropriated; and to authorize the school board to determine the terms and conditions on which the notes or bonds shall be issued including their sale and the time and place of payment of principal and interest, in accordance with the provisions of the Municipal Finance Act, N. H. Revised Statutes Annotated, Chapter 33.

Charles Adams made the amendment that the contracts for construction be let by competitive bidding. This was seconded.

Yes—90 No—30. Amendment carried.

Thomas Barrett made the amendment that we use Captain Farrar's and Reid's plan, and no other. This was

seconded. By a show of hands Yes— 23 No—majority. Amendment lost.

The original motion was then voted on.

Yes—75 No—49. (Needed to carry, 82). Motion lost.

Cameron Paine made the motion that this meeting go on record as favoring the continued use of the East Westmoreland School, until such time as the voters of East Westmoreland, by their majority vote, indicate that they would like the school closed; and that the school board be so instructed. Richard Delano made the motion that this be amended to "the whole town." By a voice vote this was carried.

The motion as amended was voted on. Yes—34 No—38. Motion lost.

Charles Adams made the motion that the present building committee be dissolved with thanks, and that the moderator appoint a new six person committee to report at the regular school meeting in March on a proposal for additional school facilities. Lucy Paine objected to the committee being appointed by the moderator and made the amendment that the committee be appointed from the floor. The amendment was lost by a voice vote. On the original motion, by a voice vote, the ayes had it. Motion carried.

The motion was made and seconded that we adjourn.

REPORT OF THE SCHOOL NURSE

The following is my report for the year ending June 30, 1958.

107 pupils had vision tests given by the school nurse.

3 pupils received vision notices.

71 pupils had hearing tests given by the school nurse.

107 pupils were weighed and measured by the school nurse.

107 pupils were inspected by the school nurse.

48 pupils were found in need of dental care.

86 pupils attended polio clinics.

1 pupil attended Crippled Children's Clinic.

11 pupils attended pre-registration clinic.

19 pupils were checked for smallpox vaccination and necessary follow-up done.

Dental health education—direct classroom teaching—October and January.

The aims of the school nurse are numerous, to list a few:

To instruct children and young people so that they may conserve and improve their own health, and thus be more able to secure that abundant vigor and vitality which are a foundation for the greatest possible happiness and service in personal, family, and community life.

To promote satisfactory understandings, attitudes, and ways of behaving among parents and other adults so that they may maintain and improve the health of the home and community.

To improve the individual and community life of the future; to work toward a better second generation, and a still better third generation; to build a healthier and fitter nation and world.

I do wish to thank all who helped make my year a successful one.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Westmoreland :

I herewith submit my annual report as your Superintendent of Schools :

Survival and success in the years ahead will be influenced to a large extent by the choices we make in regard to what we as a people consider to be valuable. The support given to the educational program in a community is a reflection of the value placed on education by its people.

Young people soon discover what their elders really value.

More than financial support of the school program is needed. There is a need for cooperative effort of parents, citizens and teachers to promote a climate in all phases of a youngster's life that will encourage and demand the best that he or she is capable of doing. The help and influence of parents is needed to aggressively support the school's efforts to promote excellence of performance.

The committees that were working on the Oral Language Arts Syllabus as a follow-up of the 1957 Workshop completed their outlines; syllabi were adopted and placed in use this year for grades one through twelve.

The Language Arts Workshop held this year placed emphasis on the written program. Miss Helen O'Leary, Associate Professor of Education at the University of Massachusetts was the keynote speaker and principal consultant. Other consultants contributing to the success of the Workshop were Miss Marie Capron, Supervisor of Student Teaching at Keene Teachers College; Miss Amy Mayo, Educational Consultant for the American Book Company and Mr. Normand Pacquette, Head of the English Department at Stevens High School, Claremont, N. H.

Committees are working to complete a Written Language Arts Syllabus for grades one through twelve and it

is hoped that it will be completed by the end of the school year.

Mathematics and science teachers conducted a three-day workshop at the same time the Language Arts Workshop was in progress. This group studied mathematics teaching methods and procedures and are currently working on a mathematics syllabus for grades seven and eight.

Mrs. Betty Lou Bell replaced Mrs. Juliana Hooper as first grade teacher in East Westmoreland. Mrs. Bell received her degree from Keene Teachers College and did her practice teaching in Concord, N. H. Mrs. Elizabeth Chickering replaced Mrs. Bell at the end of the mid-term in January, 1959. Mrs. Chickering received her degree from Keene Teachers College and taught in Walpole, N. H. last year.

At every school district meeting both annual and special it has been evident that there is general agreement that improvement in school facilities is necessary. The principal disagreements are about the number of rooms, type of construction, location and an addition versus a new building. Discussion and thorough study before taking action is prudent procedure, however, continued disagreement merely means a continuance of the present situation which means spending money on buildings that are no longer giving the service that should be given and not giving Westmoreland children the start in life that they should have.

The estimate of \$8,000.00 for state foundation aid made for the proposed 1958-1959 budget was an optimistic estimate that did not take into account that the average daily membership of foster children is not allowed in computing state aid. Westmoreland received \$5,612.69 which was \$2,387.31 less than anticipated, however, the anticipated end-of-year balance was \$1,180.16 more which partially offset the lesser amount of state aid.
