To the Inhabitants of the Town of Danbury in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Danbury on Tuesday, the 10th day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To raise such sums of money as may be necessary for the maintenance of Highways.
- 4. To see if the Town will vote to raise the sum of \$825.56 T.R.A. money and receive the State's contribution of \$5,503.73.
- 5. To see if the Town will raise the sum of \$200.00 for the George Gamble Library.
- 6. To see if the Town will vote to raise the sum of One Thousand dollars (\$1,000.00) to meet the necessary expenditures of the Danbury Volunteer Fire Department.
- 7. To see what sum of money the Town will vote to raise for the American Legion for Memorial Day.
- 8. To see what sum of money the Town will raise for the care of the Cemeteries.
- 9. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

- 10. To see if the Town will vote to raise and appropriate a sum not exceeding one hundredth of one per cent (1/100th of 1%) of the net valuation based on the assessment of year 1958 for the purpose of publicizing and promoting the natural resources of the Town with other towns in the Dartmouth-Lake Sunapee Region Association.
- 11. To see if the Town will vote to raise the sum of (\$25.00) Twenty Five dollars for Old Home Day.
- 12. To see if the Town will vote to raise the State required sum of \$100.00 for the control of White Pine Blister Rust.
- 13. To see if the Town will vote to raise the State required sum of \$150.00 for the Municipal Court.

The Commissioners and Chief of the Danbury Vo'unteer Fire Department wish to take the opportunity at this time to extend our sincere thanks to the Officers, Members and all Committees that served to help support and maintain the Fire Department during the year 1958.

We also wish to take the opportunity at this time to extend our sincere thanks and appreciation to the taxpayers of the town of Danbury for their very loval support this past year in voting our request for the total sum of One Thousand Dollars (\$1,000.00). Five Hundred Dollars (\$500.00) was used for the purchase of new 21/2" hose and Five Hundred Dollars (\$500.00) for operating expenses. If you refer to the Fire Department Treasurer's report you will notice that we purchased a used 2-speed rear end for \$50.00, booster brake for \$21.85, and other necessary parts to go with the rear end totaling \$25.36. These parts were installed into the Ford Tank Truck, the first truck to roll out to a call, thus enabling it to carry the load much easier going to and from a fire. The labor for repairing the truck was donated by the boys in the department thus saving us considerable money and to whom we owe many thanks.

This year we are again putting an article in the Warrant requesting the sum of One Thousand Dollars (\$1,000.00), Five Hundred Dollars (\$500.00) for hose and Five Hundred Dollars (\$500.00) for operating expenses. This is the third and final year for this request and will bring our complement of $2\frac{1}{2}$ " hose to 1,200 feet which we feel is quite necessary to maintain in case of a fire where we will have a long stretch to the water supply.

Report of Forest Fire Warden You Can Help Prevent Forest Fires

Twenty-five percent of all forest fires in New Hampshire are caused from careless debris burning—brush, paper, leaves, grass, etc. Most of them are started without the required permit from the local forest fire warden. The cost of extinguishing these fires annually runs into large sums of money.

According to law, responsible parties must pay the cost of putting them out. In addition, violators may be subject to court prosecution with fines running as high as (\$200) two-hundred dollars.

In the interest of fire prevention why not eliminate burning at home? Use your town dump. It has been set up for your personal convenience. It provides a suitable place for the disposal of dangerous inflammable waste material and other useless items which accumulate around the home and local stores; brush, etc. cut on your property. Eliminate the hazared of burning yourself. It will be easier for you — personally and financially.

If, however, you do burn on your premises:

- 1. Secure a permit from your local forest fire warden the law requires it.
- 2. Be sure to properly supervise your burning. Don't leave it.
- 3. Make certain your fire is DEAD OUT before leaving it.

Save yourself much possible difficulty. Use your town dump.
