# Warrant For Town Meeting

TOWN OF HART'S LOCATION

STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Hart's Location in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Willey House in said Hart's Location on Tuesday, the 13th day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may ne necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To authorize the Selectmen to borrow sums of money as may be necessary on the taxes due the Town of Hart's Location in the year 1962.
4. To see if the Town will vote to raise and appropriate the sum of \$5.00 (being 7/1,000ths of 1% of the Town's 1958 equalized valuation) for the purpose of uniting with the 45 other towns in the White Mountains Region Association in cooperative development and promotion of the North Country's economy.
5. To see if the town will vote to petition the State Tax Commission to have an audit made by the Municipal Accounting Division and make appropriation to cover the expense of same.
6. To see if the town will vote to raise Town Road Aid, \$17.08 to be used with State Highway Department quota of \$113.89 for all town roads.

7. To see what sum of money the town will vote to raise for all town roads.

8. To see if the town will vote to raise and appropriate \$200.00 to be used for two way communication system in the town.

9. To act upon any other business that may legally come before said meeting.
