

TOWN MEETING WARRANT

You are hereby notified to meet at the Community Building in said Benton on the second Tuesday of March next (the 13th) at 10 o'clock in the forenoon to vote and act upon the following subjects:

Article 1. To choose a Town Clerk; one Selectman for three years, John Boutin, Sr. being the outgoing member; one Tax Collector; one Treasurer; one Highway Agent; one Trustee of Trust Funds for three years, William J. Harris being the outgoing member; one Trustee of Trust Funds for one year to fill the vacancy caused by the resignation of James M. Leonard; one Auditor; and all other necessary town officers and agents for the ensuing year.

Article 2. To see if the Town will vote to raise and appropriate the sum of \$93.30 as the Town's share for construction of highways (Town Road Aid).

Article 3. To see if the Town will vote to raise and appropriate the sum of \$17.58 for the White Mountains Region Association.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$25.00 to observe Memorial Day as in past years.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$100.00 to complete the improvement of Mt. View Cemetery.

Article 6. To see if the Town will vote to adopt a plan for extending to employees of the Town the benefits of title II of the Federal Social Security Act (Old Age, Survivors and Disability Insurance) as authorized by Chapter 101 of the Revised Statutes Annotated Amend-

- ed by Chapter 302 and 332 of the Laws of 1955 and to raise and appropriate the sum of \$60.00 to defray the Town's share of the cost thereof.
- Article 7. To see if the Town wishes to exclude from the plan (Article 6) services in any class or classes of positions filled by popular election.
- Article 8. To see if the Town wishes to exclude from the plan (Article 6) services in any class or classes of positions the compensation for which is on a fee basis.
- Article 9. If a plan for Social Security coverage is adopted, to see if the Town will authorize the Selectmen to execute on behalf of the Town the necessary agreement with the State of New Hampshire to carry into effect the plan and to see if the Town will designate the chairman of the Board of Selectmen as the officer to be responsible for the administration of the plan.
- Article 10. To see if the Town will vote to authorize the payment of the Federal minimum wage for hourly labor performed for the Town.
- Article 11. To see if the Town will vote to make any alterations in the amount of money to be raised and appropriated for the ensuing year as recommended in the budget, and raise and appropriate all sums so determined.
- Article 12. To hear the reports of officers and agents and pass any vote relating thereto.
- **Article 13.** To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.
- Article 14. To see if the Town will authorize the Selectmen to administer or sell any real estate acquired through Tax Collector deeds.
- Article 15. To see if the Town will vote to authorize a

discount on property taxes paid before a date set by the Selectmen and to set the amount of said discount.

Article 16. To see if the Town will vote to dispense with the delivery of inventory blanks until April 1st.

Article 17. To see if the Town will vote to authorize the playing of beano.

There are in custody of the Trustees the following Trust Funds bequeathed to the town of Benton. The income shown (184.39) is that received during the year 1961 and the distribution of income is as specified by the donors of the funds. The amount in certain of the funds is somewhat greater than in previous years for the following reason:

As a result of banking difficulties at the time of the 1933 Bank Holiday, the Lisbon Savings Bank and Trust Company was reorganized and the accounts of all depositors were assessed and reduced by twenty-five percent. Under a Plan of Recapitalization of the Lisbon Bank which became effective on July 3, 1961 thirty percent of the amount so assessed was returned to the affected Trust Funds.

SUPERINTENDENT'S REPORT

To the School Board and Citizens of Benton School District:

I herewith submit my nineteenth annual report as Superintendent of Schools.

The total enrollment of the Benton Street School in 1960-1961 was 23, the average membership was 21.2 and the percent of attendance 97.6. Three pupils attended on a tuition basis from the school district of Easton and one from Haverhill. There were ten pupils enrolled in other districts; three at Haverhill Academy, one at Plymouth High School, one at Woodsville High School, three at Haverhill Elementary, and two at Warren Elementary School.

At the Benton Street School this year the total enrollment is 23, which includes three tuition pupils from Easton and two tuition pupils from Haverhill. There are three elementary pupils and three high school pupils attending Haverhill, one pupil attending Warren Elementary, one pupil enrolled at Plymouth High School, and two pupils attending Woodsville High School.

With the new elementary school under construction at Woodsville it appears that it will be a good move to send the 7th and 8th grades there next year, on a tuition basis. School conditions are changing everywhere and there are few schools left in New Hampshire where one teacher teaches all eight grades. Teachers are no longer being prepared for this work and it will be very difficult to secure a replacement when Mrs. Boemig leaves. This is Mrs. Boemig's seventh year at Benton and several times she has expressed the thought that she may be unable to return.

This year's budget has been prepared with the possibility of sending Grades 7 and 8 to Woodsville. Your School Board will discuss the details with you at the annual school meeting.

May I repeat what I said in the 1958 report. The typical one-room school today maintains six grades or less. This practice permits the teacher to concen-

trate on lower grade work and at the same time gives the older children a chance to attend village junior high school and make an easier transfer to high school.

Perhaps Woodsville will accept all the Benton children, Grades 1-8. If so, there are advantages to be gained.

By all means contact your School Board members when questions arise about school affairs. Your Board members are only too happy to be of assistance to you.

My personal thanks are extended to the School Board. I trust that each of you finds that service to the school children of Benton is a rewarding experience.

SUPERVISORY UNION NO. 34 REPORT OF SUPERINTENDENT'S SALARY

Section 5, Chapter 243, Laws of 1953 of the State of New Hampshire, requires that school district annual reports show the total amount paid to the superintendent.

One-half of the supervisory union expenses is prorated among the several school districts of the union on the basis of adjusted valuation. One-half is prorated on the basis of average daily membership in the schools for the previous school year ending June 30. The Superintendent of Supervisory Union #34, during 1960-1961, received a salary of \$8,250.00 which was made up as follows: \$4,250.00 paid by the State Department of Education from the per capita tax and \$4,000.00 prorated among the several school districts. Allowance of \$1,100.00 for travel within the Union was also prorated as stated above.

Program of the White Mountains Region Association

The White Mountains Region Association as a voluntary nonprofit organization, receives support from the communities of the Region, the state and from individual members so that a program of cooperative promotion and development of northern New Hampshire may be carried on.

The Association publishes and distributes six different folders a year advertising the many advantages of the Region. It receives and carefully answers about 6,000 letters per year from people interested in a vacation in the North Country. The value of this single service cannot be over-emphasized. Recent surveys have shown that the tourists attracted by this mailing service have spent many hundreds of thousands of dollars in the Region. The Association sponsors the annual fall foliage tours, and represents the Region at national travel shows.

Through its board of directors, it is able to speak for the Region's needs at state and national hearings and at important meetings within the Region. It maintains a news release service to local newspapers to help inform the citizens of the North Country of worth-while activities and economic trends.

This winter the Association is running a cooperative ad program with the chambers of commerce in the ski areas to promote skiing in the White Mountains. It cooperates with private promotional groups, local chambers of commerce, and with the state promotional agencies. It promotes the sale of real estate through the mailing of real-estate purchase bulletins to real estate brokers. It conducts labor surveys for groups interested in industrial development, maintains an award program for the 4-H Clubs, and promotes agriculture within the Region.

In uninterrupted service since 1938, it has helped establish the White Mountains Region as a vacation center as fine as any in the world and contributed in many other ways to the economic betterment of all forty-six communities in northern New Hampshire.
