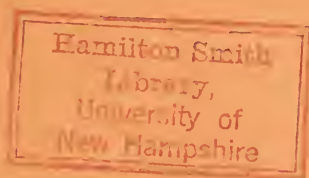

Town Warrant

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Sharon, in the County of Hillsborough in said State, qualified to vote in Town affairs:—

You are hereby notified to meet at the Brick School House in said Sharon on Tuesday, the twelfth day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To hear the reports of Agents, Auditors, Committees, or Officers heretofore chosen, and pass any vote relative thereto.

4. To see if the town will accept state aid for construction of the Class II. road known as Middle Road, and raise and appropriate or set aside for said purpose the sum of two hundred sixty-five dollars and fifty cents (\$265.50); or will accept state aid for construction of Class V. roads and raise and appropriate or set aside for said purpose the sum of two hundred five dollars and fifteen cents (\$205.15).

5. To see if the town will raise and appropriate the sum of twenty dollars (\$20.00) for the purpose of advertising the resources and natural advantages of the town, said sum to be expended under the direction of the selectmen; or take any other action relating thereto.

6. To see if the town will raise and appropriate the sum of two hundred dollars (\$200.00) for the purpose of repairing and improving the Brick School House, said sum to be expended under the direction of the selectmen, or take any other action relating thereto.

7. To see what sum of money the town will vote to raise and appropriate for the purpose of plowing roads of snow and for the purchase of necessary equipment, said sum not to exceed seven hundred dollars (\$700 00) and to be expended under the direction of the selectmen, or to take any other action relating thereto.

8. To see what sum of money the town will vote to raise and appropriate for the purpose of removing brush from the sides of highways, or take any other action relating thereto.

9. To see what sum of money the town will vote to raise and appropriate to repair highways and bridges for the ensuing year, or take any action relating thereto.

10. To see if the town will vote to instruct the Selectmen to borrow a sum of money not exceeding Two Thousand dollars (\$2,000.00) in anticipation of taxes.

11. To see what sum of money the town will vote to raise and appropriate for the Care of Cemeteries for the ensuing year, or take any action relating thereto.

12. To see what sum of money the town will vote to raise and appropriate for Old Home Day, or take any action relating thereto.

13. To see if the town will vote to adopt the provisions of the Municipal Budget Act.

14. To see if the town will appoint a zoning commission to consist of five members, to recommend boundaries for zoning districts in said town and to recommend approximate regulations therefor, in accordance with provisions of Chapter 42, of the Public Laws.

15. To see if the town will appropriate a sum of money for the expenses of the zoning commission if the town votes to appoint such commission under the preceding article.

16. To transact any other business which may legally come before said meeting.

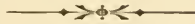
