

Article 3

Voted, by voice vote, to raise and appropriate the sum of \$81,050.00 for the maintenance of highways and bridges for the ensuing year as follows:

\$53,122.00 to be raised by taxes

\$27,928.00 to be designated from a Highway Block grant.

Article 4

Voted, by voice vote, to raise and appropriate the sum of \$40,000.00 for the reconstruction and resurfacing of bituminous surfaced roads.

Article 5

Voted, by voice vote, to raise and appropriate the sum of \$8,520.00 for the operation of the Police Department and the purchase and maintenance of equipment of the Police Department.

Article 6

Voted, by voice vote, to raise and appropriate the sum of \$7,030.00 for the operation of the Fire Department for fire protection, purchase and maintenance of equipment and buildings of the Fire Department.

Article 7

Voted, by voice vote, to raise and appropriate the sum of \$2,800.00 for the purchase of protective clothing for the Fire Department.

Article 8

Voted, by voice vote, to raise and appropriate the sum of \$5,000.00 to provide and maintain Public Library Service and authorize the Library Trustees to receive and use supplemental funds as provided.

Article 9

Voted, by voice vote, to raise and appropriate the sum of \$2,000.00 for the care and maintenance of Town Cemeteries.

Article 10

Voted, by voice vote, to raise and appropriate the sum of \$3,000.00 for deposit to the Capital Reserve for major highway equipment purchase.

Article 11

Voted, by voice vote, to raise and appropriate the sum of \$4,000.00 for deposit to the Capital Reserve for revaluation.

Article 12

Voted, by voice vote, to raise and appropriate the sum of \$5,000.00 for deposit to the Capital Reserve for major equipment including major radio equipment for the Fire Department.

Article 13

Voted, by voice vote, to establish a Capital Reserve for major repairs of town buildings and to raise and appropriate \$2,000.00 for deposit to it and to designate the Selectmen as agents of the Town authorized to make withdrawals from said fund.

Article 14

Voted, by voice vote, to designate the Selectmen as agents of the Town authorized to make withdrawals from the Capital Reserve for major highway equipment.

Article 15

Voted, by voice vote, to authorize the Selectmen to apply for, and to accept on behalf of the Town and to expand any and all gifts, grants of other funds which may now or hereafter be forthcoming, over and above the total appropriation of the town.

Article 16

Voted, by voice vote, to authorize the Selectmen to sell any real estate acquired by the Town during the period until next Town Meeting and that the Selectmen be authorized to sell and convey such estate by auction, sealed bid or in any other manner as justice may require.

Article 17

Voted, by voice vote, to authorize the Selectmen as agents of the Town to borrow money in anticipation of taxes.

Article 18

Voted, by ballot, to dissolve the Ashuelot Valley Refuse Disposal District organized under RSA Chapter 53-B (the "District"), pursuant to the provisions of Article VI, Section 7 of the district agreement for the District and the provisions of the plan of dissolution approved by the district committee of the District, a copy of which plan of dissolution has been submitted by the District to the Town. A 2/3rds majority vote was required to pass.

You are hereby notified to meet at the Sullivan Town Hall in said Sullivan on Tuesday the eighth (8th) day of March next at 11:00 AM of the clock to act upon the following by written ballot; the polls not to close before 7:00 PM.

1. To choose all necessary Town Officers and School District Officials for the ensuing year.

You are hereby notified to meet at the Sullivan Town Hall on Wednesday the ninth (9th) day of March next at 7:00 PM of the clock in the evening to act on the following subjects:

2. To vote to raise the sum of \$83,175 to defray Town charges for the ensuing year and make appropriations of the same. (Approved by: Budget Committee & Selectmen.)

3. To vote to raise and appropriate the sum of 83,050 for maintenance of highways and bridges for the ensuing year as follows:

\$55,820 to be raised by taxes

\$27,229 to be designated from a Highway Block Grant

or to take any action relating thereto. (Approved by: Budget Committee & Selectmen.)

4. To see if the Town will vote to raise and appropriate the sum of \$40,000 for the reconstruction and resurfacing of bituminous surfaced roads or take any action relating thereto. (Approved by: Budget Committee & Selectmen.)

5. To see if the Town will vote to raise and appropriate the sum of \$9,625 for the operation of the Police Department and the purchase and maintenance of equipment of the Police Department or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

6. To see if the Town will vote to raise and appropriate the sum of \$6,500 for the operation of the Fire Department for fire protection, purchase and maintenance of equipment and buildings of the Fire Department or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

7. To see if the Town will vote to raise and appropriate the sum of \$2,880 for the purchase of protective clothing for the Fire Department or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

8. To see if the Town will vote to raise and appropriate the sum of \$7,575 to provide and maintain Public Library Service and authorize the Library Trustees to receive and use supplemental funds as provided or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

9. To see if the Town will vote to raise and appropriate the sum of \$2,000 for the care and maintenance of Town Cemeteries or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

10. To see if the Town will vote to raise and appropriate the sum of \$3,000 for the deposit to the Capital Reserve for major highway equipment purchase or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

11. To see if the Town will vote to raise and appropriate the sum of \$4,000 for deposit to the Capital Reserve for revaluation or take any action relating thereto. (Approved by: Budget Committee & Selectmen)

12. To see if the Town will vote to raise and appropriate the sum of \$4,000 for deposit to the Capital Reserve for major equipment including major radio equipment for the Fire Department or take any action thereto. (Approved by: Budget Committee & Selectmen)
13. To see if the Town will vote to raise and appropriate the sum of \$2,000 for deposit to the Capital Reserve for major repairs of Town buildings or take any action relating thereto. (Approved by: Budget Committee & Selectmen)
14. To see if the Town will vote to establish a Capital Reserve for the expansion of the cemetery and to raise and appropriate the sum of \$1,000 for deposit to it and designate the Selectmen as agents of the Town authorized to make withdrawals from said fund or to take any action relating thereto. (Approved by: Budget Committee & Selectmen)
15. To see if the Town will vote to raise and appropriate the sum of \$3,500 to complete the base map, the land use chapters and any additional items on the Town's masterplan update or take any action relating thereto. (Approved by: Selectmen - Not approved by: Budget Committee . Submitted by Planning Board.)
16. Shall the Town accept the provisions of RSA 31:95-b providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the Selectmen to apply for, accept and expand, without further action by the town meeting, unanticipated money from a state, federal, or any other governmental unit or a private source which becomes available during the fiscal year? This authorization shall remain in effect until rescinded by a vote of municipal meeting. (Majority vote required.)
17. Shall the Town accept the provisions of RSA 33:7 providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the selectmen to issue tax anticipation notes?
18. Shall the Town accept the provisions of RSA 202-A4-c providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the public library trustees to apply for, accept and expend, without further action by the town meeting, unanticipated money from a state, federal or other governmental unit or a private source which becomes available during the fiscal year? (Majority vote required.)
19. To see if the town will vote to raise and appropriate the sum of \$500.00 for the deposit in the Forest Fire Trust fund or take any action relating thereto. (Approved by: Budget Committee & Selectmen)
20. To see if the Town will vote to authorize the Selectmen to sell any real estate acquired by the Town during the period until next town meeting and that the Selectmen be authorized to sell and convey such real estate by auction, sealed bid or in any other manner as justice may require.
21. To see if the Town will vote to raise and appropriate the sum of \$28,000 to operate a transfer station in Town. (Not approved by: Budget Committee & Selectmen. Submitted by resident at public budget hearing.)
22. To see if the Town will vote to establish a cemetery committee to look into and to oversee the expansion of the cemetery; committee to be appointed . (If passed, all interested residents should make themselves known to the Selectmen.)
23. To see if the Town will vote to accept the reports of the agents and committees as printed in the Town Report.
24. To transact any business which may legally come before this meeting and to listen to opinions of a purely advisory nature in regard to the conduct of Town affairs for the ensuing year.

SULLIVAN PLANNING BOARD REPORT

During 1993, the Planning Board concentrated its efforts on updating Sullivan's Master Plan. A Planning Board Subcommittee worked in coordination with the Southwest Regional Planning Commission for assistance in locating sources of information and for technical advice. A number of Board members attended the annual law lecture series. Topics covered many recent developments in the law, including the rapidly changing areas of takings and municipal estoppel.

1993 CONSERVATION COMMISSION REPORT Town of Sullivan, NH

The seven member conservation commission met on a monthly basis during the calendar year to transact business according to the guidance and intent of NH RSA 36-A. Although it was another slow year in terms of development activities, several areas of concern maintained the active participation of all members. The following summarizes the range of events in which all members contributed their time and energy in various amounts:

Attended Meetings: The town of Sullivan was again represented at the annual meeting of the NH Association of Conservation Commissions in November. A report was filed and feedback given on increasing the local statutory authority of conservation commissions in NH; the Monadnock Regional Conservation Commission meetings were attended that focused on logging practices, violations, and the role of the Society for Protection of NH Forests (SPNHF); the Southwest Regional Planning Commission's Natural Resource Advisory Council was joined in an effort to ensure proper natural resource planning initiatives surrounding the Ashuelot River Watershed Management Study Project; and the DOT hearing on renovating the town bridges across Otter Brook was attended in November.

Filed Reports: A feedback survey was filed on the Silvio Conte National Wildlife Refuge Planning Project which includes land use planning efforts by the US Fish and Wildlife Service throughout the Connecticut River Watershed. A survey was completed for the town on New Hampshire's Statewide Conservation and Outdoor Recreation Plan, with specific reference to an inventory of recreation trails, parks and other areas in town. A survey was also completed on the amount, size and location of conservation lands in town as a part of the SPNHF's inventory and mapping of all municipal and private conservation lands in the state.

Solid Waste: A tire recycling weekend was held in July that successfully carted away **572 tires** or **6.25 tons** of old used tires from the hidden and not-so-hidden dump sites around town. Donations of \$14.65 helped offset the overall \$500 charge, which was roughly one third the price of disposal through regular means at the Keene Sanitary Landfill. Many thanks are due Frank Philbrick for his assistance in the collection of roadside and other tires, as well as the use of the town barn area. Also, hats off to the excellent efforts of all of the commission members who helped out! After a set of preliminary negotiations with a hauler in Weare, NH, we all look forward to a repeat performance with **Scrap Metal** during the weekends of **June 18-19 & 25-26** this year!

Other Activities: Bonding requirements were researched around the use of town roads by logging trucks and skidders. Of the several logging intents that were filed, two operations were visited to check for compliance in wetlands crossings. Only one wetland permit was filed and reviewed, and advice was given on a stream channelization project. A set of conservation articles, pamphlets and other documents were placed on file at the town library for public reference.

Again, many thanks to commission members Becky Cummings, Joe Ovensik, Ed McCann, Jean Hoffman, Dr. David Hall and Virginia Howard, who volunteered their time and efforts to help maintain the scenic quality of Sullivan that arises from the sound conservation of its natural resources.

The library has seen several changes in 1993. Seth Cummings, Library Assistant, and Sarah Lucy, Library Director, each resigned their positions at the library. Their knowledge and expertise are missed. In September, Denise McFarland began as Librarian. Ella Pratt has been volunteering during story hour.

The state's summer reading program theme was "Ketchup On Your Reading". In spite of the efforts made to publicize the program and to plan various activities, it was not well attended.

The library has begun a weekly story hour, open to all ages. The first half-hour is dedicated to toddlers and others who have shorter attention spans. The second half-hour is devoted to classic literature and adults are also welcome. While there are some faithful attendees of the first half-hour, the second half-hour has gotten off to a slow start.

A Community Outreach Program is in its beginning stages. The goal and purpose of this program is to connect those in the community who are unable to borrow materials with volunteers who deliver library materials. It is also hoped that volunteers would read to those in the community who would enjoy this.

The library is now linked with the state library via computer. This provides us with access to many materials and information. The computer has also been used by many of our patrons to assist them with various projects.

There has also been a favorable response to the videos that the library has acquired during the past year.

The library is affiliated with the NUBANUSIT Co-op. This association provides our library with a number of benefits, including inter-library loans, a video-exchange program, purchasing discounts, updated library information, trainings, etc.

In addition to being a source of information and reading materials for the town, the library is used as the meeting place for the Planning Board, the Conservation Committee, the Friends of the Library, the Snowmobile Club, voter registration by the Supervisors of the checklist and the Health Department for Blood Pressure Clinics.

These general purpose financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with the generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general purpose financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the general purpose financial statements. 
