Warrant for Town Meeting

L.S. THE STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Grafton, in the County of Grafton in said State, qualified to vote in town affairs.

You are hereby notified to meet at the Town Hall in said Grafton on Tuesday, the 11th day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To see if the Town will vote to elect one or more Road Agents for the ensuing year.
4. To hear the report of the Budget Committee and act thereon.
5. To see if the Town will allow a discount of three per cent upon all property taxes paid on or before June 1, 1941, of two per cent upon all property taxes paid on or before July 1, 1941, and of one per cent on all property taxes paid on or before August 1, 1941.
6. To see if the Town will vote to authorize the Selectmen to make short term loans in anticipation of taxes.
7. To see what sum of money the Town will vote to raise and appropriate for the purpose of maintaining town highways and bridges, including the amount of one-quarter of one per cent.
8. To see what sum of money the Town will vote to raise and appropriate for the purpose of cutting bushes and railing embankments.
9. To see if the Town will accept State aid for con-

struction of Class 2 road, known as the Fourth New Hampshire Turnpike, and raise and appropriate or set aside for said purpose the sum of \$564.00 and receive from the State the sum of \$1,128.00, or will accept State aid for Class 5 roads and raise and appropriate or set aside for said purpose the sum of \$564.00 and receive from the State the sum of \$2,627.82.

(Note: No town may receive both class 5 and class 2 aid in the same year.)

10. To see if the Town will vote to raise and appropriate \$900.00 plus interest on \$900.00 to apply on Town debt.

11. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's deeds.

12. To see if the Town will vote to raise and appropriate the sum of \$38.37 for issuance and distribution of printed matter calling attention to the resources and natural advantages of the Town in cooperation with the other towns in the Dartmouth-Lake Sunapee Region, said appropriation to be disbursed by the Selectmen.

13. To see if the Town will vote to raise and appropriate \$300.00 for the control of White Pine Blister Rust.

14. To see if the Town will vote to purchase Tractor and Snow Plow from the Casellini Venable Corporation for \$3,200.00.

To raise and appropriate \$800.00 and raise balance on three Long Term Notes of \$800.00 each, with interest on same.

15. To see what sum of money the Town will vote to raise and appropriate for the purpose of restoring Kilton Pond Dam.

16. To see if the Town will accept a gift from Samuel P. Huff in the Deed of the Damsite and Flowage rights at Kilton Pond.

17. To see if the Town will vote to discontinue the road from the Highway leading to the John Sargent Place so-called across the Hood Farm to the Hodge place.

18. To see what sum of money the Town will raise and appropriate for the completion on repairing the Edwin Sargent Bridge.

19. To take any vote or transact any further business that may legally come before said meeting.

Report of Forest Fire Warden

I wish to submit the report for the year 1940 which was considered a very hazardous year although Grafton had very few fires considering the amount of downfall there is in town. The reason for this is the good cooperation that we got from the towns people and public in general.

With the new fire equipment that we now have we are quite well prepared to take care of any small fires that might occur. However we must be better and better prepared to meet emergencies because with unfavorable weather conditions the hazard is bound to be greater during the coming fire season. Through the kindness of Mr. Leslie Seamans we have a nice trailer in which to keep our fire equipment.

I think we owe our thanks to the Danbury C. C. C. Camp for building three water-holes in our town. These water-holes are of great help in case a forest fire pumper

has to be used.

Under the present forest fire fighting set-up we have a crew of very fine fire fighters. They are trained and know their place at a fire and are ready to go at a moment's notice.

I think we owe our thanks to the District Chief for his cooperation in helping to train our forest fire fighting crew. I also wish to thank the deputies and other town officials and towns people for being so cooperative.

As we all know by now that the law requires a permit to burn before doing any burning. Because burning without a permit puts the party that is doing the burning liable to all expenses also court action. I am in hopes to still get cooperation of the towns people as this not only cuts down fires but helps to keep the taxes down.
